

## Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

### WEEK STREET, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of gas mains replacement works, Kent County Council has made an Order prohibiting through traffic on Week Street, Maidstone, on or after 28 July 2014 for up to 4 weeks or until the works have been completed.

The road will be closed between St Francis of Assisi Catholic Church and Brenchley House.

The alternative route is via Station Road and Week Street.

### SEVENOAKS AREA

#### BRASTED HILL ROAD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of the installation of a new drain, Kent County Council intends to make an Order prohibiting through traffic on Brasted Hill Road, on or after 11th August 2014 for up to 11 days or until the works have been completed.

The road will be closed Outside Quintins to Rectory Lane outside of The Chantry.

There will be no access for through traffic between these junctions

The alternative route is via Brasted Hill Road, Pilgrims Way, Hogtrough Hill, Station Road, Church Road, High Street and Rectory Lane.

#### BOWER LANE, EYNSFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of high voltage cable works above the carriageway, Kent County Council intends to make an Order prohibiting through traffic on Bower Lane, Eynsford, on or after 17th August 2014 for up to 3 days or until the works have been completed.

Access for the residence and businesses via escort.

The alternative route is via: Burchin Cross Roads, Shoreham, Magpie Bottom, Shoreham, Fachenden Lane Shoreham, A225 Shoreham Road Shoreham, A225 Shoreham Road, Eynsford, Station Road, Eynsford and Bower lane, Eynsford.

#### CHIPSTEAD LANE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of a road crossing for UK Power Networks Kent County Council has made an Order prohibiting through traffic on Chipstead Lane, on or after 28th July 2014 for up to 5 days or until the works have been completed.

The road will be closed for the whole length and there will be no access for through traffic at this location.

The alternative route is via: Barnfield Road, Witches Lane, Worships Hill and vice versa.

#### MAPLESCOMBE LANE, FARNINGHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of high voltage cable works above the carriageway, Kent County Council intends to make an Order prohibiting through traffic on Maplescombe Lane, Farningham, on or after 17th August 2014 for up to 3 days or until the works have been completed.

The road will be closed between a small section on Maplescombe Lane and Donkey Lane.

There will be no access for through traffic between these junctions

The alternative route is via Donkey lane Farningham, Gorse Hill Farningham, London Road Farningham Botsom Lane West Kingsdown.

#### PILGRIMS WAY EAST, PILGRIMS WAY KEMSING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of carrying out carriageway repairs, Kent County Council has made an Order prohibiting through traffic on Pilgrims Way East, Pilgrims Way Kemsing, on or after 28th July 2014 for up to 5 days or until the works have been completed.

The road will be closed at Tudor Drive to Beechy Lees Road and there will be no access for through traffic at this location.

The alternative route is via: A225 Station Road, A225 Sevenoaks Road, Otford Road, A25 Seal Road, School Lane, Seal, Childsbridge Lane Seal and Kemsing and the remainder of Pilgrims Way Kemsing.

#### RYE LANE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of the renewal of gully pots and the cleaning of the drainage system, Kent County Council has made an Order prohibiting through traffic on Rye Lane, on or after 29th July 2014 for up to 3 days or until the works have been completed.

The road will be closed from the junction of Pilgrims Way to Willow Park.

There will be no access for through traffic between these junctions

### SCRATCHERS LANE, WEST KINGSDOWN, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of high voltage cable works above the carriageway, Kent County Council intends to make an Order prohibiting through traffic on Scratchers Lane, West Kingsdown, Sevenoaks, on or after 12th August 2014 for up to 2 days or until the works have been completed.

The road will be closed between Three Gates and Gabriel Spring Road and there will be no access for through traffic at this location.

The alternative route is via: Fawkham Road, West Kingsdown, London Road West Kingsdown, London Road Farningham and Gabriel Spring Road Fawkham.

### SHEPWAY AREA

#### A2034 CHERITON GARDENS, FOLKESTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of carriageway resurfacing works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of A2034 Cheriton Gardens, Folkestone.

Overnight closures are planned to commence from 11th August 2014 for up to 2 nights, between 20:00 hours through until 05:00 hours each night.

Cheriton Gardens will be closed to through traffic between the junctions with Ingles Road and Manor Road.

The alternative route is via A2033 Bouverie Road West, Castle Hill Avenue and A2034 Shorncliffe Road.

#### ROAD OF REMEMBRANCE, FOLKESTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

To allow works to install signage to be safely carried out, Kent County Council has made an Order to temporarily prohibit through traffic on Road of Remembrance, Folkestone.

Off-peak closures are planned to commence from 29 July 2014 for up to 2 days, between 09:30 hours and 15:30 hours each day.

Road of Remembrance will be closed for its entire length.

The alternative routes are:

Eastbound (towards Harbour) via West Terrace, Bouverie Place, Bouverie Square, Middelburg Square, Foresters Way, A2033 Grace Hill, New Street, Bradstone Road, A260 Dover Road, Harbour Way, Radnor Bridge Road, Ryland Place, The Tram Road, Harbour Street, Harbour Approach Road and Marine Terrace

Westbound (from Harbour) via Lower Sandgate Road, Harbour Street, Tontine Street, Dover Road, Grace Hill, Shellons Street, Middelburg Square, Cheriton Place, Sandgate Road and West Terrace.

#### (THE DISTRICT OF SHEPWAY, VARIOUS ROADS) (RESTRICTIONS AND PROHIBITIONS OF WAITING, LOADING AND UNLOADING) CONSOLIDATION (AMENDMENT NO 17) ORDER 2014

Notice is hereby given that KENT COUNTY COUNCIL propose to make the above named Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act:

The effect of the Order will be to prohibit waiting at any time (double yellow lines) at the following locations:-

*The Tram Road, Folkestone – On the western side of the road, from the junction with London Street, for a distance of 10 metres in a southerly direction.*

*- On the western side of the road, from the junction Elmstead Place, for a distance of 10 metres in a southerly direction.*

*Elmstead Place - On the southern side of the road, from the junction with The Tram Road, for a distance of 2 metres in a westerly direction*

*London Street - On both sides of the road, from the junction with The Tram Road, for a distance of 6.7m in a westerly direction*

### SWALE AREA

#### A2 KEY STREET, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

To allow the safe use of a mobile crane for works to an aerial mast, Kent County Council intends to make an Order to temporarily prohibit eastbound through traffic

on part of A2 Key Street, Sittingbourne.

An evening closure is planned to commence on 11 August 2014 for 1 night, from 21:30 hours for up to 3 hours.

A2 Key Street will be closed eastbound only at the junction with Key Street Roundabout.

This means there will be no direct access from the A2 / A249 into Sittingbourne using the A2.

Westbound traffic is unaffected.

The alternative eastbound route is via Sheppey Way, Bobbing Interchange, B2006 Staplehurst Road, Staplehurst Roundabout, St Pauls' Way, Crown Quay Lane, A2 St Michael's Road, Dover Street, West Street, London Road and Key Street.

#### CLOCK HOUSE LEVEL CROSSING, BOUGHTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of level crossing maintenance works, Kent County Council intends to make an Order prohibiting through traffic on Clock House Level Crossing, Boughton, Faversham.

A closure is planned to commence from Sunday 17 August at 00:20 hours through until Monday 18 August at 04:00 hours.

Clockhouse Lane will be closed in the vicinity of the level crossing, with no access for through traffic.

The alternative route is via Clockhouse Lane, Selling Road and Brenley Lane.

#### THE STREET, OARE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of works to provide a new water connection, Kent County Council has made an Order to temporarily prohibit through traffic on part of The Street, Oare.

A closure is planned to commence from 28 July 2014 for up to 5 days or until the works have been completed.

The Street will be closed in the vicinity of numbers 12-16, with no access for through traffic between the junctions with Church Road and Colegates Road.

The alternative route is via Western Link, Bysing Wood Road, Luddenham Hill, Bysing Wood Road, Colegates Road and The Street.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

#### WARDS HILL ROAD, MINSTER-ON-SEA (PROHIBITION OF DRIVING) TEMPORARY ORDER JULY 2014

Because of road modifications and the construction of a pedestrian crossing, Kent County Council has made an Order to temporarily prohibit through traffic on part of Wards Hill Road, Minster-on-Sea.

A closure is planned to commence from 28 July 2014 for up to 5 weeks or until the works have been completed.

Wards Hill Road will be closed between the junctions with Lynmouth Drive and Love Lane.

The alternative route is via Wards Hill Road, The Broadway, B2008 Minster Road, Waterloo Hill and Union Road.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

These works were initially due to have been carried out in February 2014.

#### WATER LANE, FAVERSHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of gas mains replacement works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Water Lane, Faversham.

A closure is planned to commence from 28 July 2014 with estimated completion by 22 August 2014.

Water Lane will be closed in the vicinity of the junction with A2 Ospringe Street.

The alternative routes are via A2 London Road, Brogdale Road, Whitehill, Eastling Road, Painters Forstal Road and Water Lane or via A2 Ospringe Street, London Road, Faversham Road, Coxett Hill, Abbots Hill and Water Lane.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

### TONBRIDGE & MALLING AREA

#### BELTRING ROAD, EAST PECKHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because a new gas main and service is to be installed, Kent County Council has made an Order prohibiting through traffic on Beltring Road, East Peckham, on or after 26 July 2014 for up to 2 days or until the works have

been completed.

The road will be closed outside the former Blue Bell Pub. The 7.5T environmental weight restriction will be suspended during the works to allow for the diversion.

The alternative route is via Lees Road, B2162 Hampstead Lane, B2015 Maidstone Road and A228 Boyle Way/ Branbridges Road.

#### CHURCH LANE, TROTTISCLIFFE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of drainage improvement works, Kent County Council has made an Order prohibiting through traffic on Church Lane, Trottscliffe, on or after 28 July 2014 for up to 1 week or until the works have been completed.

The road will be closed outside "Rosedene".

The alternative route is via The Street and School Lane.

#### CROUCH LANE, BOROUGH GREEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of cabling works for UK Power Networks, Kent County Council intends to make an Order prohibiting through traffic on Crouch Lane, Borough Green, on or after 11 August 2014 for up to 5 days or until the works have been completed.

The road will be closed outside 1 Crouch Lane.

The alternative route is via Long Mill Lane and A25 Maidstone Road.

#### HATHAM GREEN LANE, STANSTED (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of drainage and carriageway repairs to prevent flooding, Kent County Council has made an Order prohibiting through traffic on Hatham Green Lane, Stansted, on or after 28 July 2014 for up to 2 weeks or until the works have been completed.

The road will be closed from "Crab Dene" to "The White Bungalow".

The alternative route is via Stansted Lane, A20 London Road, Plaxdale Green Road and Parsons Lane.

#### HIGH STREET, AYLESFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of traffic signal maintenance, Kent County Council intends to make an Order prohibiting through traffic on High Street, Aylesford, on or after 11 August 2014 for up to 3 weeks or until the works have been completed.

The road will be closed from Forstal Road to Court Farm.

The alternative route is via Rochester Road, Pilgrims Way and Bull Lane.

#### KING STREET, WEST MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of gas mains replacement works, Kent County Council has made an Order prohibiting through traffic on King Street, West Malling, on or after 26 July 2014 for up to 31-Oct or until the works have been completed.

The road will be closed outside number 14 to opposite number 1 High Street.

The alternative route is via High Street.

#### LEIGH ROAD, HILDENBOROUGH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because it is necessary to replace the existing highway culvert to prevent flooding, Kent County Council has made an Order prohibiting through traffic on Leigh Road, Hildenborough, on or after 28 July 2014 for up to 1 week or until the works have been completed.

The road will be closed at the junction with Powder Mills.

The alternative route is via B2027 Stocks Green Road/ Rings Hill/Hildenborough Road and Powdermill Lane.

#### LUNSFORD LANE, EAST MALLING & LARKFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because it is necessary to replace a structurally unsafe sign post, Kent County Council has made an Order prohibiting through traffic on Lunsford Lane, East Malling & Larkfield, on or after 27 July 2014 for up to 1 day or until the works have been completed.

There will be no access for through traffic between the junctions with A20 London Road and Kingfisher Road.

The alternative route is via Kingfisher Road, New Hythe Lane and A20 London Road.

#### STAFFORD ROAD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because it is necessary to lift a new classroom into Slade Primary School by crane, Kent County Council intends
