Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

THANET AREA

BRIGHT'S PLACE, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of carriageway repair works, Kent County Council intends to make an Order to temporarily prohibit through traffic on Bright's Place, Ramsgate.

Daytime closures are planned to commence from Monday 18 August 2014 for up to 5 days, between 09:00 hours and 17:00 hours each day.

Bright's Place will be closed for its entire length.

King Street will remain closed.

The alternative route is via King Street and Artillery Road. Access for residents will be maintained from the junction with Artillery Road whenever safe to do so, but there are likely to be some delays and certain times when this is not possible, due to the nature of the works. The junction with

FOOTPATH FROM TOTHILL STREET TO ORCHARD CLOSE, MINSTER (RESTRICTIONS ON PEDESTRIANS) TEMPORARY ORDER 2014

Because of sewer repair works, Kent County Council intends to make an Order to temporarily prohibit the use of part of the Footpath from Tothill Street to Orchard Close, Minster.

A closure is planned to commence from 18 August 2014 for up to 4 weeks or until the works have been completed.

The Footpath will be closed in the vicinity of numbers 30 / 39, with no through access.

The alternative route is via Tothill Street and Orchard Close. Due to the nature of these works, it will not be possible to re-open the footpath outside the working hours.

PARK LANE, BIRCHINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of works to place new road markings following a Village Gateway scheme, Kent County Council has made an Order to temporarily prohibit through traffic on part of Park Lane, Birchington.

An evening closure is planned for 4 August 2014 or the next available evening with suitable weather conditions. The closure will be between 19:00 hours and 23:00 hours, and lifted as soon as the works have been completed.

Park Lane will be closed between the junction with Manston Road and the entrance to Quex Park.

The alternative route is via B2050 Manston Road, Shottendane Road, Minster Road, A28 Canterbury Road, The Square and Park Lane.

ST LUKE'S AVENUE, RAMSGATE (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2014**

Because of works to install a new traffic calming scheme, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of St Luke's Avenue, Ramsgate.

Weekday closures are planned to commence from 18 August 2014 for up to 2 weeks, Mondays to Fridays, between 07:00 hours and 17:00 hours each day.

St Luke's Avenue will be closed in phases between the junctions with A254 Margate Road and Upper Dumpton . Park Road.

The alternative route is via A254 Margate Road, A255 Boundary Road, Hardres Road and St Luke's Avenue.

Waiting will be prohibited at all times at various points on both sides of St Luke's Avenue, to the extent indicated by signs and No Waiting cones on site, to allow space for safe working.
