Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

A28 ASHFORD ROAD, BETHERSDEN (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2014**

Because of carriageway resurfacing works, Kent County Council has made an Order to temporarily prohibit through traffic on part of A28 Ashford Road, Bethersden Overnight closures are planned to commence from Monday 22 September 2014 for up to 5 nights, between 19:00 hours through until 05:00 hours each night.

A28 Ashford Road will be closed between the junctions with Forge Hill and Bull Lane, with no direct access between Ashford and Tenterden using this route.

The alternative route is via A28 Ashford Road, Woodchurch Road, Bethersden Road, Plurenden Road, Woodchurch Road, Church Hill and A28 Ashford Road.

THE GREEN, WOODCHURCH (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2014**

Because of drainage improvements to alleviate local flooding, Kent County Council has made an Order to temporarily prohibit through traffic on part of The Green, Woodchurch.

A closure is planned to commence from 22 September 2014 for up to 5 days or until the works have been

The Green, Woodchurch will be closed between the iunctions with Front Road and Back Lane

The alternative route is via Front Road and Back Lane. Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

CANTERBURY AREA

A290 BLEAN COMMON, BLEAN (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2014**

Because of carriageway patching works, Kent County Council has made an Order to temporarily prohibit through traffic on part of A290 Blean Common, Blean,

Evening closures are planned to commence from 23 September 2014 for up to 2 nights, between 19:00 hours and midnight each evening. It is hoped the works can be completed in 1 night.

Blean Common will be closed at the junction with Tyler Hill Road, with no through access between Whitstable and Canterbury using this route.

The alternative route is via A290 Blean Hill, Tile Kiln Hill, Whitstable Road, St Thomas Hill, Whitstable Road, Forty Acres Road, Beaconsfield Road, St Stephen's Hill, Canterbury Hill, Wood Hill, Hackington Road, Radfall Road, Radfall Hill, Chestfield Road, A2990 (Old) Thanet Way, A290 Clapham Hill, Pean Hill, Honey Hill and Blean Common.

Tyler Hill Road will be closed at the junction with Blean Common, with local diversions in place

Buses on service will be allowed through the closure, but there may be delays.

ST STEPHEN'S ROAD, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of telegraph pole replacement works, Kent County Council intends to make an Order to temporarily prohibit southbound traffic on part of St Stephen's Road,

A closure is planned for Sunday 12 October 2014 from 08:00 hours to 16:00 hours.

St Stephen's Road, Canterbury will be closed to southbound traffic (i.e. towards the railway station) at the roundabout junction with Broad Oak Road and Kingsmead Road.

The closure is from the roundabout for a distance of 100 metres south-westwards, and means traffic from St Stephen's Road, Broad Oak Road and Kingsmead Road vill be unable to reach the Railway Station and St Dunstan's Street using this route.

VARIOUS ROADS, BRIDGE (PROHIBITION OF DRIVING)

Because of carriageway patching works and repairs to flood damage from earlier in the year, Kent County Council intends to make an Order to temporarily prohibit through traffic on certain roads in Bridge, Canterbury, on or after 6 October 2014.

The roads affected are as shown below. Roads will be closed in sections long their length as the works

BREWERY LANE, BRIDGE will be closed from 6 October for up to 2 weeks, including weekends

MILL LANE, BRIDGE will be closed from 6 October for up to 2 weeks, including weekends

The alternative route for all through traffic affected by both closures is via High Street, Western Avenue, Saxon Road and Union Road.

BRIDGEFORD WAY, BRIDGE will be closed from 6 October for up to 5 days

There is no alternative route as the road is a cul-de-sac Access for residents will be maintained whenever it is safe to do so, but there are likely to be some delays and certain times when this is not possible, due to the nature of the works and the use of machinery.

Due to the nature of these works, it will not always be possible to re-open the roads outside the working hours.

CRABBLE ROAD, RIVER (PROHIBITION OF WAITING) TEMPORARY ORDER 2014

For the safety of the public during Dover Football Club home fixtures, Kent County Council has made an Order to temporarily prohibit waiting on part of Crabble Road. River, Dover, from 22 September 2014 for up to 1 year.

Waiting will be prohibited for the entire length of the layby on the southern side of Crabble Road, either side of the entrance to Dover Football Club.

Waiting will be prohibited at all times between the hours shown below, on all dates that Dover Football Club has home fixtures

- For fixtures on Saturdays or any other daytime fixtures, waiting will be prohibited between 09:00 hours through until 19:00 hours that day

The No Waiting restrictions will be indicated by a single yellow line and No Waiting signage displayed on site The restriction has the effect of suspending any existing parking entitlements and restrictions that apply to this section of road.

CROSS ROAD, DEAL (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2014**

Because of works to provide a new connection into the main sewer, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Cross Road, Deal.

A closure is planned to commence from 6 October 2014 for up to 2 weeks.

Cross Road will be closed in the vicinity of numbers 30-44 Cross Road, with no through access

The alternative route is via St Richard's Road, Astrid Road and Lydia Road.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours

HAY LANE, EASTRY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of drainage improvement works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Hay Lane, Eastry.

A closure is planned to commence from Monday 6 October 2014 for up to 5 days.

Hay Lane, Fastry will be closed to through traffic from the junction with Updown Road, Northbourne to where it becomes Mill Lane, Worth.

There will be no access for through traffic between Updown Road and A258 Deal Road.

The alternative route is via Updown Road, Northbourne Road, A256 Eastry Bypass, Sandwich Road, and A258

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

MILL LANE & FISHMONGER'S LANE, DOVER (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

For the safety of the public and workforce whilst works are carried out to demolish Centurion House, Kent County Council intends to make an Order to temporarily prohibit through traffic on Mill Lane and Fishmonger's Lane, Dover.

A closure is planned to commence from 6 October 2014 for an estimated period of up to 12 weeks.

Mill Lane and Fishmonger's Lane will be closed for their entire lengths.

There is no alternative route.

Due to the nature of these works, it will not be possible to re-open the roads outside working hours.

STONEHEAP ROAD, EAST STUDDAL (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2014**

Because of telegraph replacement works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Stoneheap Road, East Studdal (Sutton), Dover.

An off-peak closure is planned to for Thursday 9 October 2014 for 1 day, between 09:30 hours to 15:30 hours

Stoneheap Road will be closed between the junctions with Downs Road and Northbourne Road

The alternative route is via Downs Road and Northbourne Road.

VALE ROAD, SUTTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of telegraph pole replacement works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Vale Road, Sutton,

An off-peak closure is planned to commence on Tuesday 23 September 2014 for up to 1 day, between 09:30 hours and 15:30 hours.

Vale Road, Sutton will be closed from the junction of Wingleton Lane for a distance of approximately 100 metres to the vicinity of Sutton Vale Caravan Park. The alternative route is via Wingleton Lane, Pommeus Lane and Sutton Road.

WESTCOURT LANE, SHEPHERDSWELL (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because of works to improve local drainage. Kent prohibit through traffic on part of Westcourt Lane, Shepherdswell, Dover.

Daytime closures are planned to commence from 25 September 2014 for up to 2 days, between 08:00 hours and 16:00 hours each day.

Westcourt Lane will be closed between the junctions with Evthorne Road and the western junction with The Grange, with no through access between Eythorne Road and Westcourt Downs.

The alternative route is via Evthorne Road, Barfrestone Road, Long Lane, Westcourt Down and Westcourt Lane.

THE KENT COUNTY COUNCIL (VARIOUS ROADS, DOVER DISTRICT) (WAITING **RESTRICTIONS AND STREET PARKING PLACES)** (AMENDMENT NO 27) ORDER 2014

The Kent County Council, in exercise of their powers and under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 46, 49 and 53 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby propose to make the following Order:-

The Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) (Amendment No 27) Order 2014 shall be amended as follows:

Roads in Dover

No waiting at any time

The following items to be added in the correct alphabetical sequence:

The effect of this Order will be to introduce a prohibition of waiting at any time in the following lengths of road:

Road Name: Common Lane, River

Distance: On the eastern side of the road, from the junction with Valley Road for a distance of 15m in a north easterly direction and 15m in a south westerly direction.

Road Name: Common Lane, River

Distance: On the western side of the road, from the junction with River Street for a distance of 15m in a north easterly direction and 15m in a south westerly direction.

Road Name: Valley Road, River Distance: On both sides of the road, from the junction

with Common Lane for a distance of 15m in south easterly direction.

Road Name: River Street, River

Distance: On both sides of the road, from the junction with Common Lane for a distance of 15m in westerly

The effect of this Order will also introduce a prohibition of waiting Monday to Friday between 8.30am and 5.30pm in the following lengths of road:

Road Name: Common Lane, River

Distance: On the eastern side of the road, from a point 15m south west from the junction of Valley Road to a point 30m south west of Valley Road.

Road Name: Common Lane, River

Distance: On the western side of the road, from a point 40m north east from the junction of Lewisham Road to a point 75m north east of Lewisham Road.

B2010 SMITH'S HILL, WEST FARLEIGH & YALDING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because it is necessary to clear highway drainage, Kent County Council intends to make an Order prohibiting through traffic on B2010 Smith's Hill, West Farleigh & Yalding, on or after 6 October 2014 for up to 2 days or until the works have been completed.

There will be no access for through traffic between the junctions with B2163 Ewell Lane and Shingle Barn Road. The alternative route is via B2163 Teston Lane, A26

Tonbridge Road, B2015 Bow Road/Maidstone Road, B2162 Hampstead Lane/Lees Road, High Street and B2010 Yalding Hill.

TILDEN LANE, MARDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014

Because it is necessary to replace a telegraph pole and cabling works for BT Openreach, Kent County Council has made an Order prohibiting through traffic on Tilden Lane, Marden, on or after 25 September 2014 for up to 1 day or until the works have been completed.

The road will be closed from Stilebridge Lane for approximately 200 metres.

The alternative route is via Underlyn Lane and Stilebridge Lane.

YEOMAN LANE, BEARSTED (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2014**

Because of drainage and carriageway works to prevent flooding, Kent County Council intends to make an Order prohibiting through traffic on Yeoman Lane, Bearsted, on or after 6 October 2014 for up to 2 weeks or until the works have been completed.

The road will be closed at the junction with The Orchard. The alternative route is via The Street, Roundwell and A20 Ashford Road.
