## NOTICE OF CONFIRMATION OF MODIFICATION ORDER WILDLIFE AND COUNTRYSIDE ACT 1981 DEFINITIVE MAP AND STATEMENT FOR THE COUNTY OF KENT THE KENT COUNTY COUNCIL (PUBLIC FOOTPATH TRX6 RAMSGATE) DEFINITIVE MAP MODIFICATION ORDER 2013

On the 24th September 2014 an Inspector appointed by the Secretary of State for Environment, Food and Rural Affairs confirmed the above Order with modifications.

The effect of the Order as confirmed with modifications is to modify the Definitive Map and Statement for the area by adding a Public Footpath with an initial width of 1.6 metres commencing on Harbour Parade and crossing the flagstone paved area between property numbers 64 and 66. The path runs in a northerly direction between these properties and negotiates a flight of steps with a width of 1.6 metres. There is a metal handrail on the western side of the path. At the top of the steps the path turns in an easterly direction where it continues through a tunnel with the lesser width of 1.2 metres to its junction with Madeira Walk. The path is bounded on either side by buildings, property walls and the tunnel walls. The path has a concrete surface. From the point where the main path turns in an easterly direction, a small spur (between the points B and C on the Order Plan) leads to the Service Road. The length between points A -C (on the Order Plan) is 25 metres. The length between points B and D (on the Order Plan) is 10 metres.

All distances are approximate, all directions are general.

This Order became operative as from 24th September 2014 but if a person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of Section 53(3)(c)(i) of the Wildlife and Countryside Act 1981, or that any of the requirements of Schedule 15 to the Act have not been complied with in relation to the confirmation of the Order, he may, under Paragraph 12 of Schedule 15 to the Act, within 42 days from 31st October 2014 make application for the purpose to the High Court.
