DEFINITIVE MAP MODIFICATION ORDER 2014

The above Order was made on 9 December 2014 under section 53 of the Wildlife and Countryside Act 1981. If confirmed, it will modify the Definitive Map and Statement for the area by upgrading (a) the entire length of Restricted Byway AE429 commencing from its junction with the Ashford Road (A28) and running for 256 metres in an east south easterly direction to its junction with Restricted Byway AE18 and Public Footpath AE20. As shown between the points A and B on the Order Plan; and (b) that part of Restricted Byway AE18 which commences at the aforementioned point B and runs north eastwards for 653 metres, then for 80 metres in a south south easterly direction, and then for 294 metres in an east north easterly direction, and then south south easterly again for 114 metres, and then for 732 metres in a north easterly direction to its junction with Byway open to all Traffic CB207 at the Chartham Parish boundary. As shown between the points B, C, D, E, F and G on the Order Plan. The upgraded section of AE18 will be renumbered AE429. The route has an initial width of 5 metres from its junction with the A28 for 54 metres but at the point where the route crosses the bridge the width narrows to 3.6 metres for the next 202 metres. From the Junction with the unaffected length of Restricted Byway AE18 and Footpath AE20 the remainder of the route has a width of 3.0 metres until it meets CB207 at the **Chartham Parish Boundary**

All distances are approximate, all directions are general.
