

## Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

### ASHFORD AREA

#### **A20 ASHFORD ROAD, SMEETH & MAIN ROAD, SELLINDGE (30 MPH SPEED LIMIT) TEMPORARY ORDER 2015**

For the safety of the public and workforce during footway resurfacing works, Kent County Council intends to make an Order to impose a temporary mandatory speed limit of 30 mph on sections of the A20 Ashford Road, Smeeth and A20 Main Road, Sellindge.

The 30 mph speed limit applies during works that are planned to be carried out from 5 January 2015 for an estimated period of up to 16 weeks.

The speed limit applies in both directions on A20 Ashford Road, Smeeth and A20 Main Road, Sellindge, between the junction with Church Road / Station Road, Smeeth extending to the junction with Stone Hill, Sellindge.

The 30 mph speed limit will be imposed in phases as the works progress, with the actual extent of speed limit clearly indicated by signage displayed on site.

Due to the nature of these works, the restrictions will need to remain in place outside the working hours.

#### **STANDARD LANE, BETHERSDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

To allow safe access to the overhead phone network for cabling works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Standard Lane, Bethersden.

Off-peak closures are planned to commence from Monday 5 January 2015 for an estimated period of up to 4 days, between 09:30 hours and 15:30 hours each day.

Standard Lane will be closed from the junction with Brissenden Green Lane for approximately 500 metres, with no through access.

The alternative route is via A28 Ashford Road, Gascoigne Road and Chequer Tree Lane.

### CANTERBURY AREA

#### **THORNDEN WOOD ROAD, CHESTFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

To allow safe access to the overhead phone network for cabling works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Thornden Wood Road, Chestfield, Whitstable.

An off-peak closure is planned for Monday 5 January 2015 between 09:30 hours and 15:30 hours.

Thornden Wood Road will be closed to through traffic from the junction with Radfall Road for a distance of approximately 800 metres north-eastwards.

Access to the remainder of Thornden Wood Road continues from the Greenhill direction.

The alternative route for through traffic is via Radfall Road, Radfall Hill, Chestfield Road, A2990 (Old) Thanet Way, Greenhill Road and Thornden Wood Road.

### DOVER AREA

#### **MIDDLE DEAL ROAD, DEAL (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of gas mains replacement works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Middle Deal Road, Deal.

A closure is planned to commence from Monday 5 January 2015 for up to 2 weeks.

Middle Deal Road will be closed from outside number 246 eastwards to the junction with Orchard Avenue, with no through access between London Road and Orchard Avenue.

The alternative route is via Middle Deal Road, A258 London Road and Bowling Green Lane.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

#### **RICHBOROUGH LEVEL CROSSING, SANDWICH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of level crossing maintenance and other associated works, Kent County Council intends to make an Order to temporarily prohibit through traffic on Richborough Level Crossing, Sandwich.

Closures are planned as follows

Saturday 10 January 2015 at 00:50 hours until 19:00 hours

Sunday 22 February 2015 from 01:25 hours through until Monday 23 February at 04:00 hours

Richborough Road will be closed at Richborough Level Crossing, with no through access.

The alternative route is via A256 Sandwich By-pass, A257 Sandwich Road, Cooper Street Drove and Richborough Road.

#### **SANDWICH LEVEL CROSSING, SANDWICH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of level crossing maintenance and other associated works, Kent County Council intends to make an Order to temporarily prohibit through traffic on Sandwich Level Crossing, Sandwich.

A closure is planned for Saturday 10 January 2015 from 00:50 hours through until Sunday 11 January 2015 at 04:50 hours.

New Street, Sandwich will be closed in the vicinity of the level crossing.

The alternative route is via New Street, Harnet Street, Strand Street (plus High Street, The Chain and Galliard Street in reverse), Ash Road, A256 Sandwich Bypass, A258 Deal Road and New Street.

#### **VARIOUS ROADS, STUDDAL (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of drainage improvement works, Kent County Council intends to make an Order to temporarily prohibit through traffic on various roads in Studdal, Dover.

Closures affect Chapel Lane, Homestead Lane and Roman Road, which will each be closed in turn, as advised locally and signposted on site. Only one road will be closed at any one time.

Phased closures are planned to commence from 5 January 2015 for an estimated period of up to 3 weeks.

CHAPEL LANE and HOMESTEAD LANE will be closed in phases for their entire lengths.

The alternative route for both closures is via Waldershare Road, Gagg's Hill, Willow Woods Road, Strakers Hill and Homestead Lane.

ROMAN ROAD will be closed from the junction with Chapel Lane southwards to the property Vueland.

The alternative route is via Little America, Waldershare Road and Chapel Lane.

Due to the nature of these works, it will not be possible to re-open the roads outside the working hours.

### GRAVESHAM AREA

#### **BRITANNIA DRIVE, GRAVESEND (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Due to gas main replacement works and connections, Kent County Council intends to make an Order prohibiting through traffic on Britannia Drive, Gravesend, on or after 5th January 2015 for up to 31 days or until the works have been completed.

Britannia Drive will be closed at its junction between numbers 52 and 54 Vigilant Way and on a separate occasion at its junction between 114 and 116 Vigilant Way.

These closures will come in to effect when all appropriate signage is in place.

### MAIDSTONE AREA

#### **A229 CHATHAM ROAD, BOXLEY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because it is necessary to carry out survey works, Kent County Council intends to make an Order prohibiting through traffic on A229 Chatham Road, Boxley, on or after 4 January 2015 for up to 1 night between 19.00hrs and 05.00hrs or until the works have been completed.

The road will be closed from Running Horse Roundabout to M20 Roundabout.

The alternative route is via A229 Royal Engineers Road southbound, round Springfield Roundabout, A229 Royal Engineers Road northbound/Chatham Road.

#### **A229 HIGH STREET, STAPLEHURST (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of carriageway works, Kent County Council intends to make an Order prohibiting through traffic on A229 High Street, Staplehurst, on or after 5 January 2015 for up to 3 nights between 19.00hrs and 23.00hrs or until the works have been completed.

There will be no access for through traffic between the junctions with Offen's Drive and Church Green.

The alternative route is via A229 High Street/Cranbrook Road/Rocks Hill, A262 The Street/Sissinghurst Road/High Street, A274 North Street/Headcorn Road/Biddenden Road/Wheeler Street/Station Road/High Street/North Street/Mill Bank/Maidstone Road/Headcorn Road/North Street/Maidstone Road, B2163 Plough Wents Road/Heath Road, A229 Linton Hill/Staplehurst Road/Maidstone Road/Station Road.

#### **A274 SUTTON ROAD, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of the construction of a roundabout, Kent County Council intends to make an Order prohibiting traffic travelling at any speed greater than 30mph on A274 Sutton Road, Maidstone, on or after 5 January 2015 for up to 6 months or until the works have been completed.

The restriction will be in place between the existing 30mph gateway and the entrance to Langley Park Golfing Range.

#### **WAITING RESTRICTIONS VARIATION NO.24 ORDER 2014**

Notice is hereby given that KENT COUNTY COUNCIL has made the above named Order under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

1. The effect of the Order will introduce 'No Waiting at any Time' restrictions (double yellow lines) on the following roads or length of roads

**Cuckooood Avenue;**

South-eastern side, from its junction with Sandling Lane in a north-easterly direction to its junction with Sandbourne Drive

North-eastern side, from its junction with the access

to Boarley Court in a north-westerly direction for a distance of 5 metres

South-eastern side, from its junction with Sandling Lane in a north-easterly direction for a distance of 38 metres

South-eastern side, from a point 73 metres northeast of its junction with Sandling Lane to its junction with Sandbourne Drive

2. The effect of the Order will also introduce waiting restrictions (single yellow lines) Monday to Friday 9:30am to 5:30pm on the following roads or length of roads

**Cuckooood Avenue;**

South-eastern side, from a point 38 metres northeast of its junction with Sandling Lane in a north-easterly direction for a distance of 35 metres

A copy of the Order, which comes into force on Wednesday 24th day December 2014, a statement of the Council's reasons for making the Order and maps indicating the location and effect may be examined at The Kent County Council, Sessions House, County Hall, Maidstone ME14 1XQ and at Maidstone Borough Council offices, Maidstone Gateway, King Street, Maidstone ME15 6JQ during normal office hours.

Any person wishing to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the powers of the relevant enabling Act or that any requirement of any such enabling Act or of any regulations made thereunder have not been complied with may within 6 weeks from the date on which the Order was made make application to the High Court for this purpose.

#### **PILGRIMS WAY, DETLING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because it is necessary to lay BT ducting in the carriageway and construct a manhole, Kent County Council intends to make an Order prohibiting through traffic on Pilgrims Way, Detling, on or after 5 January 2015 for up to 10 days or until the works have been completed.

The road will be closed from Thurnham Lane to Castle Cottages.

The alternative route is via Thurnham Lane, Ware Street, Hockers Lane and The Street.

#### **ST FAITH'S STREET, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2015**

Because of a new water main connection, Kent County Council intends to make an Order prohibiting through traffic on St Faith's Street, Maidstone, on or after 5 January 2015 for up to 5 days or until the works have been completed.

The road will be closed outside The Adult Education Centre.

The alternative route is via Station Road, Sandling Road, B2012 Stacey's Street and A229 Fairmeadow.

### SEVENOAKS AREA

#### **COCKERHURST ROAD, SHOREHAM, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014**

Because BT need safe access to their overhead network cabling, Kent County Council intends to make an Order prohibiting through traffic on Cockerhurst Road, Shoreham, Sevenoaks, on or after 6th January 2015 for up to 1 Day or until the works have been completed.

The road will be closed from the junction with Redmans Lane and Castle Farm Road.

The alternative route is via Redmans Lane, Castle Farm Road.

#### **CROCKENHILL LANE, EYNSFORD, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014**

Because of electrical works, Kent County Council intends to make an Order prohibiting through traffic on Crockenhill Lane, Eynsford, Sevenoaks, on or after 5th January 2015 for up to 2 weeks or until the works have been completed.

The alternative route is via Wested Lane, Crockenhill & Swanley, London Road, Swanley, Swanley Interchange, London Road Farningham, Dartford Road, Farningham, High Street, Farningham and Sparepenny Lane, Farningham/Eynsford.

#### **FAWKHAM GREEN ROAD, FAWKHAM, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2014**

BT require access to carriageway boxes, for cabling work to restore customer service. Kent County Council intends to make an Order prohibiting through traffic on Fawkham Green Road, Fawkham, Sevenoaks, on or after 5th January 2015 for up to 5 days or until the works have been completed between the hours of 09:30hrs to 15:30hrs.

The road will be closed at its junction with Brands Hatch Road to the junction with Rogers Wood Lane.

The alternative route is via Brands Hatch Road, Rogers Wood Lane.

### SHEPWAY AREA

#### **(FOLKESTONE TOWN CENTRE AND THE BAYLE PARKING ZONE) ORDER 2012**

#### **(AMENDMENT NO 4) (ZONE A1 RELOCATION OF DISABLED PERSONS' PARKING PLACES) ORDER 2014**

Notice is hereby given that KENT COUNTY COUNCIL proposes the above Order under Sections 1, 2, 32, 44, 45 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

The Order implements the following parking restrictions and shall come into effect on the 18th December 2014

#### ROADS IN FOLKESTONE

**Limited waiting 2 hour no return within 2 hours [8am – 6pm Mondays to Saturdays (both days inclusive)] – Sandgate Road;** both sides, from a point 94.2 metres south west of its junction with West Terrace to a point 123.3 metres south west of that junction; South east side, from a point 9 metres south west of its junction with Shakespeare Terrace, south west for a distance of 11 metres; North west side, from a point 22.7 metres north east of its junction with Castle Hill Avenue, north east for a distance of 43 metres; Shakespeare Terrace; West side, from a point 18 metres south of its junction with Sandgate Road, south for a distance of 20 metres

**Zone A1 permit holders only [8am – 6pm] – Shakespeare Terrace,** south west side, from a point 16.5 metres south east of the northern carriageway, south east for a distance of 28.5 metres.

**Disabled persons' parking places [8am – 6pm 3 hours, no return within 2 hours] – Sandgate Road,** both sides from a point 94.2 metres south west of its junction with West Terrace, to a point 107.4 metres south west of that junction; South east side, from a point 15.4 metres south west of its junction with Shakespeare Terrace, south west for a distance of 13.2 metres; North east side, from a point 65.7 metres north east of its junction with Castle Hill Avenue, north east for a distance of 13.2 metres

The Order proposed to revoke the following parking restrictions

**Prohibitions of waiting [At any time] – Sandgate Road;** South east side from a point 9 metres south west of its junction with Shakespeare Terrace, south west for a distance of 5 metres; Shakespeare Terrace; South east side, from a point 38 metres south east of its junction with Sandgate Road, south for a distance of 2 metres; South west side, from a point 14.5 metres from its junction with the northern carriageway of Pleydell Gardens, south east for a distance of 15 metres.
