### NOTICE OF PUBLIC PATH ORDER

#### HIGHWAYS ACT 1980

#### WILDLIFE AND COUNTRYSIDE ACT 1981

#### (PUBLIC FOOTPATH AE659 AT SEVINGTON)

#### PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2015

The above-named Order, made on 13th March 2015 under Section 118 of the Highways Act 1980, will extinguish the entire length and width of Public Footpath AE659 which commences at its junction with Cheesemans Green Lane opposite Hogben Farm (at NGR TR 0363 3994) and runs in a north-easterly through north-westerly through north-easterly direction for 615 metres to its junction with Restricted Byway AE350 (at NGR TR 0357 4038).

All directions general, all distances approximate.

Please note that objections or representations cannot be treated as confidential and may come into the public domain. Copies of any objections or representations received may be disclosed to interested parties, including the Planning Inspectorate where the case is referred to it for determination.

If no such representations or objections are duly made to the Order (or to any part of it), or if any so made are withdrawn, the Kent County Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

### NOTICE OF PUBLIC PATH ORDER

#### TOWN AND COUNTRY PLANNING ACT 1990: SECTION 257

#### (RESTRICTED BYWAY AE350 (PART) SEVINGTON)

#### PUBLIC PATH DIVERSION ORDER 2015

The above Order was made on 18th March 2015 under section 257 of the Town and Country Planning Act 1990.

The effect of the Order, if confirmed, will be to divert the entire width of that length of Restricted Byway AE350 which commences at a point (NGR TR 0312 4030) which lies 165 metres east of its junction with Waterbrook Avenue and runs in an east-north-easterly direction for 425 metres to a point (NGR TR 0352 4041) which lies 64 metres north-west of its junction with Public Footpath AE659. A new length of Restricted Byway will be provided, with a width of 4 metres, commencing at NGR TR 0312 4030 and running in a north-easterly direction for 112 metres to NGR TR 0320 4038, continuing in an east-north-easterly through south-easterly direction for 330 metres to NGR TR 0352 4041.

If the Order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
