

THE TOWN AND COUNTRY PLANNING (DEVELOPMENT MANAGEMENT PROCEDURE) (ENGLAND) ORDER 2010

The following applications have been submitted for consideration by the Council:

Y15/1020/SH - Flat 7 The Manor House 1 Earls Avenue Folkestone Kent CT20 2EX - Listed building consent for the installation of a new boiler and flue pipe, together with alterations to the internal layout and internal alterations including the installation of a saniflow drainage device.

Y15/1149/SH - Latchgate Cottage Church Road Hythe Kent CT21 5DP - Works to trees in a Conservation Area comprising felling of Bay tree (T1), 1.75 metre reduction in height and maximum 0.75 metre reduction in lateral branches to Bay tree and Pitisporum (T2 & T3), felling of Cypress tree (T4).

Y15/1152/SH - The Priory Church Road Hythe Kent CT21 5DP - Crown reduction of a Mulberry tree situated within a conservation area comprising a 1.75 metre reduction in height and a maximum of 1 metre reduction of laterals.

Y15/1141/SH - Broad View Hillside Street Hythe Kent CT21 5EJ - Works to trees situated within a conservation area comprising: Apple, fell; Liquidambar, reduce in height by 1.5 metres, remove branch growing from tight fork, reduce crown spread by 1 metre; Bay, reduce height by 1.5 metres.

Y15/1158/SH - Springfield Dental Street Hythe Kent CT21 5LH - Removal of south section of a Conifer hedge situated within a conservation area, followed by the reduction in height of the remainder by 2 metres together with the removal of branches interfering with adjacent fences.

Y15/1051/SH - West Pier Folkestone Harbour Harbour Approach Road Folkestone Kent - Change of use from sui-generis to A1 (shops), A3 (restaurants & cafés) and A4 (drinking establishments).

Y15/1145/SH - Poplar House Church Road Lydd Romney Marsh Kent - Re-pollard back to previous pollarding points of an Ash tree situated within a conservation area.
