NOTICE OF THE MAKING OF AN ORDER TO TEMPORARILY CLOSE PUBLIC FOOTPATH EE391 IN THE PARISH OF SHOLDEN IN THE DISTRICT OF DOVER THE KENT COUNTY COUNCIL PUBLIC FOOTPATH EE391 (PROHIBITION OF TRAFFIC) TEMPORARY ORDER 2015 ROAD TRAFFIC REGULATION ACT 1984, SECTION 14(1), AS AMENDED BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991

Kent County Council has made an Order the effect of which is to temporarily close Public Footpath EE391, between point NGR TR 358, 522 (20 Vicarage Lane) and its junction with London Road from the 30th November 2015.

The path will be closed for a maximum of six months, although the works are expected to take two weeks, and the path re-opened before the end of December 2015.

The path is closed because works are being carried out to resurface the path and clear vegetation and there is a likelihood of danger to users.

NOTICE OF THE MAKING OF AN ORDER TO TEMPORARILY CLOSE RESTRICTED BYWAY EE485 IN THE PARISH OF STOURMOUTH IN THE DISTRICT OF DOVER THE KENT COUNTY COUNCIL RESTRICTED BYWAY EE485 (PROHIBITION OF TRAFFIC) TEMPORARY ORDER 2015 ROAD TRAFFIC REGULATION ACT 1984, SECTION 14(1), AS AMENDED BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991

Kent County Council has made an Order the effect of which is to temporarily close Restricted Byway EE485, between its junction with Public Footpath EE42 and Public Footpath EE133 from the 27th November 2015.

The path will be closed for a maximum of six months.

The path is closed because works are planned to removed fallen trees and to reinstate the path surface and because there is a likelihood of danger to users.

DEFINITIVE MAP AND STATEMENT FOR THE COUNTY OF KENT
THE KENT COUNTY COUNCIL
(PUBLIC FOOTPATH NS368 AT SHORNE)
DEFINITIVE MAP MODIFICATION ORDER 2015**

The above Order was made on 17th November 2015 under section 53 of the Wildlife and Countryside Act 1981. If confirmed, it will modify the Definitive Map and Statement for the area by adding a Public Footpath numbered NS368 which commences at the northern end of Queens Farm Road in the parish of Shorne (at NGR TQ 6946 7364) and runs in a northerly direction, across the Shorne Mead level crossing (via pedestrian gates on the eastern side of the crossing), for 68 metres to a junction with Public Footpath NS317 and Bridleway NS318 at NGR TQ 6946 7371. The route has a width of one metre between the pedestrian gates where it crosses the level crossing, a width of 6 metres south of the level crossing and an initial width of 7.5 metres immediately to the north of the level crossing, increasing to a width of 9 metres at its junction with Public Footpath NS317 and Bridleway NS318.

Please note that objections/representations cannot be treated as confidential and may come into the public domain. Copies of any objections or representations received may be disclosed to interested parties, including the Planning Inspectorate where the case is referred to it for determination.

If no such representations or objections are duly made to the Order (or to any part of it), or if any so made are withdrawn, the Kent County Council, instead of submitting the Order to the Secretary of State (or part of it if the Authority has by Notice to the Secretary of State so elected under paragraph 5 of schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is sent to the Secretary of State for the Environment (in whole or in part), any representations or objections which have been duly made and not been withdrawn will be sent with it.

PUBLIC PATH EXTINGUISHMENT AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2015**

On 25th November 2015, the Kent County Council confirmed the above Order under Section 118 of the Highways Act 1980.

The effect of that Order as confirmed is to extinguish the entire width and length of

that section of Public Footpath NG20 which commences at its junction with the old A2 footway at TQ 6407 7144 and runs in a north-westerly direction for 81 metres to a junction with a new cycleway at TQ 6403 7151.

PUBLIC PATH CREATION ORDER 2015**

On 25th November 2015, the Kent County Council confirmed the above Order under Section 26 of the Highways Act 1980.

The effect of the Order, as confirmed, is to create a new length of Public Footpath numbered NG23 which commences at a junction with Wrotham Road at grid reference TQ 6413 7141 and runs in a west-north-westerly direction (with a width of 2 metres) for 139 metres to TQ 6400 7147, then continuing in a north-north-easterly direction (with a width of 3 metres) for 110 metres to a junction with Coldharbour Road at TQ 6406 7156.
