

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

SCHOOL LANE & ELMSTONE HOLE ROAD, LENHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of carriageway and drainage works, Kent County Council has made an Order prohibiting through traffic on School Lane & Elmstone Hole Road, Lenham.

SCHEDULE

School Lane, Lenham – Lenham Road to Headcorn Road
22nd February 2016 for up to 1 day

Alternative route is via Headcorn Road, Green Lane and Lenham Road

Elmstone Hole Road – Liverton Hill to Lenham Road
29th February 2016 for up to 2 days

Alternative route is via Lenham Road, Park Road, Headcorn Road and Liverton Hill

UPPER HUNTON HILL & HUNTON HILL, HUNTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of carriageway works, Kent County Council intends to make an Order prohibiting through traffic on Upper Hunton Hill & Hunton Hill, Hunton, on or after 9 March 2016 for up to 1 day or until the works have been completed.

There will be no access for through traffic between the junctions with B2163 Heath Road and West Street.

The alternative route is via West Street, Mill Lane, B2162 Benover Road, B2010 High Street/Yalding Hill/Smith's Hill, B2163 Ewell Lane/Heath Road.

SEVENOAKS AREA

CASTLE FARM ROAD, SHOREHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of essential network repairs, Kent County Council has made an Order prohibiting through traffic on Castle Farm Road, Shoreham, on or after 22 February 2016 for up to 5 days or until the works have been completed.

The road will be closed at the junction with Redmans Lane.

The alternative route is via Cockerhurst Road and Redmans Lane.

SWALE AREA

CROWN ROAD, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of works to provide a new gas supply, Kent County Council has made an Order to temporarily prohibit through traffic on part of Crown Road, Sittingbourne.

A closure is planned to commence from Monday 22 February 2016 for an estimated period of up to 3 days.

Crown Road will be closed to the east of the junction with Beechwood Avenue, with access from either direction up to where the road is closed, but no through access.

The alternative routes are

Westbound via High Street and St Paul's Street

Eastbound via Windmill Road, Laxton Way, Vicarage Road and Milton High Street

Access to Beechwood Avenue continues from the Staplehurst Road direction.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

SWANTON STREET, BREDGAR (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of works to provide a new electricity supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Swanton Street, Bredgar, Sittingbourne.

A closure is planned to commence from Monday 7 March 2016 with estimated completion by 11 March 2016

Swanton Street will be closed to the north of the junction with Bashford Barn Lane, with no through access during works.

The alternative route is via Bashford Barn Lane, Hawks Hill Lane, Bexon Lane and The Street.

Access remains from either direction up to where the road is closed, but there will be no through access.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

WARDEN ROAD, EASTCHURCH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow safe access to underground footway and carriageway boxes for fibre cabling and jointing works for a new customer connection, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Warden Road, Eastchurch, Isle of Sheppey.

An off-peak closure is planned for Monday 7 March 2016, between 09:30 hours and 15:30 hours.

Warden Road will be closed in the vicinity of the pumping station and electricity sub-station, with access from either direction up to where the road is closed, but no through access during the works.

The alternative route is via Second Avenue and Fourth Avenue.

TONBRIDGE & MALLING AREA

CLAYGATE LANE, SHIPBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because it is necessary to install fibre optic cabling, Kent County Council intends to make an Order prohibiting through traffic on Claygate Lane, Shipbourne, on or after 7 March 2016 for up to 5 days or until the works have been completed.

There will be no access for through traffic between the junctions with Reeds Lane and Puttenden Road.

The alternative route is via Claygate Road, Hamptons Road and Puttenden Road.

GRANGE HILL, PLAXTOL (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of line maintenance and renewal, Kent County Council intends to make an Order prohibiting through traffic on Grange Hill, Plaxtol, on or after 7 March 2016 for up to 4 days or until the works have been completed.

The whole length of the road will be closed.

The alternative route is via Tree Lane, Church Hill, The Street, Long Mill Lane and Dux Hill.

LONG MILL LANE, PLATT (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of a new water connection, Kent County Council has made an Order prohibiting through traffic on Long Mill Lane, Platt, on or after 22 February 2016 for up to 5 days or until the works have been completed.

The road will be closed outside Bell Orchard.

The alternative route is via Comp Lane and Beechin Wood Lane.

REEDS LANE, SHIPBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because it is necessary to install fibre optic cable, Kent County Council has made an Order prohibiting through traffic on Reeds Lane, Shipbourne, on or after 22 February 2016 for up to 12 days or until the works have been completed.

The whole length of the road will be closed.

The alternative route is via Claygate Road, Puttenden Road, A227 Shipbourne Road/Tonbridge Road and Back Lane.

PARK ROAD, ADDINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because it is necessary to take down a pole transformer and convert to a compact transformer, Kent County Council has made an Order prohibiting through traffic on Park Road, Addington, on or after 22 February 2016 for up to 15 days or until the works have been completed.

There will be no access for through traffic between the junctions with Trottscliffe Road and The Chestnuts.

The alternative route is via Trottscliffe Road, A20 London Road, St Vincents Lane and Park Road.

WAVENEY ROAD, TONBRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because it is necessary to replace a traffic island, Kent County Council intends to make an Order prohibiting through traffic on Waveney Road, Tonbridge, on or after 6 March 2016 for up to 1 day or until the works have been completed.

There will be no access for through traffic between the junctions with Tyne Road and Mersey Road.

The alternative route is via Darenth Avenue, A227 Shipbourne Road, Trench Road and Northwood Road.

THE KENT COUNTY COUNCIL (VARIOUS ROADS, TONBRIDGE and MALLING) (WAITING RESTRICTIONS & ON-STREET PARKING PLACES) (AMENDMENT 10) ORDER 2016 Road Traffic Regulation Act 1984

THE KENT COUNTY COUNCIL acting as the local traffic authority and in exercise of its powers under Sections 1, 2, 5, 32, 45, 46, 47 and 124 of the Road Traffic Regulation Act 1984, and of all other powers and after consultation with the Chief of Police in accordance with Part III of Schedule 9 to said Act of 1984, proposes to make the following Order:

The effect of the proposed named Order will introduce or amend existing waiting restrictions in the following lengths of road (in this part of the notice DYL means double yellow lines) - No waiting at any Time

LADDS LANE, SNODLAND

From its junction with Manley Boulevard for 131 metres in a north-westerly direction.

TUNBRIDGE WELLS AREA

DRAPER STREET, SOUTHBOROUGH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of the installation of BT cables, Kent County Council intends to make an Order prohibiting through traffic on Draper Street, Southborough, on or after 7 March 2016 for up to 4 days or until the works have been completed.

The road will be closed outside number 1 to The Warehouse.

The alternative route is via Pennington Road, A26 London Road and Sheffield Road.

Tunbridge Wells Half Marathon 21st February 2016

Kent County Council gives Notice that owing to the likelihood of danger to the public whilst an event is being held on the highway, Kent County Council has made an Order; the effect will be to temporarily prohibit the use of Vehicles on:-

A26 St John's Road/London Road between Powder Mill Lane and Birchwood Avenue
Birchwood Avenue, Bounds Oak Way, Darnley Drive, St Lawrence Avenue, Woodland Way

B2176 Bidborough Ridge junction with Woodland Way – prohibit westbound traffic.

B2176 Bidborough Ridge, B2176 Penshurst Road, B2176 Rogues Hill, B2188 High Street Penshurst, B2188 Fordcombe Road, B2188 New Road, B2188 Saints Hill

B2188 Spring Hill between Sandfield Road and Chafford Lane. Diversion is via Chafford Lane, Walters Green Road and Sandfield Road.

B2188 Fordcombe Road, A264 Ashurst Road

A264 Langton Green Road between A264 Ashurst Road and Major Yorks Road – prohibit eastbound traffic.
Diversion is via A264 Ashurst Road, B2188 Fordcombe Road, Chafford Lane, Walters Green Road, Sandfield Road, B2188 Saints Hill/New Road/Fordcombe Road/High Street, B2176 Rogues Hill/Penshurst Road/Bidborough Ridge, A26 London Road/St John's Road, A264 Mount Ephraim/Bishops Down/Langton Road.

Newlands, Dornden Drive, A264 Bishop's Down, A264 Mount Ephraim

A26 Mount Ephraim between A26 St John's Road/Grosvenor Road/London Road – prohibit southbound traffic. Diversion is via A26 Grosvenor Road, Upper Grosvenor Road, Meadow Road, Goods Station Road, A26 Grosvenor Road/Mount Pleasant Road, A264 Church Road.

A26 St John's Road/Grosvenor Road to Powder Mill Lane
Prohibit left and right hand turns on the roads below as indicated by signage on site:

Any Vehicle being used for Ambulance purposes, Coastguard/RNLI, Fire Brigade or Police services.

Anything done by a Statutory Undertaker vehicle in connection with an emergency repair.

Anything done with the permission or at the direction of a KCC traffic Marshal, Event Organisers or a Police Constable in Uniform;
