

Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

Road, south west for a distance of 21 metres; **ROADS IN NEW ROMNEY: Church Approach**, Both sides, for its entire length; **Church Road**, Both sides, from its junction with Station Road to its junction with Church Approach; South east side, from its junction with Church Lane, south west for a distance of 16 metres; North west side, from its junction with Church Approach, south west for a distance of 46 metres; North west side, from a point 76 metres south east of its junction with Church Approach, to its junction with Victoria Street; Both sides, from its junction with Church Road, south east for a distance of 13.5 metres; **Langport Road**, Both sides, from its junction with Station Road, north east for a distance of 26 metres; **Littlestone Road**, North east side, from a point 47.5 metres south west of its southern junction with Warren Road to its junction with Station Road; South west side, from a point 24 metres south east of its junction with Station Approach, to its junction with Station Road; **Mountfield Road**, Both sides, from its junction with Station Road, south west for a distance of 46 metres; **Station Road**, North east side, from its junction with Littlestone Road, to a point 46 metres north west of its junction with Langport Road; South west side, from its junction with Littlestone Road, to a point 41 metres north west of its junction with Mountfield Road; **Warren Road (north west junction)**, Both sides, from its junction with Littlestone Road, north east for a distance of 59 metres; **Warren Road (south east junction)**, Both sides, from its junction with Littlestone Road, north for a distance of 46 metres

No stopping at any time on the following roads:

ROADS IN FOLKESTONE: Park Farm Road, West side, from a point 39 metres north of its junction with Radnor Park Road, north for a distance of 26 metres; **ROADS IN NEW ROMNEY: Church Road**, North west side, from a point 46 metres south west of its junction with Church Approach, south west for a distance of 27 metres

Revocation of no waiting at any time from the following roads:

ROADS IN FOLKESTONE: Holywell Avenue, Both sides, from a point 340 metres west of its junction with Canterbury Road (A260), west for a distance of 30 metres including the western and southern area of the turning head

Any person wishing to question the validity of the Notice or any of its provisions on the grounds that it is not within the powers of the relevant enabling Act or that a requirement of any such enabling Act or of any relevant regulations made there under has not been complied with may, within 6 weeks from the date on which the Notice was published, make application for the purpose to the High Court.

SWALE AREA

B2006 MILL WAY, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow carriageway resurfacing works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of B2006 Mill Way, Sittingbourne

An overnight closure is planned for Monday 27 June 2016 from 19:30 hours through until 05:00 hours

B2006 Mill Way will be closed between the roundabout junction with A2005 (Mill Way / King Street) to a point north of the entrance to Morrisons, with no through access during these works

The alternative route for all through traffic is via B2006 King Street, St Paul's Street, Staplehurst Road, Bobbing Interchange, A249 Iwade Bypass, B2005 Grovehurst Road, Swale Way, Castle Road, B2006 Eurolink Way and Mill Way

B2007 MAIN ROAD, QUEENBOROUGH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow carriageway resurfacing works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of B2007 Main Road, Queenborough.

Overnight closures are planned from Wednesday 29 June 2016 for up to 2 nights, between 20:30 hours through until 05:00 hours each night

B2007 Main Road will be closed between the junction with Brielle Way and the roundabout junction with Railway Terrace, with no through access during works.

The alternative route for all through traffic is via A249 Brielle Way, B2007 Whiteway Road, North Road and Main Road

CLAXFIELD ROAD, LYNSTED (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of gas mains replacement works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Claxfield Road, Lynsted, Sittingbourne.

A closure is planned to commence from Monday 27 June 2016 with estimated completion by 22 July 2016

Claxfield Road will be closed between the junctions with Wood Street and Lynsted Lane. Access remains from either direction up to where the Claxfield Road is closed, but there will be no through access.

The alternative route is via Lynsted Lane, A2 London Road and Claxfield Road.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

FROGNAL LANE, TEYNHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow drainage improvement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Frogнал Lane, Teynham, Sittingbourne

A closure is planned for Monday 11 July 2016 from 09:00 hours until approximately 16:00 hours

Frogнал Lane will be closed to through traffic for its entire length.

The alternative route is via A2 London Road, Station Road and Lower Road

KIT HILL, BOUGHTON UNDER BLEAN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow a detailed bridge inspection to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Kit Hill, Boughton under Blean, Faversham.

A closure is planned for Monday 11 July 2016 from 09:00 hours through to 16:00 hours

Kit Hill will be closed in the vicinity of the railway bridge. Access remains from either direction up to where Kit Hill is closed, but there will be no through access

The alternative route is via Selling Road and Crouch Lane

SALTERS LANE, FAVERSHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of works to lay phone ducting in the carriageway, Kent County Council has made an Order to

temporarily prohibit through traffic on part of Salters Lane, Faversham.

A closure is planned to commence from Monday 27 June 2016 for an estimated period of up to 5 days.

Salters Lane will be closed in the vicinity of the junction with A2 Canterbury Road, with no through access during works.

Access to the remainder of Salters Lane continues from the southern direction (i.e. from A251 Ashford Road).

The alternative route for all through traffic is via A2 Canterbury Road, A251 Ashford Road and Salters Lane.

Due to the nature of these works, it is unlikely the road can be re-opened outside the working hours.

TONGE ROAD, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow drainage improvement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Tonge Road, Sittingbourne.

A closure is planned for Monday 11 July 2016 for up to 1 day.

Tonge Road will be closed to the east (Lomas Road) side of the junction with All Saints Road, with no through access during works.

The alternative route is via Murston Road, A2 Canterbury Road / Fox Hill / The Street, Hempstead Lane, Church Road and Lomas Road

Access to the remainder of Tonge Road / Lomas Road continues from either direction up to where the road is closed, but there will be no through access.

TONBRIDGE & MALLING AREA

VARIOUS ROADS, MAIDSTONE & TUNBRIDGE WELLS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because carriageway surface treatment works are proposed to be carried out on or near a road, Kent County Council has made an order to prohibit traffic on the routes described in the Schedule below.

The Order will come into operation on 30th June 2016 and will be valid for a maximum period of 18 months or until the works have been completed, whichever is sooner.

Planned dates will be indicated by signage displayed on site 7 days in advance. Road closures and other restrictions will be in effect when the appropriate signage and barriers are in place.

This programme is subject to weather and other factors and may therefore change; every effort will be made to keep as close as possible to the programmed dates and duration. Changes will be notified locally and signposted on site.

Audley Rise, Tonbridge.

On Thursday 30th June 2016 for 2 days between the hours of 10.00hrs and 14.00hrs.

Thursday- Audley Rise to Ives road between the hours of 10.00hrs and 14.00hrs

AUDLEY AVENUE, TONBRIDGE - closed between Barden Park Road and Audley Rise on Thursday 30th June for 2 days between the hours of 10.00hrs and 14.00hrs
Friday Audley Avenue, Ives Road to Pembroke Road.
Diversion via Ives Road, Clare Avenue and Pembroke Road, Rescinds one way order.

BASTED MILL, BOROUGH GREEN- Closed between Quarry Hill Road and Mill Lane on Monday the 11th

July 2016 for 2 days between the hours of 09.30hrs and 16.00hrs.

Diversion Via Thong Lane and Mill Lane

GARDEN ROAD, TONBRIDGE- Closed A227 Hadlow Road on Friday 1st July 2016 for 1 day between the hours of 10.00hrs and 14.00hrs.

HIGH CROSS ROAD, IGHTHAM - Closed between The A227 Ightham Road and Coach Road on Thursday 7th July 2016 for 2 days between the hours of 08.30hrs and 16.00hrs.

Diversion via The A227 Ightham Road, The Street, A227 Borough Green Road, The A25 Sevenoaks Road and Coach Road.

PINE TREE LANE-on Friday 8th July for 1 day between the hours of 08.30hrs and 16.00hrs. Diversion via Coach Road and Stone Street Road.

TONBRIDGE & MALLING AND MAIDSTONE AREAS

BROOK STREET, B245 TONBRIDGE ROAD, TONBRIDGE & MALLING AND FARLEIGH LANE, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of carriageway resurfacing, Kent County Council intends to make an Order prohibiting through traffic on Various Roads, as per the schedule below or until the works have been completed.

The Order will come into operation on 4 July 2016 and will be valid for a maximum period of 18 months or until the works have been completed, whichever is sooner. The anticipated dates of works are listed in the schedule.

4 July 2016 for up to 4 nights between 19.00 and 01.00
Diversion via A26 Quarry Hill Road/London Road, B2176 Bidborough Ridge and Hayesden Lane

B245 Tonbridge Road, Hildenborough - between Foxbus and Mount Pleasant
22 July 2016 for up to 2 working nights between 22.00 and 05.00
Diversion via Stocks Green Road and Watts Cross Road

TUNBRIDGE WELLS AREA

MAJOR YORKS ROAD, TUNBRIDGE WELLS (PROHIBITION OF SOUTHBOUND TRAFFIC) TEMPORARY ORDER 2016

Because of a new gas service to be installed, Kent County Council has made an Order prohibiting southbound traffic on Major Yorks Road, Tunbridge Wells, on or after 26 June 2016 for up to 3 days or until the works have been completed.

The restriction will be from A26 London Road to the entrance of the car park.

The alternative route is via A264 Bishop's Down/Mount Ephraim/Church Road and A26 London Road.
