### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

HIGHWAYS ACT 1980  
WILDLIFE AND COUNTRYSIDE ACT 1981

THE KENT COUNTY COUNCIL (PUBLIC FOOTPATH WT203 (PART),  
CAPEL)  
PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT  
MODIFICATION ORDER 2016

On 8th July 2016 the Kent County Council confirmed the above Order under Section 119 of the Highways Act 1980.

The effect of that Order as confirmed is to divert the entire width of that length of public footpath numbered WT203 which commences at NGR TQ 6217 4411 (point A) and runs south for 208.0 metres to NGR TQ 6216 4391 (point B), between the points A-B on the Order plan and to provide a new length of public footpath numbered WT203, with a width of 2.0 metres, which commences at the aforementioned point A and runs west-south-west for 129 metres where it enters the woodland at NGR TQ 6215 4408 (point C), then turns to run south through south-east for 243.0 metres to the aforementioned point B. A total length of 372.0 metres between the points A-C-B on the Order plan.

All directions general, all distances approximate.

A copy of the Order as confirmed and the Order Map have been placed and may be seen free of charge at the Offices of Tunbridge Wells Borough Council, Town Hall, Royal Tunbridge Wells, Kent, TN1 1RS or at the Kent County Council, PROW & Access Service, Invicta House, Maidstone, Kent, ME14 1XX. The Order comes into force on 19th August 2016, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act which has not been complied with in relation to the Order, he or she may under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within 6 weeks from the 22nd July

2016, make an application to the High Court.

BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991

**Kent County Council has made an Order the effect of which is to temporarily close (FP WT216), from the junction with Old Church Road for a distance of 351m to TQ 6232 4232 from the 25 July 2016.**

The path will be closed for a maximum of six months, although it is expected that it will reopen before 15 August 2016.

The path is to be closed because works are planned on or near it to install ducts and cables for UKPN.

There is no alternative route.
