Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

A28 ASHFORD ROAD, CHILHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow bridge waterproofing repairs followed by carriageway resurfacing to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of A28 Ashford Road, Chilham,

A weekend closure is planned from Friday 12 August 2016 at 20:00 hours continuing through until Sunday 14 August at 22:30 hours.

A28 Ashford Road will be closed at Chilham, at the bridge between the sewage works and the junction with Branch

~ There will be no direct access between Ashford and Canterbury using the A28, during these works

The alternative route is via A252 Maidstone Road (Chilham), The Street, Canterbury Road, A251 Buck Street, A251 / A2042 Faversham Road, Penlee Point, A28 Canterbury Road and Ashford Road

Access to the remainder of the A28 continues from either direction up to where the road is closed, but there will be no through access.

PETT LANE, CHARING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow works to provide a new water connection to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Pett Lane, Charing.

A closure is planned to start from Monday 8 August 2016 for an estimated period of up to 5 days.

Pett Lane will be closed between the junctions with The Hill and Toll Lane, with no through access during works. The alternative route is via High Street, A20 Ashford Road, Wicken Lane and Pett Lane.

Access remains from either direction up to where Pett Lane is closed, but there will be no through access

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

THE STREET, WESTWELL (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2016**

Because of kerbing works together with works to replace broken gullies, Kent County Council has made an Order to temporarily prohibit through traffic on part of The Street, Westwell, Ashford

Daytime closures are planned from Monday 25 July 2016 for an estimated period of up to 2 weeks.

The Street, Westwell will be closed to through traffic between the junctions with Watery Lane and Westwell Lane, with no through access during the works.

The alternative route is via Watery Lane, A20 Maidstone Road and Westwell Lane

VARIOUS ROADS, ASHFORD - SURFACE TREATMENTS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow a programme of carriageway micro-surfacing and surface dressing to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on various roads in the Ashford District.

Closures are planned to commence on or after 27 July 2016, as detailed below. The dates of closures will sign-posted on site and notified to local residents.

The roads affected, planned dates, extent of closures and alternative routes are as shown below.

Closures are within the times 07:00 hours and 19:00 hours

Some roads may need a brief repeat closure 1-2 weeks after the original closure, to allow for the reinstatement of road markings and adjustment of iron works (road drain covers, manhole covers, etc) to suit the new surface. Any repeat closures will be notified by signage on site.

OLD SURRENDEN MANOR ROAD, GREAT CHART - closed between A28 Ashford Road and Mill Road

Alternative route via A28 Ashford Road, Forge Hill and Mill

MOOR LANE, WOODCHURCH / APPLEDORE – closed for its entire length (i.e. between B2067 and Woodchurch Road)

28 July-1 August 2016. Alternative route via B2067 Brook Street, Appledore Road, Bench Hill and Woodchurch Road

SHADOXHURST ROAD, WOODCHURCH - closed between Bethersden Road and Place Lane

1-2 August 2016

Alternative route via Bethersden Road, Front Road, The Green and Place Lane

DOWLE STREET ROAD, PLUCKLEY - closed between

Pluckley Road and Sparrow Hatch Lane.

1-2 August 2016

Alternative route via Pluckley Road, Bethersden Road and Sparrow Hatch Lane

CADES ROAD, HOTHFIELD - closed for its entire length 1-2 August 2016

Alternative route via A20 Maidstone Road and Station

The traffic order preventing coast-bound traffic on A20 Maidstone Road turning right into Station Road will be suspended whilst Cades Road is closed

SCHOOL ROAD, APPLEDORE - closed for its entire length (i.e. between B2080 Tenterden Road and Woodchurch Road/Heath Road/Kenardington Road

3 August 2016 Alternative route via B2080 Tenterden Road and Heath

FERRY ROAD. APPLEDORE - closed between Court Lodge Road and B2080 Tenterden Road

3-8 August 2016

Alternative route via Court Lodge Road, The Street and B2080 Tenterden Road

FERRY ROAD, APPLEDORE / APPLEDORE ROAD, STONE closed between Court Lodge Road and The Street / Catts

Alternative route via School Road, B2080 Tenterden Road / Reading Street / Appledore Road / East Hill / Oaks Road, A28 High Street / West Cross, B2082 Smallhythe Road / Poplar Road / Wittersham Road, Stocks Road and Catts Hill

Note that only one section of Ferry Road will be closed at

BIRCHOLT FORSTAL, BRABOURNE - closed for its entire length.

8 August 2016

There is no alternative route as the road is a cul-de-sac CORONATION DRIVE, GREAT CHART also including Bean Close and The Paddocks – closed in phases for entire

24-26 August 2016

There is no alternative route as the roads are cul-de-sacs

This programme is subject to weather and other factors which potentially may cause some changes; every effort will be made to ensure all changes are promptly notified.

CANTERBURY AREA

BEACH WALK, WHITSTABLE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow demolition and construction works for new dwellings to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Beach Walk, Whitstable.

A number of closures are planned to commence from Monday 8 August 2016 onwards, continuing until works have been completed, currently estimated to be February

Closures will be at various times as and when necessary: generally weekdays only, but additional overnight closures may also be needed for utility works if required.

When closures are in operation, they will be clearly indicated by relevant signage displayed on site. The closures are needed for deliveries, use of a mobile

crane and other construction activities Beach Walk will be closed in the vicinity of The Savoy

Snooker Club.

The alternative route is via Beach Walk and B2205 Tower

BRYAN ADAMS CONCERT, CANTERBURY (TRAFFIC RESTRICTIONS) TEMPORARY ORDER 2016

For the safety of the public during the staging of a Bryan Adams Concert, Kent County Council intends to make an Order to temporarily restrict traffic on certain roads in the vicinity of The Spitfire Ground, Canterbury

Restrictions come into force on Saturday 13 August 2016 as shown below, and will remain in force until safe to lift

The following roads will be closed to the extent indicated, from 21:00 hours to approximately 23:30 hours, with local diversions signed on site

B2068 ST LAWRENCE ROAD, CANTERBURY - closed for its

B2068 NACKINGTON ROAD, CANTERBURY – closed between the junctions with Merton Lane and Old Dover

OLD DOVER ROAD, CANTERBURY

- · Closed in both directions between the junctions with Ethelbert Road and Nackington Road

Closed northbound only - between the junctions with New Dover Road and B2068 Nackington Road

The road closures do not apply to taxis or buses on stage carriage and park and ride services Operatives on site will allow managed access for residents and visitors into locations where there are road closures

Waiting will be prohibited at all times on the following roads, from 15:00 hours through to 23:30 hours, as clearly indicated by signs and cones on site

OLD DOVER ROAD -

- · on both sides, between the junction with St Lawrence Road southwards to the roundabout junction with New Dover Road, to the extent indicated by signage on site
- · on the northern side, between the junctions with St Lawrence Road and St Lawrence Close

ST LAWRENCE ROAD - on both sides for its entire length B2068 NACKINGTON ROAD - on both sides between the junctions with Old Dover Road and The Foreland

This Order suspends any existing parking entitlements and restrictions that currently apply to the sections of road identified above.

CHEQUERS HILL, PETHAM (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2016**

To allow works to provide a new electricity supply to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Chequers Hill, Petham, Canterbury.

A closure is planned to commence from Monday 8 August

Chequers Hill will be closed in the vicinity of Yew Tree Park, with access to the remainder of Chequers Hill continuing from either direction up to where the road is closed.

The alternative route is via B2068 Stone Street, Town Road, The Street and Church Lane.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

COULTER ROAD & DOLPHIN STREET, HERNE BAY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of carriageway patching works, Kent County Council has made an Order to temporarily prohibit through traffic on Coulter Road and Dolphin Street, Herne

COULTER ROAD, GREENHILL closed for its entire length Off-peak Closure Tuesday 26 July 2016 for 1 day, 09:30 hours to 15:30 hours

The alternative route is via Cornwall Road and Blackburn

DOLPHIN STREET, HERNE BAY closed for its entire length Closed from Tuesday 26 July 2016 for up to 3 days

The alternative route is via High Street, Richmond Street and Central Parade

Access to Telford Street remains from Richmond Street

HOLLOW LANE & HOLLOWMEDE, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow gas mains replacement works to be carried out. Kent County Council has made an Order to temporarily prohibit through traffic on sections of Hollow Lane and Hollowmede, Canterbury.

Phased closures are planned to commence from 25 July 2015 with estimated completion by 4 September 2015

HOLLOW LANE will be closed in between the junctions with A28 Wincheap and Hollowmede

The alternative route is via A28 Wincheap, Homersham HOLLOWMEDE will then be closed in the vicinity of the

iunction with Hollow Lane, with access remaining from Flham Road direction This closure is for approximately 2 weeks
The alternative route is via A28 Wincheap, Victoria Road,

Cogan's Terrace and Elham Road. The timing of the phases is depends on weather and ground conditions, and the exact extent will be notified to local residents and signposted on site.

Due to the nature of these works, it will not be possible to re-open the roads outside the working hours.

RADFALL HILL, CHESTFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow gas mains replacement works to be carried out, Kent County Council has made an Order to temporarily rohibit through traffic on part of Radfall Hill, Chestfield

Phased closures are planned to start from Monday 25 July 2016 with estimated completion by 4 September 2016. Radfall Hill will be closed in phases from the junction with

Broomfield Gate working towards Radfall Ride, with no

through access during works. The alternative route is via South Street, Millstrood Road, A2990 (Old) Thanet Way, A290 Clapham Hill / Pean Hill / Blean Common / Blean Hill / Tile Kiln Hill / Whitstable Road / St Thomas Hill / Whitstable Road, Forty Acres Road Beaconsfield Road, Canterbury Hill, Wood Hill, Hackington

Road and Radfall Road Access remains from either direction up to where the road is closed, but there will be no through access.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

DARTFORD AREA

A296 & A225 PRINCES ROAD, DARTFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because it is necessary for surfacing works, to install road studs and road markings, Kent County Council intends to make an Order prohibiting through traffic on A296 and A225 Princes Road, Dartford, on or after 8 August 2016 for up to 1 week between 22.00 hrs and 05.30hrs or until the works have been completed.

SCHEDULE

A296 Princes Road - from Princes Road Roundabout at A282 Junction 1B to junction with B2500 Watling Street Diversion is via A296 Watling Street, Bean Lane interchange, A2 Dartford By-Pass, M25 J2, A2 Dartford By-Pass, A2018 Old Bexley Lane/Shepherds Lane, B2174 Princes Road and A225 Princes Road.

A225 Princes Road - from Princes Road Roundabout at A282 Junction 1B to Park Road Roundabout

Diversion is via B2174 Princes Road, A2018 Shepherds Lane/Old Bexley Lane, A2 Dartford By-Pass, M25 J2, A2
Dartford By-Pass, Bean Lane Interchange, and A296

COMMON LANE, WILMINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of drainage repair works, Kent County Council intends to make an Order prohibiting through traffic on Common Lane, Wilmington, on or after 8 August 2016 for up to 3 weeks or until the works have been completed.

There will be no access for through traffic between the iunctions with Oakfield Lane and Parsons Lane.

The alternative route is via Oakfield Lane, A225 Hawley Road, B258 Church Hill/High Road.

HIGHFIELD ROAD, DARTFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of new gas services, Kent County Council has made an Order prohibiting through traffic on Highfield Road, Dartford, on or after 25 July 2016 for up to 7 days or until the works have been completed.

The road will be closed outside number 31 to 45.

The alternative route is via Heath Street, A225 Lowfield Street and A226 Instone Road.

ST VINCENT'S ROAD, DARTFORD (PROHIBITION OF NORTHBOUND TRAFFIC) TEMPORARY ORDER 2016

Because of gas main replacement works, Kent County Council has made an Order prohibiting northbound traffic on St Vincent's Road, Dartford, on or after 25 July 2016 for up to 6 weeks or until the works have been completed.

The road will be closed to northbound traffic at the junction of A226 The Brent.

The alternative route is via A226 The Brent/Fast Hill/Home Gardens, A2026 Hythe Street, Mill Pond Road, Temple Hill, Temple Hill Square and St Vincent's Avenue.

DOVER AREA

THE LINCES, DOVER (PROHIBITION OF DRIVING)

To allow road widening works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of The Linces, Dover.

A closure is planned to start from Monday 8 August 2016 for an estimated period of up to 4 weeks.

The Linces will be closed between both junctions with Byron Crescent, with no through access during works. The alternative route is via Byron Crescent.

Waiting will be prohibited at all times on both sides of Byron Crescent for its entire length, to ensure the road is clear to be used as a diversion.

Due to the nature of these works, it is unlikely the road can be re-opened outside the working hours, but it will be re-opened at any times that the works allow this.

CHALKY ROAD, STOCKBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of the replacement of a telegraph pole, Kent County Council intends to make an Order prohibiting through traffic on Chalky Road, Stockbury, on or after 12 August 2016 for up to 1 day or until the works have been

The road will be closed from A249 Sittingbourne Road to outside "Ash Wood".

The alternative route is via South Street Road, Church Lane, Church Hill and A249 Sittingbourne Road.

SEVENOAKS AREA

A25 SEAL ROAD, A25 BRADBOURNE VALE ROAD, A225 ST JOHN'S HILL & A225 OTFORD ROAD, SEVENOAR (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of minor changes to the crossroad islands and carriageway resurfacing, Kent County Council has made an Order prohibiting through traffic on A25 Seal Road, A25 Bradbourne Vale Road, A225 St John's Hill & A225 Otford Road, Sevenoaks, as per the schedule below
