Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

THANET AREA

ALBION STREET, BROADSTAIRS (PROHIBITION OF DRIVING) TEMPORARY ORDER SEPTEMBER 2016

To allow works to repair a water supply pipe to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Albion Street, Broadstairs

Daytime closures are planned from Monday 12 September 2016 for an estimated period of up to 3 days.

Albion Street will be closed in the vicinity of number 45, with no through access between the junctions with Dickens Walk and St Mary's Road.

Access continues from either direction up to where Albion Street is closed, but there will be no through access during the works. The alternative route is via B2052 High Street, Carlton

Avenue, Lindenthorpe Road, Crow Hill, B2052 Nelson Place and Albion Street.

NORTHDOWN PARK ROAD, MARGATE (PROHIBITION **OF DRIVING) TEMPORARY ORDER 2016**

To allow carriageway resurfacing works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Northdown Park Road, Margate

Overnight closures are planned from Tuesday 6 September 2016 for up 3 weekday nights, between 19:00 hours continuing through until 05:00 hours each night.

Northdown Park Road will be closed in both directions from the junction with Friendly Close (east of Foreland Avenue) eastwards to the junction with George Hill Road / Reading Street Road / Green Lane.

There will be no through access between Northumberland Avenue and Green Lane during these closures.

The overall alternative route for all through traffic is via Northdown Park Road, B2052 College Road, A255 St Peter's Road / Dane Court Road / Broadstairs Road / The Broadway, B2053 St Peter's Park Road / Albion Road / Beacon Road / Westover Road / Northdown Hill and Green Lane.

B2051 Queen Elizabeth Avenue will be closed between West Park Avenue and Northdown Park Road, with access remaining from Northdown Road.

B2052 Millmead Road will be closed between St Mary's Avenue and Northdown Park Road, with access remaining from the College Road direction.

PROSPECT ROAD, BIRCHINGTON (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2016**

To allow works to provide a new electricity supply to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Prospect Road, Birchington.

A closure is planned to commence from Monday 12 September 2016 for an estimated period of up to 5 days. Prospect Road will be closed from the junction with

Station Road to the vicinity of number 11.

The alternative route is via Station Road, Paddock Road, Westfield Road and Prospect Road.

The One-way Traffic Order in respect of Prospect Road will be suspended between the junction with Westfield Road and the point of closure, to allow access / exit.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.
