Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

ASHFORD AREA

COURT LODGE ROAD, APPLEDORE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow works to provide a new electrical service to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Court Lodge Road, Appledore.

A closure is planned from Monday 14 November 2016 for an estimated period of up to 5 days. Court Lodge Road will be closed in the vicinity of the

properties 'The Quillet's Garth' to 'Runsell', near the junction with The Street. The alternative route is via B2080 The Street, Tenterden Road, School Road and Court Lodge Road.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

GODINTON LANE, HOTHFIELD & WORTEN ROAD, GREAT CHART (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow works to be carried out to install telecoms cabling in existing underground ducting, Kent County Council has made an Order to temporarily prohibit through traffic on part of Godinton Lane, Hothfield & Worten Road, Great Chart, in the Ashford area.

Off-peak closures are planned from Monday 14 November 2016 for up to 3 days, between 09:30 hours and approximately 15:30 hours each day. Godinton Lane and Worten Road will be closed to

through traffic between Goldwyn Community School and the pumping station. There will be no through access between the junctions with Waterfall Road and Etchden Road / Ninn Lane.

The alternative route is via Etchden Road, Bears Lane, Bethersden Road, The Street, Park Drive and Waterfall Road.

SHOTTENDEN LANE, MOLASH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow works to be carried out to install a new joint box and cabling in connection with the provision of fibre-optic broadband, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Shottenden Lane, Molash, near Ashford.

A closure is planned to commence from Monday 28 November 2016 for an estimated period of up to 2 weeks. Shottenden Lane will be closed in the vicinity of Vicarage Cottages (approximately 100 metres of the junction with The Street) northwards for approximately 40 metres. The alternative route is via A252 The Street / Canterbury Road, A251 Faversham Road / Ashford Road, Shottenden Road and Shottenden Lane.

Due to the nature of these works, it will not be possible to re-open the road outside the working hours.

CANTERBURY AREA

JOY LANE, WHITSTABLE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow works to provide a new gas supply to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Joy Lane, Whitstable.

A closure is planned from Thursday 24 November 2016 for an estimated period of up to 3 days.

Joy Lane will be closed in the vicinity of number 86, with no access between the junctions with Genesta Avenue and Meteor Avenue

The alternative route is via Columbia Avenue, Sandpiper Road and Valkyrie Avenue.

Access to the remainder of Joy Lane continues from either direction up to where the road is closed, but there will be no through access at any time during these works. Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

PILGRIMS WAY, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

To allow cabling works to provide a new electricity supply to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on the cul-de-sac part of Pilgrims Way, Canterbury.

A closure is planned from Monday 28 November 2016 for an estimated period of up to 5 days. The cul-de-sac section of Pilgrims Way that is directly accessed from Spring Lane will be closed for its entire

length. There is no alternative route as Pilgrims Way is a No

Through Road. Limited access will be maintained by operatives on site,

but there are likely to be some delays and certain times when this is not possible, for safety reasons.

Access to the remainder of Pilgrims Way continues from Pilgrims Road or Mount Road. Due to the nature of these works, it will not be possible

to re-open the road outside the working hours

ST DUNSTAN'S TERRACE, CANTERBURY (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2016**

To allow safe access to underground structures for phone cabling works to restore customer service, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of St Dunstan's Terrace, Canterbury.

2016, between 09:30 hours and approximately 15:30 hours.

St Dunstan's Terrace will be closed from the junction with London Road southwards for approximately 25 metres. The alternative route is via London Road, New Street and Orchard Street.

CANTERBURY AND THANET AREAS

The coastbound A299 Thanet Way is unaffected at this stage.

This programme may be affected by weather and other factors which may cause changes at short notice; every effort will be made to keep as close as possible to the planned dates.

DARTFORD AREA

HILLTOP GARDENS, DARTFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of pipe laying to a new housing development, Kent County Council intends to make an Order prohibiting through traffic on Hilltop Gardens, Dartford, on or after 30 November 2016 for up to 8 days or until the works have been completed.

The road will be closed from Temple Hill for a distance of 50 metres.

The alternative route is via Hilltop Gardens and vice versa

PUDDLEDOCK LANE, WILMINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2016

Because of a new electric connection, Kent Cour Council has made an Order prohibiting through traffic on Stanhope Road, Swanscombe, on or after 12 November 2016 and 19 November 2016 for up to 2 days or until the works have been completed.

The road will be closed outside number 2 to 16. The alternative route is via High Street, A226 Galley Hill Road/Stonebridge Road/Thames Way, A2260 Ebbsfleet Gateway/Southfleet Road and Southfleet Road and vice versa.

CHAPMANS HILL, AYLESHAM (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2016**

To allow works to be carried out to install telecoms cabling in existing underground ducting, Kent County Council has made an Order to temporarily prohibit through traffic on part of Chapmans Hill, Aylesham, in the Dover area.
