

# Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

## THANET AREA

### **A256 RICHBOROUGH WAY, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017**

To allow works to be carried out to install transverse yellow safety markings on the approach to Ebbsfleet Roundabout, Kent County Council intends to make an Order to temporarily prohibit southbound traffic on part of A256 Richborough Way, Ramsgate.

Overnight closures are planned from Monday 12 June 2017 for up to 2 nights, between 19:00 hours through until approximately 07:00 hours each night.

A256 Richborough Way will be closed southbound only, between Sevenscore Roundabout and Ebbsfleet Roundabout.

The alternative route is via A299 Hengist Way, Lord of the Manor Roundabout and Sandwich Road.

Northbound traffic on A256 Richborough Way, Ramsgate is unaffected.

### **(VARIOUS ROADS, THE DISTRICT OF THANET) (PROHIBITION OF RIGHT HAND TURN MOVEMENTS) ORDER 2017**

Notice is hereby given that KENT COUNTY COUNCIL has made the above named Order under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

The effect of the named Order will introduce banned right hand turn movements (including pedal cycles) in the following lengths of road in Broadstairs:-

#### **WESTWOOD ROAD INTO ST. GEORGES PRIMARY SCHOOL VEHICLE ACCESS**

From Westwood Road (westbound) into St. Georges Primary School vehicle access, Broadstairs

#### **ST. GEORGES PRIMARY SCHOOL VEHICLE ACCESS INTO WESTWOOD ROAD**

From St. Georges Primary School vehicle access (southbound) into Westwood Road (westbound), Broadstairs.

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement in relation to the Orders.
