

THE TOWN AND COUNTRY PLANNING (DEVELOPMENT MANAGEMENT PROCEDURE) (ENGLAND) ORDER 2010

The following applications have been submitted for consideration by the Council:

Y17/0423/SH - Flat 8, 6 Augusta Gardens Folkestone Kent CT20 2RR - Replacement of 7 timber sash windows with uPVC casement windows.

Y17/0487/SH - Bofors Madeira Road Littlestone New Romney Kent - Removal of existing covered walkway, installation of double height window to front elevation, roof light windows to side elevations and replacement of tile hanging to side elevations with cladding.

Y17/0557/SH - Melway Close Fairfield Road New Romney Kent TN28 8HW - Erection of single storey side extension to replace existing side extension and garage.

Y17/0403/SH - 7 The Old High Street Folkestone Kent CT20 1RJ - Section 73 application for removal of Conditions 4 and 5 of planning permission Y16/1125/SH to enable live/amplified music to be played and refuse/recycling arrangements to be retained as existing.

Y17/0514/SH - 10 Marine Parade Folkestone Kent CT20 1PX - Installation of a boardwalk from Lower Leas Coastal park to the Harbour station.

Y17/0464/SH - 2 - 4 Shakespeare Centre 145 - 147 Sandgate Road Folkestone Kent CT20 2DA - Internally illuminated fascia sign, non-illuminated projecting sign, non-illuminated panel sign and internally illuminated panel sign.

Y17/0553/SH - 1 St Lawrence Court Lions Road New Romney Kent TN28 8DF - Erection of a single storey rear extension following removal of existing conservatory.

Y17/0549/SH - 25 The Stade Folkestone Kent CT19 6AB - Installation of rear dormer window, hip-to-gable extension and erection of single storey rear extension, together with the cladding of external walls (resubmission of Y17/0162/SH).
