# Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

BRISSENDEN GREEN LANE, BETHERSDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a telegraph pole for a new customer phone service, Kent County Council has made an Order to temporarily prohibit through traffic on part of Brissenden Green Lane, Bethersden, in the Ashford area.

An off-peak closure is planned for Saturday 30 September 2017, between 09:30 hours and approximately 15:30 hours.

Brissenden Green Lane will be closed in the general vicinity of Apple Tree Farm, with access from either direction up to where the road is actually closed, but no through access.

The alternative route is via Standard Lane, A28 Ashford Road and Woodchurch Road back to Brissenden Green Lane.

#### **CANTERBURY AREA**

#### HIGH STREET, BRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new gas supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of High Street, Bridge, near Canterbury.

A closure is planned from Monday 9 October 2017 for an estimated period of up to 3 days.

High Street, Bridge will be closed in the vicinity of number 29, with no through access between the junctions with Union Road and Western Avenue.

The alternative routes are as follows

Vehicles under 7.5T via Town Hill, Bekesbourne Road, Bifrons Hill, The Street (Patrixbourne), Patrixbourne Road

Eastbound via A2050 Dover Road, A2 Trunk Road, Bourne Park off-slip, Coldharbour Lane, Bonny Bush Hill and Bridge Hill back to High Street

Westbound via A2 Trunk Road, A2050 Dover Road, New Dover Road to Park and Ride Roundabout then eastbound on A2050 Dover Road to off-slip, Bifrons Hill, Bekesbourne Road and Town Hill back to High Street

Access to the remainder of High Street continues from either direction up to where the road is actually closed, but there will be no through access during these works.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours

#### HOATH ROAD, HOATH (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2017**

To allow carriageway surface treatment works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Hoath Road, Hoath, near Canterbury.

Daytime closures are planned from Monday 25 September 2017 for up to 4 days, between 07:00 hours and 19:00 hours each day

Hoath Road will be closed in 2 phases, as follows, with only one section closed at any one time.

Phase 1 - closed Between Hawe Lane and Bredlands Lane Alternative route via Babs Oak Hill, A28 Staines Hill, Island Road and Bredlands Lane

Phase 2 - Hoath Road will then be closed between Bredlands Lane and Hicks Forstal Road, once works completed on Phase 1.

Alternative route via Babs Oak Hill, A28 Staines Hill,

Island Road, The Glen, Nethergong Hill, Sandpit Hill, Church Lane, Boyden Gate Hill, Highstead, Ford Hill and Maypole Road

Access for residents will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

#### WESTBERE LANE, WESTBERE (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2017**

To allow works to be carried out to jet, clean and survey sewer pipes between manholes, Kent County Council intends to make an Order to temporarily prohibit through traffic on Westbere Lane, Westbere, near Canterbury.

Phased closures are planned from Monday 9 October 2017 for up to 5 days between 07:00 hours and 17:00

Westbere Lane will be closed in 2 phases, initially between the junctions with Staines Hill and Church Lane, then between Church Lane and Bushy Hill Road.

The alternative route is via A28 Staines Hill, Island Road and Bushy Hill Road.

#### MALTHOUSE ROAD, STANSTEAD & BEAN ROAD, GREENHITHE (PROHIBITION OF DRIVING) TEMPORARY **ORDER 2017**

#### HERON HILL LANE, MEOPHAM (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2017**

Because of new water connections, Kent County Council has made an Order prohibiting through traffic on Heron Hill Lane, Meopham, on or after 25 September 2017 for up to 3 days or until the works have been completed.
