Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

The road will be closed at the junction with Farley Lane. The alternative route is via Farley Lane, Croydon Road, High Street, New Street, Westbury Terrace, Granville

CROUCH HOUSE ROAD, EDENBRIDGE (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2017**

Because of railway maintenance works, Kent County Council has made an Order prohibiting through traffic on Crouch House Road, Edenbridge, on or after 00.01hrs 30 September 2017 to 23.59hrs 1 October 2017 or until the works have been completed.

The road will be closed at the railway bridge.

Because it is necessary to permantely reinstate the carriageway, Kent County Council has made an Order prohibiting through traffic on Hillingdon Avenue, Sevenoaks, on or after 1 October 2017 for up to 1 day or until the works have been completed.

The road will be closed at the junction with A25 Seal Road/Hospital Road.

The alternative route is via A25 Seal Road, A225 St Johns Hill, Wickenden Road, Little Wood and vice versa.

MORLEYS ROAD, SEVENOAKS WEALD (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2017**

Because of carriageway resurfacing, Kent County Council has made an Order prohibiting through traffic on Morleys Road, Sevenoaks Weald, on or after 27 September 2017 for up to 3 nights between 21.00hrs and 05.00hrs or until the works have been completed.

The road will be closed between A21 Sevenoaks By-Pass and Morleys Farm House.

The alternative route is via Glebe Road, Hubbards Hill, Gracious Lane, A225 Tonbridge Road/Riverhill and vice

WATERCROFT ROAD, HALSTEAD (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2017**

Because of the installation of signs and vegetation cut back, Kent County Council intends to make an Order prohibiting through traffic on Watercroft Road, Halstead, on or after 9 October 2017 for up to 3 days or until the works have been completed.

The road will be closed between Cadlocks Hill and Old London Road.

The alternative route is via London Road, Old London Road, Shoreham Lane, Station Road and vice versa.

WEALD INTERCHANGE (MORLEYS ROUNDABOUT). SEVENOAKS WEALD (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2017**

Because of carriageway resurfacing, Kent County Council has made an Order prohibiting through traffic on Weald Interchange (Morleys Roundabout), Sevenoaks Weald, on or after 25 September 2017 for up to 2 nights between 21.00hrs and 05.00hrs or until the works have been

The road will be closed on the east side at the junction

The alternative route is via A21 Sevenoaks Bypass, Quarry Hill Road, High Street, A227 Shipbourne Road, Stumble Hill, Ightham Road, Tonbridge Road, Bates Hill, The Street, Borough Green Road, Ightham Bypass, Sevenoaks Road, Maidstone, Road, High Street, Seal Road, St Johns Hill, Dartford Road, High Street, Tonbridge Road, River Hill and vice versa.

SHEPWAY

RADNOR CLIFF, FOLKESTONE (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2017**

To allow works to be carried out to provide a new water connection. Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Radnor Cliff, Folkestone.

Daytime closures are planned from Monday 9 October 2017 for up to 5 days, between 09:00 hours and 16:00 hours each day.

Radnor Cliff will be closed in the vicinity of number 21, just east of the junction with Radnor Cliff Crescent.

There is no alternative route as the road is a cul-de-sac.

The alternative route for cars and light vehicles only is via A251 Faversham Road, A2 Canterbury Road, Selling Road, Selling Street, Hogben's Hill, Winding Hill and New **House Lane**

For all vehicles over 3.5T, the diversions are as follows Southbound via A251 Faversham Road, A2 Brenley Corner / Canterbury Road / London Road / Boughton Bypass / Dover Road to eastbound off-slip, Bifrons Hill, Bekesbourne Road, Town Hill, Dover Road, to re-join A2 Dover Road westbound, Thanington Westbound Off-slip, A28 Thanington Road / Ashford Road / Canterbury Road A252 Maidstone Road / The Street / Canterbury Road, A251 Faversham Road and Ashford Road

Northbound via A251 Ashford Road / Faversham Road, A252 Canterbury Road / The Street / Maidstone Road, A28 Canterbury Road / Ashford Road / Thanington Road. A2 Dover Road / Boughton Bypass / Brenley Corner, A2 London Road / Canterbury Road back to A251 Ashford

Access to the remainder of the A251 continues from either direction up to where the road is actually closed, but there will be no through access during these works.

Access for any residents affected by the closures will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

The timing of the closures may potentially be affected by weather and ground conditions. Any changes to dates will be publicised and signposted on site.

WEST STREET, OUEENBOROUGH (PROHIBITION OF **WAITING) TEMPORARY ORDER 2017**

To allow the safe use of a mobile crane for maintenance works at Queenborough Creek Barrier (Flood Defences), Kent County Council intends to make an Order to temporarily prohibit parking on part of West Street, Queenborough, Isle of Sheppey.

TONBRIDGE HALF MARATHON (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2017**

The Tonbridge Half Marathon
