PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND
STATEMENT
MODIFICATION ORDER 2017

On 6th September 2017, the Kent County Council confirmed the above Order under section 119 of the Highways Act 1980.

The effect of the Order, as confirmed, is to divert the entire width of that length of Public Footpath Public Footpath CB422 which commences at its junction with Kenfield Road at Kenfield House and runs in an east-south-easterly through south-easterly direction for 265 metres to NGR TR 1229 5277, and provide a new length of Public Footpath to be numbered CB422 which commences at the aforementioned point at NGR TR 1229 5277 and runs in a north-westerly direction for 165 metres to the field boundary at NGR TR 1221 5292, continuing in a north-north-westerly direction for 25 metres to then run along the southern side of the boundary fence for 82 metres to a new junction with Kenfield Road at NGR TR 1213 5298. The path has an initial width of 2 metres where it crosses the field to the rear of Kenfield House and for the first 49 metres where it enters the garden of Kenfield House, after which the path narrows to a width of 1.75 metres for 8 metres and then narrows further to 1.2 metres for 18 metres. The path continues with a width of 1.8 metres (with the exception of a pinch point by a mature tree 5 metres in from the roadside) to its junction with Kenfield Road at which point there is a gap of 1.5 metres. All directions general, all distances approximate.

A copy of the Order and the Map have been placed and may be seen free of charge at the Canterbury City Council, Military Road, Canterbury, Kent, CT1 1YW or at the offices of the Kent County Council, PROW and Access Service, Invicta House, Maidstone, Kent ME14 1XX during normal office hours. Copies of the Order and Map may be purchased there at the price of £5.

The Order has now come into force but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act which has not been complied with in relation to the Order, he or she may under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within 6 weeks from the 22nd September 2017, make an application to the High Court.

DEFINITIVE MAP MODIFICATION ORDER 2017

The above Order was made on 12th September 2017 under section 53 of the Wildlife and Countryside Act 1981. If confirmed, it will modify the Definitive Statement only for Public Footpath NU5 by deleting the current entry, namely 'north to south section width recorded as 12 - 15 feet, remainder 6ft', and replacing it with 'North to South section width recorded as starting at 1.8 metres for 60 metres from "The Shore" before widening to 2.3 metres for a further 109 metres and then reducing to 1.8 metres for the remaining 24 metres before connecting with Crete Hall Road. The riverside East to West section, along "the Shore", is recorded as 4.5 metres'.

A copy of the Order and Map may be seen free of charge during normal office hours at the offices of Gravesham Borough Council, Civic Centre, Windmill Street, Gravesend, Kent DA12 1AU or at the Kent County Council, Countryside Access Service, Invicta House, County Hall, Maidstone, Kent ME14 1XX. Any representation about or objection to the Order must be sent or delivered in writing to Ms. Melanie McNeir at the Kent County Council (address as below) no later than Friday 3rd November 2017. Please state the grounds on which they are made.

Please note that objections/representations cannot be treated as confidential and may come into the public domain. Copies of any objections or representations received may be disclosed to interested parties, including the Planning Inspectorate where the case is referred to it for determination.

If no such representations or objections are duly made to the Order (or to any part of it), or if any so made are withdrawn, the Kent County Council, instead of submitting the Order to the Secretary of State (or part of it if the Authority has by Notice to the Secretary of State so elected under paragraph 5 of schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is sent to the Secretary of State for the Environment (in whole or in part), any representations or objections which have been duly made and not been withdrawn will be sent with it.
