The above-named Order, made on 29th September 2017 under section 118 of the Highways Act 1980, will extinguish the entire width and length of Public Footpath AE308 which commences at its junction with the public highway known as Whiteways at TR 1187 4145 and runs in a south-easterly direction for 130 metres to the field boundary at TR 1193 4133. All directions general, all distances approximate.

PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2017**

The above-named Order, made on 25th July 2017 under section 119 of the Highways Act 1980, will divert the entire width of that length of **Public Footpath AE308** which commences at an existing stile in the field boundary at TR 1197 4125 and runs in a north-north-easterly direction for 15 metres to its junction with Public Footpath AE309, continuing in a north-westerly direction for 85 metres to a field boundary at TR 1193 4133 and will provide a new length of **Public Footpath numbered AE308**, with a width of 2 metres, which commences at the previously described point at TR 1197 4125 and runs in a west-north-westerly direction along the northern side of the field boundary for 81 metres, then continuing in a north-easterly direction for 63 metres along the eastern side of the field boundary to re-join the line of Public Footpath AE308 at TR 1193 4133.

The Order will also divert the entire width of that length of **Public Footpath AE309** which commences at its junction with Public Footpath AE308 at TR 1197 4126 and runs in a northerly direction for 140 metres to a junction with the public highway known as 'Whiteways' (opposite Public Footpath HE154) and will provide a new length of **Public Footpath numbered AE309**, with a width of 2 metres, which commences at the previously described junction with the public highway known as 'Whiteways' and utilising part of that highway to run in a west-north-westerly direction for 4 metres, then continuing in a south-westerly direction, along the eastern side of the field boundary, for 85 metres to a junction with Public Footpath AE308 at TR 1193 4133.

THIS ORDER SUPERSEDES THE KENT COUNTY COUNCIL (PUBLIC FOOTPATH MR337 (PART) PLAXTOL) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2017.

A new order has been made due to an incorrect prefix on the grid references referred to in the previous order.

The above named Order made on 2nd October 2017 under Section 119 of the Highways Act 1980 will divert the entire width of that length of Public Footpath numbered MR337 which commences at NGR TQ 6200 5294 (point A on the order plan) and runs in a south easterly direction for 164 metres to NGR TQ 6210 5281 (point B) and then runs in a south easterly direction for 122 metres to NGR TQ 6216 5271 (point C). (Between the points A-B-C on the Order plan) and will add a new length of Public Footpath numbered MR337 with a width of 2.3 metres which commences at NGR TQ 6200 5294 (aforementioned point A) and runs in a south south westerly direction for 25 metres to NGR TQ 6200 5292 (point D) and then in a south south westerly direction for 37 metres to NGR TQ 6199 5288 (point E) and then continues in a east south easterly direction for 56 metres to NGR TQ 6204 5286 (point F) and continues in a south easterly direction for 87 metres to NGR TQ 6212 5281 (point G). The path continues via a slight curve in a south south easterly direction for 16 metres to NGR TQ 6212 5280 (point H) and then continues in a south south easterly direction for 100 metres to NGR TQ 6216 5271 (aforementioned point C). (Between the points A-D-E-F-G-H-C on the Order plan).
