

Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

ASHFORD AREA

ASHFORD ROAD, HAMSTREET (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to replace bridge joints to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Ashford Road, Hamstreet, near Ashford.

A closure is planned from Monday 23 October 2017, with estimated completion by 27 October 2017.

Ashford Road will be closed in the general vicinity of the bridge over the A2070 Hamstreet Bypass.

The alternative route is via A2070 Hamstreet Bypass, Marsh Road, The Street and Hamstreet Road and vice versa.

Access to the remainder of Ashford Road continues from either direction up to where the road is actually closed, but there will be no through access during these works.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

PLUCKLEY ROAD, CHARING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new water connection, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Pluckley Road, Charing, near Ashford.

A closure is planned from Monday 23 October 2017, for an estimated period of up to 5 days.

Pluckley Road will be closed in the vicinity of the junction with Blackberry Lane, to the south-west of the railway bridge.

The alternative route is via Station Road, A20 Ashford Road, Leacon Lane and Pluckley Road.

Access to Charing Station continues from the Station Road (Charing) direction

Access to the remainder of Pluckley Road continues from either direction up to where the road is actually closed, but there will be no through access during these works.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

CANTERBURY AREA

BOROUGH, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new electricity supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Borough, Canterbury.

An overnight closure is planned for Thursday 26 October 2017 from 21.00 hours through until approximately 06.00 hours.

Borough will be closed in the vicinity of the entrance to The King's School.

The alternative routes are

Eastbound via Palace Street, Orange Street, King Street, Knott's Lane, St Radigund's Street, Pound Lane, The Causeway, St Stephen's Road, Kingsmead Road, Northgate, New Ruttington Lane, Union Place, Victoria Row and Northgate

Westbound via St Radigund's Street, Knott's Lane and Kings Street

DERRINGSTONE STREET, BARHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow drainage improvement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on Derringstone Street, Barham, near Canterbury.

Phased closures are planned from Monday 23 October 2017 for an estimated period of up to 2 weeks.

Derringstone Street will be closed in short sections for its entire length, with access from either direction up to where the road is closed at any time

The alternative route for through traffic is via Railway Hill, Green Hills and Valley Road.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

HIGH STREET, BRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new gas supply, Kent County Council has made an Order to temporarily prohibit through traffic on part of High Street, Bridge, near Canterbury.

A closure is planned for Sunday 15 October 2017 for up to 1 day.

High Street, Bridge will be closed in the vicinity of number 29, with no through access between the junctions with Union Road and Western Avenue.

The alternative routes are as follows

Vehicles under 7.5T via Town Hill, Bekesbourne Road, Bifrons Hill, The Street (Patixbourne), Patixbourne Road and High Street

Vehicles over 7.5T

Eastbound via A2050 Dover Road, A2 Trunk Road, Bourne Park off-slip, Coldharbour Lane, Bonny Bush Hill and Bridge Hill back to High Street

Westbound via A2 Trunk Road, A2050 Dover Road, New Dover Road to Park and Ride Roundabout then eastbound on A2050 Dover Road to off-slip, Bifrons Hill, Bekesbourne Road and Town Hill back to High Street

Access to the remainder of High Street continues from either direction up to where the road is actually closed, but there will be no through access during these works. Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

HOLLOW LANE, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow carriageway repairs to be carried out, coupled with the installation of new kerbing and gullies, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Hollow Lane, Canterbury.

A closure is planned from Thursday 26 October 2017 with estimated completion by 3 November 2017.

Hollow Lane will be closed in the general vicinity of the A2 overbridge, with no through access between the junctions with Homersham and New House Lane.

Access to the remainder of Hollow Lane continues from either direction up to where the road is actually closed.

The alternative route for through traffic is via Iffin Lane, Merton Lane, B2068 Nackington Road, Old Dover Road, A28 Rhodaus Town, Pin Hill and Wincheap back to Hollow Lane.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

LOWER HERNE ROAD, HERNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow remedial works to be carried out following earlier works to install high voltage power cables, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Lower Herne Road, Herne, in the Canterbury area.

A closure is planned from Monday 23 October 2017 for an estimated period of up to 5 days.

Lower Herne Road will be closed in both directions from the 'Y' junction extending westwards along the narrow section to Strode Farm, with no through access at any time.

The alternative route is via Lower Herne Road, A291 Herne Street, Canterbury Road and Bullockstone Road.

Access to Ash Close will be maintained from an eastern direction,

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

NEW HOUSE LANE, THANINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new gas supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of New House Lane, Thanington, near Canterbury.

A closure is planned from Monday 23 October 2017 for an estimated period of up to 3 days.

New House Lane will be closed between New House Farm and number 76.

The alternative route is via Iffin Lane, Chartham Downs Road and New House Lane.

Access to the remainder of New House Lane continues from either direction up to where the road is actually closed, and most of the houses can be reached the northern (Hollow Lane) direction.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

PARK VIEW, STURRY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide new water and gas connections, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Park View, Sturry, near Canterbury.

A closure is planned from Monday 23 October 2017 for an estimated period of up to 5 days.

Park View will be closed between the junctions with Deansway Avenue and Broadlands.

The alternative route is via Deansway Avenue, A291 Herne Bay Road, Popes Lane, Hillbrow Avenue, River View, Woodside Road (McCarthy Avenue in opposite direction) back to Park View.

Access to the remainder of Park View continues from an eastern direction up to where the road is actually closed.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

ST STEPHEN'S HILL, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to install new telecoms cabling in the carriageway, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of St Stephen's Hill, Canterbury.

A closure is planned from Monday 23 October 2017 for up to 5 days

St Stephen's Hill will be closed to the north of St Stephen's Green, with access from either direction up to where the road is closed, but no through access.

The alternative route is via St Stephen's Road, B2248 Station Road West, St Dunstan's Street, Forty Acres Road, Beaconsfield Road and St Stephen's Hill.

An alternative route for vehicles under 7.5 T is via St Stephen's Hill, Downs Road, Tenterden Drive, Farleigh

Road and Broad Oak Road.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

WESTBERE LANE, WESTBERE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to jet, clean and survey sewer pipes between manholes, Kent County Council has made an Order to temporarily prohibit through traffic on Westbere Lane, Westbere, near Canterbury.

Phased closures are planned from Monday 9 October 2017 for up to 5 days between 07:00 hours and 17:00 hours each day.

Westbere Lane will be closed in 2 phases, initially between the junctions with Staines Hill and Church Lane, then between Church Lane and Bushy Hill Road.

The alternative route is via A28 Staines Hill, Island Road and Bushy Hill Road.

The timing of the phases will depend on progress with the works.

DARTFORD AREA

SCHOOL LANE, BEAN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of a new connection to the water main, Kent County Council intends to make an Order prohibiting through traffic on School Lane, Bean, on or after 23 October 2017 for up to 3 days or until the works have been completed.

The road will be closed outside "The Royal Oak".

The alternative route is via B255 Southfleet Road, B262 Betsham Road, Park Corner Road and vice versa.

DARTFORD & SEVENOAKS AREAS

MALTHOUSE ROAD, STANSTEAD & BEAN ROAD, GREENHITHE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of carriageway microsurfacing, Kent County Council has made an Order prohibiting through traffic on Malthouse Road, Stanstead and Bean Road, Greenhithe, as per the schedule below or until the works have been completed.

SCHEDULE

Malthouse Road, Stanstead – Pease Hill to Stansted Hill 15 October 2017 for up to 3 days
The alternative route is via Pease Hill, Haven Hill, Fairseat Lane, Stansted Hill and vice versa

Bean Road, Greenhithe – Mounts Road to the access road to McDonalds

18 October 2017 for up to 3 days

The alternative route is via St Clements Way, Mounts Road and vice versa

DOVER AREA

SAUNDERS LANE, ASH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new gas supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Saunders Lane, Ash, near Sandwich.

A closure is planned from Monday 23 October 2017, with estimated completion by 27 October 2017.

Saunders Lane will be closed in the vicinity of Saunders House, near the junction with Sandwich Road.

Access to the remainder of Saunders Lane continues from New Street up to where the road is actually closed, but there will be no through access during these works.

The alternative route is via Sandwich Road and New Street

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

THE STREET, WORTH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to construct a new manhole and new sewer connections, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of The Street, Worth, near Deal.

A closure is planned from Monday 23 October 2017 for an estimated period of up to 5 days.

The Street will be closed in the vicinity of the new development opposite Chilton Villa.

The alternative route is via A258 Deal Road and Jubilee Road.

Access to the remainder of The Street continues from either direction up to where the road is actually closed, but there will be no through access during these works.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

VARIOUS ROADS, SANDWICH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to install dropped kerbs, Kent County Council has made an Order to temporarily

prohibit through traffic on certain roads in Sandwich.

The roads affected, planned dates of closure and alternative routes are as shown below.

KNIGHTRIDER STREET, SANDWICH – closed at the junction with The Quay

Closure from 9 October 2017 for up to 2 days

The alternative routes are

Southbound via The Quay, High Street and Upper Strand Street

Northbound via Upper Strand Street, High Street, The Chain, Galliard Street, New Street, Cattle Market, Harnet Street, Delf Street, the Strand, High Street and The Quay

SCHOOL ROAD, SANDWICH – closed outside main entrance to the school

Closure from 23 October 2017 for up to 2 days

The alternative route is via Church Street St Mary's, Strand Street and Paradise Row

CHURCH STREET (ST MARY'S), SANDWICH – closed outside St Marys Church

Closure from 26 October 2017 for up to 2 days

The alternative routes are

Northbound via Delf Street, Harnet Street and Strand Street,

Southbound via Strand Street, High Street, The Chain, Galliard Street, New Street, Cattle Market, Harnet Street and Delf Street

Closures are between 07:00 hours and approximately 16:00 hours each day.

MAIDSTONE AREA

BIMBURY LANE, STOCKBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of the installation of a BT cabinet, Kent County Council has made an Order prohibiting through traffic on Bimbury Lane, Stockbury, on or after 9 October 2017 for up to 10 working days or until the works have been completed.

The road will be closed from Aerodrome Approach to outside number 1.

The alternative route is via South Street Road, Chalky Road, Steps Hill Road, A249 Sittingbourne Road, Aerodrome Approach and vice versa.

CRUMP'S LANE, ULCOMBE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of the installation of a joint box and ducting, Kent County Council has made an Order prohibiting through traffic on Crump's Lane, Ulcombe, on or after 11 October 2017 for up to 3 days or until the works have been completed.

The road will be closed at the junction with Boughton Park.

The alternative route is via Headcorn Road, Pye Corner, Eastwood Road, Lenham Road and vice versa.

KINGSLEY ROAD, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of a new connection to the water main, Kent County Council intends to make an Order prohibiting through traffic on Kingsley Road, Maidstone, on or after 23 October 2017 for up to 5 working days or until the works have been completed.

The road will be closed outside number 124.

The alternative route is via Waterloo Street, Hastings Road, Mote Road and vice versa.

LENHAM FORSTAL ROAD, LENHAM HEATH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of low voltage cable installation, Kent County Council intends to make an Order prohibiting through traffic on Lenham Forstal Road, Lenham Heath, on or after 23 October 2017 for up to 11 working days or until the works have been completed.

The road will be closed outside 1 to 6 Rose Cottages.

The alternative route is via Lenham Forstal Road, Bull Hill, Lenham Heath Road and vice versa.

PETT ROAD, STOCKBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of a new electric supply, Kent County Council has made an Order prohibiting through traffic on Pett Road, Stockbury, on or after 9 October 2017 for up to 3 days or until the works have been completed.

The road will be closed outside Magie Hall.

The alternative route is via Church Lane, Kennel Barn Road, Deans Bottom and vice versa.

WINDMILL HILL, ULCOMBE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of works on an overhead BT structure, Kent County Council has made an Order prohibiting through traffic on Windmill Hill, Ulcombe, on or after 15 October 2017 for up to 1 day or until the works have been completed.
