

# Highways

## Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

The road will be closed from Knowle Hill Lane to "Weald View Farm".

The alternative route is via Pye Corner, The Street, Ulcombe Hill, Lenham Road and vice versa.

### SEVENOAKS AREA

#### BEECHENLEA LANE, SWANLEY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of UK Power Network works, Kent County Council intends to make an Order prohibiting through traffic on Beechenlea Lane, Swanley, on or after 23 October 2017 for up to 5 days or until the works have been completed.

The road will be closed at the junction with Swanley Village Road.

The alternative route is via B2173 London Road/High Street, B258 Swanley Lane, Highland Hill, Swanley Village Road and vice versa.

#### BRITTAINS LANE, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of gas mains replacement works, Kent County Council intends to make an Order prohibiting through traffic on Brittains Lane, Sevenoaks, on or after 23 October 2017 for up to 10 weeks or until the works have been completed.

The road will be closed between Beaconsfield and Oak Lane.

The alternative route is via Oak Lane, A225 High Street, A224 London Road/Tubs Hill/London Road and vice versa.

#### GILL'S ROAD AND WILSON LANE, SOUTH DARENTH & LONGFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of the replacement of BT telegraph poles and cabling works, Kent County Council has made an Order prohibiting through traffic on Gill's Road and Wilson Lane, South Darenth & Longfield, on or after 10 October 2017 for up to 9 working days or until the works have been completed.

### SCHEDULE

Gill's Road – B260 Green Street Green Road to Wilson Lane

The alternative route is via B260 Green Street Green Road, St Margaret's Road, Gill's Road and vice versa

Wilson Lane – whole length

The alternative route is via Rabbits Road, Pinden, Canada Farm Road, B260 Green Street Green Road, St Margaret's Road, Gill's Road and vice versa

#### HITCHEN HATCH LANE, SEVENOAKS (PROHIBITION OF SOUTHBOUND TRAFFIC) TEMPORARY ORDER 2017

Because a new gas service is to be installed, Kent County Council intends to make an Order prohibiting southbound traffic on Hitchen Hatch Lane, Sevenoaks, on or after 23 October 2017 for up to 5 working days or until the works have been completed.

The alternative route is via Mount Harry Road, A225 Dartford Road, B2020 The Vine/St Botolph's Road and A224 London Road.

#### ROWHILL ROAD, HEXTABLE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of footway patching, Kent County Council intends to make an Order prohibiting through traffic on Rowhill Road, Hextable, on or after 23 October 2017 for up to 4 days or until the works have been completed.

The road will be closed between B258 Top Dartford Road and Puddledock Lane.

The alternative route is via B258 Top Dartford Road, Puddledock Lane and vice versa.

#### WATERCROFT ROAD, HALSTEAD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of the installation of signs and vegetation cut back, Kent County Council has made an Order

prohibiting through traffic on Watercroft Road, Halstead, on or after 9 October 2017 for up to 3 days or until the works have been completed.

The road will be closed between Cadlocks Hill and Old London Road.

The alternative route is via London Road, Old London Road, Shoreham Lane, Station Road and vice versa.

### SHEPWAY AREA

#### RADNOR CLIFF, FOLKESTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new water connection, Kent County Council has made an Order to temporarily prohibit through traffic on part of Radnor Cliff, Folkestone.

Daytime closures are planned from Monday 9 October 2017 for up to 5 days, between 09:00 hours and 16:00 hours each day.

Radnor Cliff will be closed in the vicinity of number 21, just east of the junction with Radnor Cliff Crescent.

There is no alternative route as the road is a cul-de-sac.

Access for residents and for the car park at Lower Sandgate Road affected will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

There will be no access for vehicles over 6' 6" wide at any time during these works, and this width restriction needs to remain in force outside the working hours.

Access to the section of Radnor Cliff west of the junction with Radnor Cliff Crescent is unaffected.

#### REDOUBT WAY, DYMCHURCH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to replace an electricity pole, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Redoubt Way, Dymchurch.

A closure is planned for Tuesday 24 October 2017 for up to 1 day.

Redoubt Way will be closed in the vicinity of number 24, near the junction with Beach Road.

The alternative route is via Uden Road, Beverly Gardens and Beach Road.

Access to the remainder of Redoubt Way continues from either direction up to where the road is actually closed.

### SWALE AREA

#### DAVINGTON HILL, FAVERSHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow drainage improvement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Davington Hill, Faversham.

Daytime closures are planned from Monday 23 October 2017 for up to 5 days, between 08:00 hours and 17:00 hours each day.

Davington Hill will be closed between the junctions with Dark Hill and Brent Hill, with access from either direction up to where the road is closed, but no through access.

The alternative route is via Dark Hill, Busing Wood Road, Western Link Oare Road and Priory Row.

#### WEST STREET, QUEENBOROUGH (PROHIBITION OF WAITING) TEMPORARY ORDER 2017

To allow the safe use of a mobile crane for maintenance works at Queenborough Creek Barrier (Flood Defences), Kent County Council has made an Order to temporarily prohibit parking on part of West Street, Queenborough, Isle of Sheppey.

All waiting, loading and parking will be prohibited on both sides of West Street, from the junction with High Street southwards for up to 40 metres, to the extent clearly indicated by No Waiting signs and cones placed on site.

Restrictions will apply on days that the crane is due to be in use, and will apply between 09:00 hours and approximately 17:00 hours each day.

Planned dates are as follows: - Monday 9 October, Friday 13 October, Monday 16 October, Wednesday 18 October, Wednesday 1 November and Friday 3 November 2017.

This programme is subject to weather and other factors which may potentially cause changes at short notice; every effort will be made to keep as close as possible to the planned dates, and any changes will be publicised.

This Order suspends any existing parking entitlements and restrictions that currently apply to West Street.

### TONBRIDGE & MALLING AREA

#### BULLEN LANE, EAST PECKHAM (TEMPORARY 30MPH SPEED LIMIT) TEMPORARY ORDER 2017

For the safety of the public and workforce during works on a gas main, Kent County Council intends to make an Order for a temporary mandatory speed limit of 30 miles per hour to be imposed on Bullen Lane from Bush Road to "The Long Arm", on or after 25 October 2017 for up to 7 days or until the works have been completed.

#### KEMSING ROAD, WROTHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of a new connection to the water main, Kent County Council intends to make an Order prohibiting through traffic on Kemsing Road, Wrotham, on or after 23 October 2017 for up to 5 days or until the works have been completed.

The road will be closed outside "Yaldham Manor Farm".

The alternative route is via Pilgrims Way, Old Terry's Lodge Road, Exedown Road and vice versa.

#### PRIORY ROAD, TONBRIDGE (PROHIBITION OF DRIVING & PROHIBITION OF PEDESTRIANS) TEMPORARY ORDER 2017

Because of wheel timber renewal works, Kent County Council has made an Order prohibiting pedestrian and vehicular traffic on Priory Road, Tonbridge, on or after 14 October 2017 from 00.30hrs to 04.00hrs on 16 October 2017 or until the works have been completed.

The road will be closed 10 metres either side of the railway bridge.

The alternative route for vehicles is via B2260 Quarry Hill Road, A2014 Pembury Road, Goldsmid Road and for pedestrians is via B2260 Railway Approach, Vale Road, Goldsmid Road and vice versa.

#### WINDMILL HILL, PLATT (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of a new connection to the water main, Kent County Council has made an Order prohibiting through traffic on Windmill Hill, Platt, on or after 9 October 2017 for up to 3 days or until the works have been completed.

The road will be closed outside "Valley Cottages".

The alternative route is via Comp Lane, Long Mill Lane, A25 Maidstone Road and vice versa.

### TUNBRIDGE WELLS AREA

#### A26 LONDON ROAD & A264 CHURCH ROAD, TUNBRIDGE WELLS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of carriageway resurfacing, Kent County Council intends to make an Order prohibiting through traffic on A26 London Road and A264 Church Road, Tunbridge Wells, on or after 24 October 2017 for up to 2 nights between 20.00hrs and 05.00hrs or until the works have been completed.

### SCHEDULE

A26 London Road – A264 Mount Ephraim to Vale Road  
The alternative route is via A264 Mount Ephraim, A264 Bishops Down, Major Yorks Road, A26 London Road and vice versa

A264 Church Road – A264 Mount Ephraim to Mount Pleasant Road

The alternative route is via Mount Pleasant Road, Vale Road, A26 London Road, Major Yorks Road, A264 Bishops Down, A264 Mount Ephraim and vice versa

#### FOXHOLE LANE, HAWKHURST (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of works on an overhead BT structure, Kent County Council intends to make an Order prohibiting through traffic on Foxhole Lane, Hawkhurst, on or after 26 October 2017 for up to 1 day or until the works have been completed.

The road will be closed between A268 Rye Road and Foxhole Lane/Field Green.

The alternative route is via A268 Rye Road, Field Green/Foxhole Lane and vice versa.

#### GORE LANE, GOUDHURST (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of works on an overhead BT structure, Kent County Council intends to make an Order prohibiting through traffic on Gore Lane, Goudhurst, on or after 23 October 2017 for up to 3 days or until the works have been completed.

The road will be closed between B2079 North Road and B2079 Summer Hill.

The alternative route is via B2079 North Road/Summer Hill and vice versa.

#### HINKSDEN ROAD, BENENDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of works on an overhead BT structure, Kent County Council intends to make an Order prohibiting through traffic on Hinksden Road, Benenden, on or after 23 October 2017 for up to 3 days or until the works have been completed.

The road will be closed between Foxhole Lane and Coldharbour Road.

The alternative route is via Coldharbour Road, Mill Street, Sponden Lane, Foxhole Lane/Field Green and vice versa.

#### LOWER GREEN ROAD, RUSTHALL (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because a new gas service is to be installed, Kent County Council intends to make an Order prohibiting through traffic on Lower Green Road, Rusthall, on or after 23 October 2017 for up to 6 working days or until the works have been completed.

The road will be closed between Ashley Park and Ashley Gardens.

The alternative route is via between Ashley Park, Ashley Gardens and vice versa.

#### TONBRIDGE ROAD, PEMBURY (PROHIBITION OF NORTHBOUND TRAFFIC) TEMPORARY ORDER 2017

Because of the construction of a cycleway and footway, Kent County Council has made an Order prohibiting northbound traffic on Tonbridge Road, Pembury, on or after 9 October 2017 for up to 4 weeks or until the works have been completed.

Northbound traffic will be prohibited between A21 Pembury By-Pass and Tunbridge Wells Hospital.

The alternative route is via A21 Pembury By-Pass, A228 Pembury Road and vice versa.
