## Highways

# Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

#### ASHFORD AREA

CHILHAM LEVEL CROSSING, MYSTOLE LANE, CHILHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER OCTOBER 2017

To allow level crossing maintenance and other associated works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on Chilham Level Crossing, Mystole Lane, Chilham, near Ashford.

A closure is planned for Monday 30 October 2017, from 23:30 hours through until approximately 05:00 hours.

Mystole Lane will be closed in the vicinity of Chilham Level Crossing. Mystole Lane is shown as Pickelden Lane on some maps.

The alternative route is via A28 Canterbury Road, Shalmsford Street, Chartham Downs Road, Mystole Lane and Pickelden Lane.

Access remains from either direction up to where the road is closed, but there will be no through access.

## WOTTON ROAD, ASHFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to replace failed concrete slabs in the carriageway, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Wotton Road, Ashford.

Overnight closures are planned from Monday 30 October 2017 for up to 4 nights, from 20:00 hours through until approximately 05:00 hours each night.

Wotton Road will be closed in the vicinity of the junction with Austin Road.

There is no alternative route as the road is a cul-de-sac. Businesses have been made aware of the closures.

The closures are in conjunction with temporary 3-way traffic lights during the days, to ensure the slabs are fully protected from traffic whilst curing.

Access to businesses will be maintained for daytime trading.

#### **CANTERBURY AREA**

## CHITTY LANE, CHISLET (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to construct a new wet well, Kent County Council has made an Order to temporarily prohibit through traffic on part of Chitty Lane, Chislet, near Canterbury.

A closure is planned from Monday 16 October 2017 with estimated completion by 1 December 2017.

Chitty Lane will be closed along its southern section, eastwards to the vicinity of Lower Chitty Farm.

The alternative route for any through traffic is via Church Lane and the remainder of Chitty Lane.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

## KAKE STREET, WALTHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out to provide a new water connection, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Kake Street, Waltham, near Canterbury.

A closure is planned from Monday 30 October 2017 for an estimated period of up to 5 days.

Kake Street will be closed in the general vicinity of Well House, to the south of Sarness Farm.

Access to the remainder of Kake Street continues from either direction up to where the road is actually closed, but there will be no through access during these works.

The alternative route for through traffic is via Anvil Green Road, Richdore Road and Woods Hill back to Kake Street

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

## PUCKLE LANE, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

To allow works to be carried out works to provide a new electricity supply, Kent County Council has made an Order to temporarily prohibit through traffic on part of Puckle Lane, Canterbury.

A closure is planned from Monday 16 October 2017 for an estimated period of up to 5 days.

Puckle Lane, Canterbury will be closed in the vicinity of number 11, with no through access between the junctions with Raymond Avenue and Old Dover Road.

The alternative route is via Prospect Place, Nunnery Fields and Old Dover Road

The One-way Traffic Order in respect of Puckle Lane will be suspended from the junction with Prospect Place to where the road is closed and from the junction with Old Dover Road to where the road is closed, to allow limited access / exit.

Due to the nature of the works, it will not be possible to re-open the road outside the working hours.

#### DARTFORD AREA

B262 STATION ROAD, SOUTHFLEET (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of water mains replacement, Kent County

Council intends to make an Order prohibiting through traffic on B262 Station Road, Southfleet, on or after 30 October 2017 for up to 35 working days or until the works have been completed.

The road will be closed between Park Corner Road and Foxhounds Lane.

The alternative route is via A2 Watling Street, B255 Bean Lane/High Street/Southfleet Road, B262 Betsham Road and vice yersa

## HEDGE PLACE ROAD, GREENHITHE (PROHIBITION OF PARKING) TEMPORARY ORDER 2017

Because of a new development, Kent County Council intends to make an Order for a single yellow line to be installed to prevent parking between 09.00hrs and 15.00hrs Monday to Friday on Hedge Place Road, Greenhithe, on the southbound side of the carriageway from outside number 90 to adjacent to number 11 Barnfield Close.

This Order takes effect on or after 30 October 2017 for a period of up to 18 months or until the works have been completed.
