It is about to submit this Order to The Secretary of State for Communities and Local Government for confirmation, and if confirmed, the Order will authorise Canterbury City Council to purchase compulsorily the land described below for the purpose of facilitating the carrying out of development, redevelopment or improvement of that land which will contribute to the promotion and/or improvement of the economic, social and environmental well-being of the area by enabling mixed-use development including leisure, retail, carrying out of development, redevelopment or improvement of
