

# Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

## WEST STREET, WEST MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of a new gas service is to be installed, Kent County Council has made an Order prohibiting through traffic on West Street, West Malling, on or after 2 December 2017 for up to 2 days and on 4 December 2017 between 19.00hrs and 05.00hrs or until the works have been completed.

The road will be closed outside number 2.

The alternative route is via Offham Road, Teston Road, St Leonard's Street, High Street and vice versa.

## (VARIOUS ROADS, THE BOROUGH OF TONBRIDGE AND MALLING)

### (20MPH, 30MPH, 40MPH, 50MPH SPEED LIMITS AND DEREGULATED ROADS) AMENDMENT No.26 ORDER 2017

NOTICE is hereby given that the Kent County Council has made the above named Order under Sections 1, 2, 4 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which would be to-

From 1 April 2013 Kent County Council became responsible for a number of Public Health functions. One of those was the health improvement for the population of Kent. In recent years the demand for the implementation of 20mph schemes had been increasing in response to both local and national campaigns, therefore Kent County Council are implementing the 20mph Public Health Scheme in the following roads in Eccles, Aylesford.

1. **ALMA ROAD:** From its junction with Bull Lane for its entire length
2. **BELGRAVE STREET:** From its junction with Cork Street to its north-eastern extremity
3. **CORK STREET:** From its junction with Bull Lane to its junction with Belgrave Street
4. **GREENFIELD CLOSE:** From its junction with Bull Lane for its entire length
5. **HAWKES ROAD:** From its junction with Bull Lane for its entire length
6. **HAYMAN WALK:** From its junction with Jenner Way for its entire length
7. **JENNER WAY:** From its junction with Bull Lane to its junction with St Mark's Court
8. **MACKENDERS LANE:** From its junction with Bull Lane for its entire length including its south-eastern arm
9. **MACKENDERS CLOSE:** From its junction with Mackenders Lane for its entire length
10. **SKINNERS CLOSE:** From its junction with Mackenders Lane for its entire length
11. **SPRINGETT CLOSE:** From its junction with Jenner Way for its entire length
12. **ST MARKS COURT:** From its junction with Jenner Way for its entire length
13. **ST PETERS PLACE:** From its junction with St Marks Close for its entire length
14. **STEVENS ROAD:** From its junction with Jenner Way

for its entire length

15. **VARNES STREET:** From its junction with Cork Street to its junction with Alma Road

16. **VICTORIA STREET:** From its junction with Cork Street to its junction with Alma Road

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement in relation to the Orders.

## TUNBRIDGE WELLS AREA

### ROMFORD ROAD, PEMBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because it is necessary to jet and clean the sewer, Kent County Council has made an Order prohibiting through traffic on Romford Road, Pembury, on or after 27 November 2017 for up to 5 working days or until the works have been completed.

The road will be closed outside Priory Farm.

The alternative route is via Woodside Road, Henwood Green Road and vice versa.

### VAUXHALL LANE, SOUTHBOROUGH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2017

Because of the disconnection and removal of street lights, Kent County Council has made an Order prohibiting through traffic on Vauxhall Lane, Southborough, on or after 27 November 2017 for up to 3 days or until the works have been completed.

The road will be closed from A26 London to outside "Three Oaks".

The alternative route is via A26 London Road/Quarry Hill Road, A2014 Pembury Road, Vauxhall Lane (A21 link road) and vice versa.
