**(AMENDMENT No. 1) ORDER 2017**

**THE KENT COUNTY COUNCIL (VARIOUS ROADS, DOVER DISTRICT) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (No. 55) ORDER 2017**

Notice is hereby given that KENT COUNTY COUNCIL intend to make the above Orders under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2) and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

If made the effect of the first named Order will be to amend the Kent County Council (The District of Dover) (Prohibition of Waiting by Large Goods Vehicles) Order 2017 will to prohibit heavy goods vehicles (over 7.5 tonnes) from waiting at any time (a) for the whole length of both sides of Barwick Road, Dover; (b) on the unrestricted lengths along the northern side of Coombe Valley Road, Dover, between Primrose Road and Edgar Road; and (c) on the northern side of Folkestone Road, Dover, between the east boundary of 182 and opposite 277 Folkestone Road.

The effect of the second named Order will be to further amend Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 by prohibiting waiting between 9.30am and 6.30pm on all days on the northern side of the northern arm (adjacent Deal Castle) of Marine Road, Deal where waiting is currently permitted.

Full details are contained in the draft Orders which, together with the relevant drawings, a copy of any orders which will be amended by the proposed Orders, and a statement of the Council's reasons for proposing to make the Orders may be examined at The Council Offices, White Cliffs Business Park, Dover.

An information pack containing information relating to the proposals will be available for inspection at the District Council Area Offices located at Deal Library, Broad Street, Deal; and Dover Gateway, Castle Street, Dover during normal office hours.
