- Y17/1405/SH** - Land 225 Metres Northwest May Tree The Minnis Rhodes Minnis Kent - Erection of agricultural building to provide general purpose storage and attached lean-to bay for livestock.
- Y17/1527/SH** - 12 Cliffe House Radnor Cliff Folkestone Kent CT20 2TY - Replacement cladding to front elevation and alterations to fenestration to rear elevation.
- Y17/1486/SH** - 31 - 33 Sandgate High Street Sandgate Kent CT20 3AH - Increase in roof height to create second floor living accommodation.
