## Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

## **CANTERBURY AREA**

ALBION LANE, HERNE (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018** 

To allow works to be carried out to provide a new electricity supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Albion Lane, Herne, near Herne Bay.

A closure is planned for Tuesday 9 January 2018 for ar estimated period of up to 2 days.

Albion Lane will be closed to the south of the junction with Ridgeway Walk; access to the remainder of Albion Lane continues from either direction up to where the road is actually closed, but there will be no through access during these works.

The alternative route is via Ridgeway Road and Forgefields.

Due to the nature of the works, the road will need to remain closed outside the working hours.

This Order comes into force from 9 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

## COLDHARBOUR LANE, BRIDGE (PROHIBITION OF DRIVING & 10 MPH SPEED LIMIT) TEMPORARY ORDER 2018

To allow works to be carried out to lay phone ducting in the carriageway in connection with the installation of broadband, Kent County Council intends to make an Order to impose temporary traffic restrictions on Coldharbour Lane, Bridge, near Canterbury

Restrictions apply during works which are planned from Monday 8 January 2018, with estimated completion by 21 January.

Coldharbour Lane will be closed at all times from the entrance to the Business Park eastwards to the junction with Poor Start Lane.

The alternative route for through traffic is via Bonny Bush Hill, Bridge Hill, High Street Patrixbourne Road (for vehicles over 15 T via Bifrons Hill, Bekesbourne Road, Town Hill, due to weight limit on Patrixbourne Road), The Street, Station Road, School Lane, Chalkpit Hill, Adisham Road, Bramling Road and Poor Start Lane

A temporary mandatory maximum speed limit of 10 miles per hour will be imposed on sections of Coldharbour Lane, between the Bourne Park slip roads from the A2 eastwards to the entrance to the Business Park.

The 10 mph Speed Limit applies in both directions on Coldharbour Lane in phased sections of approximately 100 metres at a time, in conjunction with temporary traffic lights and a "Convoy System" to escort traffic through the roadworks.

The 10 mph speed limit applies specifically when convoy working is in place, daytimes only, and the relevant signs are displayed on site.

This Order comes into force from 8 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

## DARTFORD AREA

POWDER MILL LANE, WILMINGTON (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2018** 

Because of the installation of a new culvert, Kent County Council intends to make an Order prohibiting through traffic on Powder Mill Lane, Wilmington, on or after 8 January 2018 for up to 37 days or until the works have been completed.
