SMARDEN ROAD, HEADCORN (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018**

Because of a new water main diversion, Kent County Council intends to make an Order prohibiting through traffic on Smarden Road, Headcorn, on or after 15 January 2018 for up to 5 days or until the works have been completed.

The road will be closed between Frank's Bridge and A274

The alternative route is via A274 Biddenden Road, Shenley Road, Bell Lane, Headcorn Road and vice versa.

Because of a new electric service connection, Kent County Council intends to make an Order prohibiting through traffic on Grassy Lane, Sevenoaks, on or after 15 January 2018 for up to 5 days or until the works have been completed.

The alternative route is via Oak Lane, A225 Tonbridge Road, Solefields Road and vice versa.

The alternative route is via B2026 Main Road,

Dennettsland Road and vice versa

SHEPWAY AREA

JEFFERSTONE LANE, ST MARY'S BAY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow sewer repair works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Jefferstone Lane, St Mary's Bay, Romney Marsh.

A closure is planned from Tuesday 2 January 2018, with estimated completion by 2 March 2018.

Jefferstone Lane will be closed in the general vicinity of the level crossing, north of Nesbit Road.

Access to the remainder of Jefferstone Lane continues from either direction up to where the road is actually closed, but there will be no through access during these

The alternative route is via A259 Dymchurch Road and St Mary's Road.

Due to the nature of these works, the road will need to remain closed outside the working hours.

This Order comes into force from 2 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

MUDDLES PASSAGE, BOUVERIE ROAD WEST. FOLKESTONE (PROHIBITION OF DRIVING) TEMPORARY **ORDER 2018**

To allow works to be carried out to lay telecoms ducting in the carriageway to provide new services, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Muddles Passage, off Bouverie Road West, Folkestone.

A closure is planned from Monday 15 January 2018 for an estimated period of up to 3 days.

Muddles Passage will be closed in the vicinity from the junction with Bouverie Road West to Cherry Tree Mews. Access remains from Ingles Road direction.

The alternative route for any through traffic is via Bouverie Road West, Christchurch Road and Ingles Road. Due to the nature of these works, the road will need to remain closed outside the working hours.

This Order comes into force from 15 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

PILGRIM SPRING, FOLKESTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be safely carried out to demolish a block of flats, garages and play areas, Kent County Council has made an Order to temporarily prohibit through traffic on part of Pilgrim Spring, Folkestone

A closure is planned from Wednesday 3 January 2018

Pilgrim Spring will be closed at the far northern end at the approach road leading to the rear of numbers 30-73.

There is no alternative route as the road is a cul-de-sac. Due to the nature of these works, the road will need to

remain closed outside the working hours. Due to the nature of these works, it may not be possible to re-open the road outside the working hours.

This Order comes into force from 3 January 2018 and remains in force until the works have been completed, with a maximum duration of 18 months.

ST JOHN'S ROAD, NEW ROMNEY (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2018**

To allow works to be carried out to provide a new water connection, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of St John's Road, New Romney.

Daytime closures are planned from Monday 15 January 2018 for an estimated period of up to 5 days, between 09:00 hours and approximately 15:30 hours each day.

St John's Road will be closed in the vicinity of the junction with Lydd Road.

Access to the remainder of St John's Road continues from an eastern (West Street) direction up to where the road is actually closed.

The alternative route for any through traffic is via A259 Lydd Road and West Street.

The closure is in conjunction with temporary traffic lights

This Order comes into force from 15 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

SWAMP LEVEL CROSSING, LYDD & TILLERY LEVEL CROSSING, BROOKLAND (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018**

To allow level crossing maintenance and other associated works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on Swamp Level Crossing, Lydd and Tillery Level Crossing, Brookland, both on the Romney Marsh.

Overnight closures are planned as follows, between 23:30 hours through until approximately 05:30 hours

SWAMP ROAD, LYDD will be closed in the vicinity of Swamp Level Crossing, planned for the night of Tuesday

The alternative route is via A259 Lydd Road, B2075 Romney Road – Caldecot Lane and Dennes Lane

TILLERY LANE, BROOKLAND will be closed in the vicinity of the level crossing, planned for the night of Thursday 4

The alternative route is via A259 Rhee Wall, Tickners Lane and Barnhouse Lane

Access to the remainder of each road continues from either direction up to where the road is actually closed, but there will be no through access during these works. This Order comes into force from 2 January 2018 and

remains in force until the works have been completed, with a maximum duration of 6 months.

SWALE AREA

MANOR ROAD, MILSTEAD (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018**

To allow safe access to underground structure for phone cabling works to be carried out, Kent County Council has

made an Order to temporarily prohibit through traffic on part of Manor Road, Milstead, near Sittingbourne.

Off-peak closures are planned from Tuesday 2 January 2018 for up to 4 days, between 09:30 hours and approximately 15:30 hours each day

Manor Road will be closed in the vicinity of Milstead Manor Farm, with no through access between the junctions with Frinsted Road and Wood Lane

The alternative route is via Frinsted Road, Milstead and Torry Hill back to Manor Road.

This Order comes into force from 2 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

NORTON ROAD, NORTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to provide a new electricity supply, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Norton Road, Norton, in the Swale area.

A closure is planned from Monday 15 January 2018, with estimated completion by 19 January 2018.

Norton Road will be closed in the general vicinity of Wheelwright Cottages, with no through access between the junctions with Provender Lane and Lewson Street

The alternative route is via Provender Lane, A2 signposted.

Access to the remainder of Norton Road / Norton Lane continues from either direction up to where the road is

Due to the nature of these works, the road will need to remain closed outside the working hours.

This Order comes into force from 15 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

STONE LEVEL CROSSING, BUCKLAND, FAVERSHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow level crossing maintenance and other associated works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on Stone Level Crossing, Buckland,

A closure is planned for Sunday 21 January 2018 between 07:00 hours and 19:00 hours.

Lower Road will be closed at Stone Level Crossing, with no access between the junctions with Buckland Farm Road and Elverton Lane.

The alternative route is via Lower Road, Lower Norton Lane, A2 London Road, Four Oaks Road and Lower Road.

This Order comes into force from 21 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

WRENS ROAD & HEARTS DELIGHT ROAD, BORDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow gas mains replacement works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on sections of Wrens Road and Hearts Delight Road, Borden, near Sittingbourne.

Phased closures are planned from Tuesday 3 January 2018, with estimated completion by 5 March 2018.

Phase 1 – WRENS ROAD will be closed in sections Phase 1 – WKENS KOAD will be closed in sections between the junctions with Sutton Baron Road and Hearts Delight Road, from 3 January 2018 onwards The alternative route is via Wrens Road, Gore Road, Primrose Lane, Bredgar Road and Hearts Delight Road

Phase 2 – WRENS ROAD and HEARTS DELIGHT ROAD both closed at the same time from 15 January onwards The alternative routes are Wrens Road as above

Hearts Delight Road via Hearts Delight, Bannister Hill, Borden Lane, Homewood Avenue, Ufton Lane, Gore Court Road, Woodstock Road and Tunstall Road

Phase 3 – HEARTS DELIGHT ROAD closed in phases from

The alternative route is as shown above

The timing of the phases is approximate and may potentially be affected by weather and ground conditions. Any changes to dates will be notified to local residents and signposted on site.

Access to the remainder of Wrens Road and Hearts

Delight Road will continue from either direction up to where the road is actually closed at any time.

Access for residents affected will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for

Due to the nature of the works, the roads will need to remain closed outside the working hours.

This Order comes into force from 3 January 2018, remains in force until the works have been completed, with a maximum duration of 6 months.
