

# Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

## TONBRIDGE & MALLING AREA

### B2016 SEVEN MILE LANE, WROTHAM HEATH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of drainage works, Kent County Council intends to make an Order prohibiting through traffic on B2016 Seven Mile Lane, Wrotham Heath, on or after 20 January 2018 for up to 2 days or until the works have been completed.

The road will be closed between A20 London Road and Teston Road.

The alternative route is via A20 London Rd, A228 Ashton Way/Malling Road, A26 Tonbridge Road and vice versa.

### OLD LANE, IGHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because a new gas service is to be installed, Kent County Council has made an Order prohibiting through traffic on Old Lane, Igham, on or after 2 January 2018 for up to 5 working days or until the works have been completed.

The road will be closed outside "Midsummer Meadow".

There is no alternative route but access will be maintained for residents.

### WINDMILL HILL, PLATT (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because a new gas service is to be installed, Kent County Council intends to make an Order prohibiting through traffic on Windmill Hill, Platt, on or after 15 January 2018 for up to 7 working days or until the works have been completed.

The road will be closed outside "Old Mill House".

The alternative route is via Comp Lane, Long Mill Lane, A25 Maidstone Road and vice versa.

## TUNBRIDGE WELLS AREA

### CONGHURST LANE, HAWKHURST (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of works on an overhead BT structure, Kent County Council has made an Order prohibiting through traffic on Conghurst Lane, Hawkhurst, on or after 2 January 2018 for up to 2 days between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed between A268 Rye Road and Risden Lane.

The alternative route is via A268 Rye Road, A229 Highgate Hill/Moor Hill, B2244 Hastings Road and vice versa.
