Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

CANTERBURY AREA

ALBION LANE, HERNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to provide a new electricity supply, Kent County Council has made an Order to temporarily prohibit through traffic on part of Albion Lane, Herne, near Herne Bay.

A closure is planned for Tuesday 9 January 2018 for an estimated period of up to 2 days.

Albion Lane will be closed to the south of the junction with Ridgeway Walk; access to the remainder of Albion Lane continues from either direction up to where the road is actually closed, but there will be no through access during these works.

The alternative route is via Ridgeway Road and Forgefields.

Due to the nature of the works, the road will need to remain closed outside the working hours.

This Order comes into force from 9 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

COLDHARBOUR LANE BRIDGE (PROHIBITION OF DRIVING & 10 MPH SPEED LIMIT) TEMPORARY ORDER 2018

To allow works to be carried out to lay phone ducting in the carriageway in connection with the installation of broadband, Kent County Council has made an Order to impose temporary traffic restrictions on Coldharbour Lane, Bridge, near Canterbury

Restrictions apply during works which are planned from Monday 8 January 2018, with estimated completion by 21 January.

Coldharbour I ane will be closed at all times from the ntrance to the Business Park eastwards to the junction with Poor Start Lane.

The alternative route for through traffic is via Bonny Bush Hill, Bridge Hill, High Street Patrixbourne Road (for vehicles over 15 T via Bifrons Hill, Bekesbourne Road, Town Hill due to weight limit on Patrixbourne Road), The Street, Station Road, School Lane, Chalkpit Hill, Adisham Road, Bramling Road and Poor Start Lane

A temporary mandatory maximum speed limit of 10 miles per hour will be imposed on sections of Coldharbour Lane, between the Bourne Park slip roads from the A2 eastwards to the entrance to the Business Park.

The 10 mph Speed Limit applies in both directions on Coldharbour Lane in phased sections of approximately 100 metres at a time, in conjunction with temporary traffic lights and a "Convoy System" to escort traffic through the roadworks.

The 10 mph speed limit applies specifically when convoy working is in place, daytimes only, and the relevant signs are displayed on site.

This Order comes into force from 8 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

HAMILTON ROAD, WHITSTABLE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to lay telecoms ducting in the carriageway, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Hamilton Road, Whitstable.

A closure is planned for Sunday 28 January 2018 for up to 1 day, from 09:00 hours onwards.

Hamilton Road will be closed between the junction with Cromwell Road and Stream Walk. Access to the remainder of Hamilton Road continues

from Regent Street direction up to where the road is actually closed.

The alternative route is via Cromwell Road and Regent Street.

This Order comes into force from 28 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

SWEECHGATE, BROAD OAK (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to provide a new foul sewer connection, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Sweechgate, Broad Oak, near Canterbury.

A closure is planned from Saturday 27 January 2018 for an estimated period of up to 6 days.

Sweechgate will be closed between the junctions with Shalloak Road and Barnet's Lane, with access from either direction up to where the road is closed, but no through access.

The alternative route is via Shalloak Road, Vauxhall Road, A28 Sturry Road, Mill Road, Sturry Hill and Herne Bay Road to Sweechgate.

Due to the nature of the works, the road will need to remain closed outside the working hours.

This Order comes into force from 27 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

MILITARY ROAD, CANTERBURY (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2018**

To allow gas mains replacement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Military Road, Canterbury. N.B. this does not affect the main A28 Military Road

A closure is planned from Monday 22 January 2018, with estimated completion by 9 February 2018. Military Road will be closed from the entrance to the

Royal Mail Sorting Office to where the road becomes Hudson Road.

The alternative route is via Military Road, A28 Tourtel Road, Sturry Road and Brymore Road.

The Order which prevents traffic turning left from A28 Sturry Road into Brymore Road on weekday mornings between 07:30 hours and 09:30 hours will be suspended, whilst the road is closed.

Access to the remainder of Military Road continues from either direction up to where the road is actually closed, and access to Regency Place is maintained from Hudson Road.

Due to the nature of the works, the road will need to remain closed outside the working hours.

This Order comes into force from 22 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

DARTFORD AREA

POWDER MILL ANE, WILMINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of the installation of a new culvert, Kent County Council has made an Order prohibiting through traffic on Powder Mill Lane, Wilmington, on or after 8 January 2018 for up to 37 days or until the works have been completed. The road will be closed at the bridge over the River Darent.

SHELLBANK LANE, DARENTH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of the replacement of telegraph poles, Kent County Council intends to make an Order prohibiting through traffic on Shellbank Lane, Darenth, on or after 22 January 2018 for up to 5 days or until the works have been completed.

The road will be closed between Beacon House and Manor Farm.

The alternative route is via B255 High Street/Southfleet Road, B262 Sandbanks Hill, B260 Green Street Green Road and vice versa.

DOVER AREA

A256 WHITFIELD HILL & HONEYWOOD ROAD, WHITFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To facilitate Highways England works to resurface A2 Whitfield Roundabout, Kent County Council intends to make an Order to temporarily prohibit through traffic on A256 Whitfield Hill and Honeywood Road, Whitfield. Overnight closures of Whitfield Roundabout are planned

from Tuesday 23 January 2018 for up to 5 weekday nights, from 20:00 hours through until approximately 06:00 hours each night. A256 WHITFIELD HILL will be closed for its entire length,

with managed access from London Road direction for any residents and their visitors.

HONEYWOOD ROAD will be closed from the roundabout junction with Menzies Road northwards to Whitfield Roundabout.

KEARSNEY AVENUE will be closed at the junction with Whitfield Hill; access remains from London Road direction.

These closures are in conjunction with Highways England closures of the A2 Trunk road, with fully signposted diversion routes

This Order comes into force from 23 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

A256 CRABBLE HILL, DOVER (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018**

To allow a detailed bridge inspection to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of A256 Crabble Hill, Dover.

An overnight closure is for Monday 22 January 2018 from 22:00 hours continuing through until approximately 06:00 hours.

A256 Crabble Hill will be closed in the vicinity of the railway bridge, with local access from either direction up to where the road is closed, but no through access. The alternative routes are via

Westbound via A256 Buckland Avenue, Barton Road, Frith Road, Charlton Green, Maison Dieu Road, Woolcomber Street, A20 Townwall Street, Jubilee Way, Duke of York Roundabout, A2 Trunk Road, A256 Whitfield Hill and London Road.

Coastbound (towards Dover) via A256 London Road. Whitfield Hill, A2 Trunk Road, Duke of York Roundabout, Jubilee Way, A20 Townwall Street, A256 York Street, Priory Road, High Street and London Road

This Order comes into force from 22 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

BARNSOLE ROAD, STAPLE (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018**

To allow works to be carried out to update overhead electricity cabling, Kent County Council has made an Order to temporarily prohibit through traffic on part of Barnsole Road, Staple, in the Dover area.

Daytime closures are planned from Monday 8 January 2018, for up to 5 days, between 08:00 hours and 16:00 hours each day.

Barnsole Road will be closed between the junctions with Lower Road and Chalkpit Lane.

The alternative routes are via Lower Road, School Lane and Mill Road or via Fleming Road, Drainless Road, Hammill Road, Sandwich Road and Chalkpit Lane

Access to the remainder of Barnsole Road continues from a southern / eastern direction up to where the road is actually closed.

Access for residents affected will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

This Order comes into force from 8 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

CROOKS COURT LANE & GRAVEL LANE, WEST HOUGHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow cabling works to be carried out in connection with the installation of broadband, Kent County Council intends to make an Order to temporarily prohibit through traffic on Crooks Court Lane and Gravel Lane, West Hougham, near Dover.

Phased closures are planned from Monday 22 January 2018, with estimated completion by 9 February 2018. Crooks Court Lane / Gravel Lane will be closed in sections, with access from either direction up to where the road is actually closed at any time, but no through access.

The alternative route is via Satmar Lane, Winehouse Lane, B2011 New Dover Road and Hougham Court Lane. Due to the nature of the works, the road will need to remain closed outside the working hours.

Access for residents affected will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

MARSHBOROUGH ROAD MARSHBOROUGH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to lay telecoms ducting in the carriageway, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Marshborough Road, Marshborough, near Sandwich.
