

Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

Station Road and vice versa.

EGLANTINE LANE, FARNINGHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of works on an overhead BT structure, Kent County Council has made an Order prohibiting through traffic on Eglantine Lane, Farningham, on or after 10 January 2018 for up to 1 day or until the works have been completed.

The road will be closed from outside "Charlton Vale" heading south for approximately 225 metres.

The alternative route is via A20 London Road, A225 Dartford Road, Franks Lane and vice versa.

HAMPKINS HILL ROAD, CHIDDINGSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of works on an overhead BT structure, Kent County Council intends to make an Order prohibiting through traffic on Hampkins Hill Road, Chiddingstone, on or after 22 January 2018 for up to 1 day or until the works have been completed.

The road will be closed between B2027 Tonbridge Road and Chiddingstone Road.

The alternative route is via The Village, Mill Lane, B2027 Chequers Hill/Tonbridge Road and vice versa.

PINDEN, HORTON KIRBY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of a new water connection, Kent County Council intends to make an Order prohibiting through traffic on Pinden, Horton Kirby, on or after 22 January 2018 for up to 5 days or until the works have been completed.

The road will be closed outside Harrow Place.

The alternative route is via Canada Farm Road, B260 Green Street Green Road, Fawkham Road, Valley Road, Scudders Hill, Canada Farm Road and vice versa.

RYE LANE, OTFORD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of gas mains replacement works, Kent County Council has made an Order prohibiting through traffic on Rye Lane, Otford, as per the schedule below or until the works have been completed.

SCHEDULE

8 January 2018 for up to 47 working days – between Willow Park and Byeways
The alternative route is via Station Road, A224 London Road, Pilgrims Way West and vice versa.

22 January 2018 for up to 20 working days – between Pilgrims Way West and Willow Park
The alternative route is via Willow Park, Telston Lane, Pilgrims Way West and vice versa.

WATERY LANE, KEMSING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of works on an overhead BT structure, Kent County Council intends to make an Order prohibiting through traffic on Watery Lane, Kemsing, on or after 22 January 2018 for up to 5 days or until the works have been completed.

The road will be closed between Honey Pot Lane and "Stonepitts".

The alternative route is via Broad Oak Lane, A25 Maidstone Road/High Street, School Lane, Childsbridge Lane, West End, St Ediths Road, Noahs Ark, Honey Pot Lane and vice versa.

Road Traffic Regulation Act 1984

NOTICE IS HEREBY GIVEN that the Kent County Council (hereinafter referred to as "the Council"), acting as the local traffic authority, has made an Order under Section 1, 2, 35, 36, 45, 46, 47, 49, 53, 124 of and Part IV of Schedule 9 to the Road Traffic Regulations Act of 1984, the effect of which is to amend the existing Appendix 25 – Sevenoaks in "The Kent County Council (Various Roads in the District of Sevenoaks) (Prohibition and Restriction of Waiting and Loading and Unloading and On-Street Parking Places) (Consolidation) Order 2013" and subsequent amendment Orders thereto, through the introduction and/or amendment of waiting restrictions in the following lengths of road:

In the Town of Sevenoaks

Ashgrove Road
North side, from a point 12m west of the western kerb line of Burntwood Road to a point 12m east of the eastern kerb line of Burntwood Road

New double yellow line prohibiting waiting at any time

Burntwood Road
Both sides, from the south western kerb line of Grassy Lane, south westwards for 12m

New double yellow line prohibiting waiting at any time

Burntwood Road
Both sides, from a point 5m north east of the north eastern kerb line of Burntwood Grove, south westwards then southwards for 85m

New double yellow line prohibiting waiting at any time

Burntwood Road
Both sides, from the northern kerb line of Ashgrove Road, northwards for 12m

New double yellow line prohibiting waiting at any time

Burntwood Road
Northwest side, from a point 12m south west of the south western kerb line of Grassy Lane to a point 5m north east of the north eastern kerb line of Burntwood Grove

New single yellow line prohibiting waiting between 2pm and 3pm from Monday to Friday

Burntwood Road
Southeast side, from a point 12m south west of the south western kerb line of Grassy Lane to a point 5m north east of the north eastern kerb line of Burntwood Grove

New single yellow line prohibiting waiting between 11am and 12 noon from Monday to Friday

Burntwood Road
West side, from a point 85m south west then south of the north eastern kerb line of Burntwood Grove to a point 12m north of the northern kerb line of Ashgrove Road

New single yellow line prohibiting waiting between 2pm and 3pm from Monday to Friday

Burntwood Road
East side, from a point 85m south west then south of the north eastern kerb line of Burntwood Grove to a point 12m north of the northern kerb line of Ashgrove Road

New single yellow line prohibiting waiting between 11am and 12 noon from Monday to Friday

Grassy Lane
West side, from a point 7m north of the boundary of Woodstock/Scots Pines, Grassy Lane northwards for 29m

New double yellow line prohibiting waiting at any time

Grassy Lane
East side, from a point 20m south of the southern kerb line of Oak Lane, southwards to a point 68m north of the boundary of 19/21 Grassy Lane

New single yellow line prohibiting waiting between 11am and 12 noon from Monday to Friday

Grassy Lane
East side, from the boundary of 19/21 Grassy Lane, northwards for 68m

New double yellow line prohibiting waiting at any time

Grassy Lane
East side, from the boundary of 19/21 Grassy Lane, southwards to a point 17m north of the north western kerb line of Burntwood Road

New single yellow line prohibiting waiting between 11am and 12 noon from Monday to Friday

Grassy Lane
Both sides, from a point 17m north of the north western kerb line of Burntwood Road to a point 3m south east of the south eastern kerb line of Burntwood Road

New double yellow line prohibiting waiting at any time

Grassy Lane
North east side, from a point 5m north west of the north western kerb line of Wellmeade Drive to a point 3m south east of the south eastern kerb line of Wellmeade Drive

New double yellow line prohibiting waiting at any time

Grassy Lane
West side, from a point 7m north of the boundary of Woodstock/Scots Pines, Grassy Lane southwards to a point 17m north of the north western kerb line of Burntwood Road

New single yellow line prohibiting waiting between 2pm and 3pm from Monday to Friday

Oak Lane
South and south east sides, from its junction with High Street (A225), westwards and south westwards to a point 127m south west of the western kerb line of Oak Hill Road

New double yellow line prohibiting waiting at any time (in currently unrestricted sections)

Oak Lane
North and north west sides, from a point 77m east of the eastern kerb line of Oak Hill Road westwards and south westwards to a point 127m south west of the western kerb line of Oak Hill Road

New double yellow line prohibiting waiting at any time (in currently unrestricted sections)

Turners Gardens
North west side, from a point in line with the north eastern flank wall of 17 Turners Gardens south westwards to a point in line with the boundary of 8/9 Turners Gardens

New single yellow line prohibiting waiting between 11am and 12 noon from Monday to Friday

Turners Gardens
South east side, from a point in line with the north

eastern flank wall of 17 Turners Gardens south westwards to a point 5m north east of a point in line with the south western flank wall of 4 Turners Gardens

New single yellow line prohibiting waiting between 2pm and 3pm from Monday to Friday

Turners Gardens
South east side, from a point 5m north east of a point in line with the south western flank wall of 4 Turners Gardens to a point 20m north east of a point in line with the south western flank wall of 6 Turners Gardens

New double yellow line prohibiting waiting at any time

Turners Gardens
South east side, from a point 20m north east of a point in line with the south western flank wall of 6 Turners Gardens south westwards to a point in line with the boundary of 8/9 Turners Gardens

New single yellow line prohibiting waiting between 2pm and 3pm from Monday to Friday

Turners Gardens
Both sides, from a point in line with the boundary of 8/9 Turners Gardens south westwards for 22m

New double yellow line prohibiting waiting at any time

Wellmeade Drive
Both sides, from the north eastern kerb line of Grassy Lane north eastwards for 15m

New double yellow line prohibiting waiting at any time

Wellmeade Drive
North west and west sides, from a point 15m north east of the north eastern kerb line of Grassy Lane north eastwards then northwards to the boundary of 4/5 Wellmeade Drive

New single yellow line prohibiting waiting between 11am and 12 noon from Monday to Friday

Wellmeade Drive
South east and east sides, from a point 15m north east of the north eastern kerb line of Grassy Lane north eastwards then northwards to the boundary of 4/5 Wellmeade Drive

New single yellow line prohibiting waiting between 2pm and 3pm from Monday to Friday

Any person may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement in relation to the Order.

SHEPWAY AREA

HIGH STREET, HYTHE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to lay telecoms ducting in the carriageway, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of High Street, Hythe.

A closure is planned from Tuesday 23 January 2018 at 19:00 hours continuing through until Thursday 25 January 2018 at approximately 04:00 hours.

High Street will be closed in the general vicinity of the Post Office, with no through access between the junctions with Bank Street and Malthouse Hill

The alternative route for all through traffic is via East Street Roundabout, A259 Prospect Road, Rampart Road, Red Lion Square and High Street

The One-way Traffic Order in respect of High Street, Hythe will be suspended between the junctions with Bank Street and Malthouse Hill, to allow limited essential access / exit from either direction up to where the road is closed.

The One-way Traffic Order in respect of Bank Street, Hythe will be suspended between the junctions with Prospect Road / Chapel Street and High Street to allow access / exit.

This Order comes into force from 23 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

ROLFE LANE, NEW ROMNEY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to provide a new electricity supplies, together with telecoms ducting

works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Rolfe Lane, New Romney.

A closure is planned from Monday 8 January 2018, with estimated completion by 19 January 2018.

Rolfe Lane will be closed at its northern end, between the junction with Cockreed Lane and the property 'Crantock'. Access to the remainder of Rolfe Lane continues from a southern direction up to where the road is actually closed, but there will be no through access during these works.

The alternative route for through traffic is via Cockreed Lane, Ashford Road, Fairfield Road and Walner Lane back to Rolfe Lane.

Due to the nature of the works, the road will need to remain closed outside the working hours.

Access for residents affected will be maintained whenever it is safe to do so, but there are likely to be delays and certain times when this is not possible for safety reasons.

This Order comes into force from 8 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

SWALE AREA

A2 WEST STREET, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow carriageway repair works to be carried out, Kent County Council has made an Order to temporarily prohibit westbound traffic on part of A2 West Street, Sittingbourne.

An overnight closure is planned for Monday 8 January 2018, from 19:00 hours through until approximately 07:00 hours

A2 West Street will be closed to westbound (London-bound) traffic to the west of junction with Ufton Lane.

The alternative route is via A2 St Michael's Road, B2006 Crown Quay Lane, Eurolink Way, Mill Way, King Street, St Paul's Street, Staplehurst Road, Bobbing Interchange, Sheppey Way, Key Street Roundabout, A2 Key Street and London Road to West Street.

Eastbound traffic is unaffected, access to Ufton Lane will be maintained and westbound access to the remainder of A2 continues up to where the road is actually closed, but through traffic will need to follow the above diversion.

This Order comes into force from 8 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

BUTLER'S HILL, DARGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to update overhead electricity cabling, Kent County Council has made an Order to temporarily prohibit through traffic on part of Butler's Hill, Dargate, near Faversham.

Daytime closures are planned from Monday 8 January 2018, for up to 5 days, between 08:00 hours and 16:00 hours each day.

Butler's Hill will be closed at its northern end, in the vicinity of the junction with Plumpudding Lane / Dargate Road.

Access to the remainder of Butler's Hill continues from a western (Hernhill) direction up to where the road is actually closed.

The alternative route is via Butlers Hill, Church Hill, Staplestreet Road, Dawes Road, Courtenay Road and Dargate Road.

NOUDS LANE, TEYNHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow safe access to the overhead cable network for phone cabling works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Nouds Lane, Teynham, near Sittingbourne

Off-peak closures are planned from Monday 22 January 2018 for up to 3 days, between 09:30 hours and approximately 15:30 hours each day

Nouds Lane will be closed from the junction with A2 London Road to the vicinity of Nouds House.

The alternative route is via A2 London Road, Norton Lane, Norton Road and Tickham Lane back to Nouds Lane.

This Order comes into force from 22 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

THE STREET, OARE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow gas mains replacement works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of The Street, Oare, near Faversham.

A closure is planned from Monday 8 January 2018, with estimated completion by 15 January 2018.
