CHURCH ROAD, TOVIL (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2018**

GOUDHURST ROAD & PLAIN ROAD, MARDEN (30MPH SPEED LIMIT & PROHIBITION OF DRIVING) TEMPORARY

Because of the installation of a new drinking water main, Kent County Council intends to make an Order prohibiting through traffic on Plain Road, Marden from outside 8 Brooklyn Villas to 2 Orchard Side. A temporary mandatory speed limit of 30 miles per hour will be imposed on Goudhurst Road between the junctions with Plain Road and Sheephurst Road on or after 10 February 2018 for up to 23 working days or until the works have been completed.
