Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

Rhode Common Road will then be closed from the junction with Jezzards Lane southwards to the entrance to Winterbourne Quarry, with access remaining from a southern direction.

Due to the nature of the works, it will not be possible to re-open roads outside the working hours.

This Order comes into force from 29 January 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

Access for any residents affected will be maintained whenever it is safe to do so, but subject to delays and certain times when this is not possible for safety reasons.

RECTORY ROAD, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow gas mains replacement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Rectory Road, Sittingbourne.

Phased closures are planned from Monday 12 February 2018, with estimated completion by 19 February 2018. Rectory Road will be closed in sections from the junction with A2 Canterbury Road to a point south of the southern junction with Commonwealth Close.

The alternative route is via A2 Canterbury Road, Swanstree Avenue and St John's Avenue back to Rectory Road.

Access to the remainder of Rectory Road continues from a southern direction up to where the road is actually closed.

Access to Commonwealth Close will be maintained from one or other direction as signposted on site.

The One-way Traffic Order in respect of Commonwealth Close will be suspended, to allow essential access / exit Due to the nature of the works, it will not be possible to

re-open the road outside the working hours. This Order comes into force from 12 February 2018 and

remains in force until the works have been completed, with a maximum duration of 6 months.

WARDWELL LANE, LOWER HALSTOW (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow safe access to underground structures to enable phone cabling works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Wardwell Lane, Lower Halstow, near Sittingbourne.

An off-peak closure is planned for Friday 2 February 2018, between 09:30 hours and approximately 15:30 hours

Wardwell Lane will be closed in the vicinity of 'The Cobbs', with local access from either direction up to where the road is actually closed, but no through access.

The alternative route is via School Lane, Boxted Lane, Breach Lane, The Street and Vicarage Lane back to Wardwell Lane.

This Order comes into force from 2 February 2018 and remains in force until the works have been completed, with a maximum duration of 6 months.

TONBRIDGE & MALLING AREA

CROUCH LANE, PLATT (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of remedial works on a sunken patch, Kent County Council has made an Order prohibiting through traffic on Crouch Lane, Platt, on or after 29 January 2018 for up to 3 days or until the works have been completed.

The road will be closed outside "Cedar House".

The alternative route is via A25 Maidstone Road, Long Mill Lane and vice versa.

KEEPERS COTTAGE LANE & WORRALL DRIVE, WOULDHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

For the safety of the public during the construction of St Peters Village development, Kent County Council intends to make an Order prohibiting through traffic on Keepers Cottage Lane and Worrall Drive, Wouldham, on or after 12 February 2018 for up to 18 months or until the works have been completed.

LONG MILL LANE, CROUCH, BOROUGH GREEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of works on an overhead BT structure, Kent County Council intends to make an Order prohibiting through traffic on Long Mill Lane, Crouch, Borough Green, on or after 12 February 2018 for up to 3 days or until the works have been completed.

The road will be closed from outside "Yew Tree Barn" to "Grimbles".

The alternative route is via Plough Lane, Basted Lane, Quarry Hill Road, A25 Maidstone Road, Crouch Lane and vice versa.

SWAN STREET, WEST MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of a new connection to the water main, Kent County Council has made an Order prohibiting through traffic on Swan Street, West Malling, on or after 4 February 2018 for up to 1 day and a further closure after 19.00hrs on 5 February 2018 or until the works have been completed.

The road will be closed outside The Swan Hotel.

The alternative route is via High Street, Town Hill, A20 London Road, Winterfield Lane, Lucks Hill and vice versa.

TESTON ROAD, OFFHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of BT ducting works, Kent County Council intends to make an Order prohibiting through traffic on Teston Road, Offham, on or after 12 February 2018 for up to 5 days or until the works have been completed.

The road will be closed outside "Little Westover".

The alternative route is via King Hill, A228 Malling Road, A26 Tonbridge Road, B2016 Seven Mile Lane and vice versa.

VIGO HILL, TROTTISCLIFFE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because it is necessary to jet and clean the sewer, Kent County Council has made an Order prohibiting through traffic on Vigo Hill, Trottiscliffe, on or after 30 January 2018 for up to 14 working days between 09.00hrs and 15.00hrs or until the works have been completed.

The road will be closed between A227 Gravesend Road and Pilgrims House.

The alternative route is via A227 Gravesend Road, A20 London Road, Trottiscliffe Road, Addington Lane, Taylors Lane and vice versa.

VARIOUS ROADS, TONBRIDGE & MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

Because of carriageway works, Kent County Council intends to make an Order prohibiting through traffic on Various Roads, Tonbridge & Malling, on or after 10 February 2018 for up to 18 months or until the works have been completed.
