

# Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

## THANET AREA

### A299 MONKTON ROUNDABOUT, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow essential carriageway resurfacing works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic in the vicinity of A299 Monkton Roundabout, Monkton, near Ramsgate.

Overnight closures are planned from Friday 16 March 2018 for up to 6 weekday nights.

Closures are between 19:00 hours through until approximately 05:00 hours each night.

MONKTON ROUNDABOUT and all approaches will be closed, with the following effects

A299 THANET WAY will be closed between Monkton Roundabout and St Nicholas Roundabout

A299 CANTERBURY ROAD WEST will be closed between Monkton Roundabout and Minster Roundabout

The alternative route for all through traffic is via A28 Canterbury Road, B2052 George V Road, Hartsdown Road, Tivoli Road, Beatrice Road (B2052 College Road in opposite direction due to one-way system), A254 Ramsgate Road, Margate Road, A256 Haine Road, New Haine Road, Haine Road, A256 / A299 Hengist Way and Canterbury Road West

Thanet-bound traffic on A253 Ramsgate Road / Canterbury Road will be diverted via Sarre and A28 Canterbury Road (Birchington) to join the above route.

SEAMARK ROAD will be closed at Monkton Roundabout and can continue to be accessed from its northern junction with A28 Canterbury Road.

WILLETTS HILL will be closed at Monkton Roundabout and can continue to be accessed from a southern junction (Monkton Street)

### CANNONBURY ROAD, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow works to be carried out to install a new drop-kerb crossing, Kent County Council has made an Order to temporarily prohibit through traffic on part of Cannonbury Road, Ramsgate.

Daytime closures are planned from Monday 26 February 2018 for up to 3 days.

Cannonbury Road will be closed in the vicinity of number 4, with no through access.

The alternative route is via Grange Road, West Cliff Road and Cannonbury Road.

### DANE ROAD, MARGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow carriageway resurfacing works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Dane Road, Margate.

An overnight closure is planned for Thursday 1 March 2018, from 19:00 hours through until approximately 05:00 hours.

Dane Road will be closed between the junctions with Wilderness Hill and Addiscombe Road.

The alternative route is via Park Road, Park Crescent Road and Addiscombe Road

Approach Road will be closed at the junction with Dane Road, with through traffic diverted via Northdown Park Road.

Limited access for residents affected will be maintained whenever it is safe to do so, but subject to delays and times when this is not possible for safety reasons.

### EGBERT ROAD, WESTGATE ON SEA (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow gas mains replacement works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Egbert Road, Westgate on Sea, near Margate.

A closure is planned from Monday 12 March 2018 with

estimated completion by 16 March 2018.

Egbert Road will be closed in the vicinity of the junction with Sea Road, with access to the remainder of Egbert Road continuing from a southern direction up to where the road is actually closed.

The alternative route for any through traffic is via Sea Road, St Mildred's Road and Ethelred Road.

Due to the nature of the works, the road will need to remain closed outside the working hours.

### POORHOLE LANE, BROADSTAIRS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2018

To allow excavations to be carried out to repair a sewer in the carriageway, Kent County Council has made an Order to temporarily prohibit through traffic on part of Poorhole Lane, Broadstairs.

A closure is planned from Monday 26 February 2018, with estimated completion by 9 March 2018.

Poorhole Lane will be closed in the vicinity of 'Lok'nstore', with access to the remainder of Poorhole Lane continuing from either direction up to where the road is actually closed.

The alternative route for through traffic is via A254 Margate Road and A256 Westwood Road.

Due to the nature of these works, the road will need to remain closed outside the working hours.

### (WESTWOOD ROAD, THE DISTRICT OF THANET) (PROHIBITION OF RIGHT HAND TURN MOVEMENTS) AMENDMENT NO.1 ORDER 2017

Notice is hereby given that KENT COUNTY COUNCIL has made the above named Order under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

The effect of the proposed named Order will be to ban 'Right Hand Turn Movements' for all vehicles (including pedal cycles) in the following lengths of road in Broadstairs:-

1. WESTWOOD ROAD INTO HOPE WAY  
From Westwood Road (westbound) into Hope Way, Broadstairs
2. HOPE WAY INTO WESTWOOD ROAD  
From Hope Way (southbound) into Westwood Road (westbound), Broadstairs.

The Order shall come into operation on Wednesday 28th day of February 2018.

Full details and a statement of the Council's reasons for making the Order, a map indicating the location and the effect and a copy of any other Orders which will be amended by the Order may be examined on Mondays to Friday at The Kent County Council, Sessions House, Maidstone, ME14 1XQ and at The Kent County Council, Kent Highway & Transportation, Ashford Highway Depot, Henwood Industrial Estate, Unit 4 Javelin Way, Ashford, Kent TN24 8AD during normal office hours or viewed online at [www.kent.gov.uk/highwaysconsultations](http://www.kent.gov.uk/highwaysconsultations)

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement in relation to the Orders.
