Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

ASHFORD AREA

FOSTEN LANE, BIDDENDEN. (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2022**

Because of overhead cabling works, Kent County Council intends to make an Order prohibiting through traffic on Fosten Lane, Biddenden, on or after 19th May 2022 for up to 1 day, between 09:30 hours and 15:30 hours or until the works have been completed.

Because of new utility connection works, Kent County Council has made an Order prohibiting through traffic on part of Leacon Lane, Charing, on or after 3rd May 2022 for up to 4 days or until the works have been completed.

The road will be closed in the vicinity of The Rainbow Chinese Takeaway, to the extent indicated by signs and barriers on site.

The alternative route is via Leacon Lane, Pluckley Road, Station Road, A20 Ashford Road, Ashford Road and vice versa.

MAYTHAM ROAD, ROLVENDEN. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of utility overhead cabling works, Kent County Council has made an Order prohibiting through traffic on part of Maytham Road, Rolvenden, on or after 3rd May 2022 for up to 1 day, between 09:30 hours and 15:30 hours or until the works have been completed. The road will be closed between Ingles and Palstre Court Road, to the extent indicated by signs and barriers on site.

The alternative route is via Maytham Road, A28 High Street/Tenterden Road/Rolvenden Hill/Rolvenden Road. B2082 Smallhythe Road/Peening Quarter Road, Palstre Court Road and vice versa.

ORCHARD DRIVE, WYE. (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2022**

Because of highway improvement works, Kent County Council has made an Order prohibiting through traffic on part of Orchard Drive, Wye, on or after 2nd May 2022 for up to 15 days or until the works have been completed.

The road will be closed between numbers 16 to 19. There will be no alternative route but access will be maintained when it is safe to do so.

SHOTTENDEN LANE, MOLASH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of utility repair and maintenance works, Kent County Council intends to make an Order prohibiting through traffic on part of Shottenden Lane, Molash, on or after 16th May 2022 for up to 1 day, between 08:00 hours and 18:00 hours or until the works have been completed.

The road will be closed in the vicinity of number 2 The Oast, to the extent indicated by signs and barriers on site.

The alternative route is via Shottenden Lane, A252 Maidstone Road, Soleshill Road, Shottenden Road and vice versa.

SPARROW HATCH LANE, BETHERSDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Network Rail works, Kent County Council intends to make an Order prohibiting through traffic on part of Sparrow Hatch Lane, Bethersden, on or after 22nd May 2022 for up to 1 day, between 07:30 hours and 18:30 hours or until the works have been completed.

The road will be closed 20 metres either side of the rail bridge, to the extent indicated by signs and barriers on site.

Because of pole replacement and overhead cabling works, Kent County Council has made an Order prohibiting through traffic on part of Station Road. Smeeth, on or after 8th May 2022 for up to 1 day, between 09:00 hours and 15:00 hours or until the works have been completed.

The road will be closed in the vicinity of Evegate Manor, to the extent indicated by signs and barriers on site. The alternative route is via Station Road, A20 Hythe

Road, The Street, Bower Road and vice versa.

THE STREET & CANTERBURY ROAD, BRABOURNE (20MPH SPEED LIMIT) TEMPORARY ORDER 2022

Because of utility repair and maintenance works. Kent County Council has made an Order prohibiting through traffic on part of Wye Road, Hastingleigh, on or after 3rd May 2022 for up to 4 days or until the works have been completed.

The road will be closed in the vicinity of Coldharbour Farm, to the extent indicated by signs and barriers on site.

ASHFORD & MAIDSTONE AREAS

SHEARWAY LANE, HEADCORN & SMARDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow pole renewal works to be carried out. Kent County Council has made an Order prohibiting through traffic on part of Shearway Lane, Headcorn, on or after 5th May 2022 for up to 1 day between the hours of 09:30 and 15:30, or until the works have been completed.

To allow utility works to be carried out Kent County Council has made an Order prohibiting through traffic on part of Drill Lane, Ickham, on or after 3rd May 2022 for up to 7 days or until the works have been completed.

The road will be closed in the general vicinity of Treasury Oast, to the extent indicated by signs and barriers on site.

The alternative route is via Drill Lane, Wickham Road, Wickham Lane, and vice versa.
