

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

The road will be closed between the junctions with Lughorse Lane and Vicarage Road, to the extent indicated by signs and barriers on site.

The alternative route for any through traffic is via Vicarage Road, West Street, Hunton Hill, Upper Hunton Hill, B2163 Heath Road, B2163 Ewell Lane, B2010 Smiths Hill, B2010 Yalding Hill and vice versa.

ALBION PLACE, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow defect works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Albion Place, Maidstone, on or after 2nd May 2022 for up to 2 days or until the works have been completed.

The road will be closed at the junction with Brooks Place, to the extent indicated by signs and barriers on site.

The one-way Order on Albion place will be temporarily suspended, to allow for diverted traffic.

The alternative route is via King Street, A249 Andrew Broughton Way.

BEDFORD PLACE, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow clearance works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Bedford Place, Maidstone, on or after 20th May 2022 for up to 5 days between the hours of 08:00 and 18:00, or until the works have been completed.

The road will be closed from the junction with A20 Terrace Road, to the extent indicated by signs and barriers on site.

There is no alternative route for this closure, due to the road being a dead-end.

BERWYN GROVE, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow pole replacement works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Berwyn Grove, Maidstone, on or after 6th May 2022 for up to 1 day between the hours of 08:00 and 18:00, or until the works have been completed.

The road will be closed from outside number 3 to outside number 5, to the extent indicated by signs and barriers on site.

The alternative route is via Norrington Road, Pear Tree Lane, Paynes Lane, Berwyn Grove and vice versa.

EASTWOOD ROAD, ULCOMBE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow drainage cleansing works to be carried out Kent County Council has made an Order prohibiting through traffic on part of Eastwood Road, Ulcombe, on or after 6th May 2022 for up to 1 day between the hours of 09:30 and 15:30, or until the works have been completed.

The road will be closed from outside Wesley Cottage to outside Eastwood Farmhouse, to the extent indicated by signs and barriers on site.

The alternative route is via Eastwood Road, Lenham Road, Headcorn Road, Liverton Hill, Green Hill Lane, Ulcombe Hill, The Street, Pye Corner and vice versa.

EASTWOOD ROAD, ULCOMBE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow clearance works to be carried out on ducting, Kent County Council intends to make an Order prohibiting through traffic on part of Eastwood Road, Ulcombe, on or after 17th May 2022 for up to 6 days between the hours of 09:30 and 15:00, or until the works have been completed.

The road will be closed between the junctions with Knowle Road and Lenham Road, to the extent indicated by signs and barriers on site.

The alternative route is via Lenham Road, Headcorn Road, Liverton Hill, Ulcombe Hill, The Street and vice versa.

GRAVELLY BOTTOM ROAD, KINGSWOOD (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow drainage maintenance works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Gravelly Bottom Road, Kingswood, on or after 5th May 2022 for up to 1 day or until the works have been completed.

The road will be closed from the junction with Ulcombe Road to outside Uplands, to the extent indicated by signs and barriers on site.

The alternative route is via Gravelly Bottom Road, Chartway Street, Pitt Road and vice versa.

HOLLINGBOURNE HILL, HOLLINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow gully cleansing works to be carried out, Kent County Council intends to make an Order prohibiting

through traffic on part of Hollingbourne Hill, Hollingbourne, on or after 20th May 2022 for up to 1 day or until the works have been completed.

The road will be closed between the junctions with Ringlestone Road, to the extent indicated by signs and barriers on site.

The alternative route for any through traffic is via Upper Street, Eyhorne Street, Ashford Road, New Cut Road, Bearsted Road, Newnham Court Roundabout, Newnham Court Roundabout To M20 Junction 7 Roundabout, A249 Newnham Court Roundabout M20 Junction 7, M20 Junction 7 From Junction 6 Off Slip, Sittingbourne Road, Detling Hill, Stockbury Valley, A249 M2 J5 Roundabout, Stockbury Roundabout, Oad Street, Pond Farm Road, Sutton Baron Road, Wrens Road, Hearts Delight Road, Bredgar Road, Primrose Lane, The Street, Swanton Street, Court Danes Shaw, Court Dane Shaws and vice versa.

KINGS STREET, MAIDSTONE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow investigation works to be carried out Kent County Council has made an Order prohibiting through traffic on part of King Street, Maidstone, on or after 4th May 2022 for up to 1 night between the hours of 22:30 and 05:00, or until the works have been completed.

The road will be closed between the junctions with Queen Anne Road and Albion Place, to the extent indicated by signs and barriers on site.

The alternative route for traffic travelling west is via Albion Place, Brooks Place, Queen Anne Road, Marsham Street, Church Street.

The alternative route for traffic travelling east is via Queen Anne Road, Brooks Place, Albion Place.

LENHAM ROAD & CHEGWORTH ROAD, ULCOMBE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow ducting works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Lenham Road, Ulcombe, on or after 9th May 2022 for up to 2 days between the hours of 09:30 and 15:00, or until the works have been completed.

Lenham Road will be closed at the junction with Chegworth Road, to the extent indicated by signs and barriers on site.

Chegworth Road will be closed at the junction with Lenham Road, to the extent indicated by signs and barriers on site.

The alternative route is via Ulcombe Hill, The Street, Headcorn Road, Crumps Lane, Ulcombe Road, Lenham Road, Liverton Hill and vice versa.

THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF MAIDSTONE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) VARIATION NO.41 ORDER 2021

ROAD TRAFFIC REGULATION ACT 1984

Notice is hereby given that KENT COUNTY COUNCIL intends to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following order:-

The effect of the Order will be to introduce new or to extend or amend existing waiting restrictions in the following lengths of road (in this part of the notice DYL means waiting to be prohibited at all times by double yellow lines) and remove some residents parking bays due to the installation of a new zebra crossing.

Roads in the Borough of Maidstone

BUCKLAND HILL – DYL – (1) On both sides from its junction with Buckland Road remove the 29 metres of double yellow lines in a westerly direction. **(2)** On north side 29 metres from its junction with Buckland Hill in a westerly direction remove 24 metres of residents parking bays. **(3)** On the south side 29 metres from its junction with Buckland Hill remove 7 metres of residents parking bays in a westerly direction. **(4)** On the north side install DYL from a point 35 metres west of its junction with Buckland Hill for a distance of 16 metres in a westerly direction. **(5)** Install a Zebra Crossing from its junction with Buckland Hill in place of the current restrictions.

The Order was made on 28 April 2022 and its provisions will come into effect on 2 May 2022.

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation

Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement to the Orders.

SEVENOAKS AREA

B269 POOTINGS ROAD, FOUR ELMS. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of carriageway patching, Kent County Council has made an Order to temporarily prohibit through traffic on part of B269 Pootings Road, Four Elms, on or after 3rd May 2022 for up to 1 day or until the works have been completed.

The road will be closed between B2027 Four Elms Road and Bywood.

The alternative route is via B2042 Ide Hill Road, B2027 Four Elms Road, B2026 Station Road/Main Road, B269 Spout Lane and vice versa.

BEECHENLEA LANE, SWANLEY. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of drainage works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Beechenlea Lane, Swanley, on or after 6th May 2022 for up to 4 days or until the works have been completed.

The road will be closed either side of the railway.

The alternative route is via Beechenlea Lane, B2173 London Road/High Street, B258 Swanley Lane, Highlands Hill, Swanley Village Road and vice versa.

BIRCHIN CROSS ROAD, KNATTS VALLEY. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Birchin Cross Road, Knatts Valley, on or after 17th May 2022 for up to 2 days between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed between Row Dow Lane and Shorehill Lane.

The alternative route is via Birchin Cross Road, Clarkes Green Lane, Cotmans Ash Lane, Pilgrims Way, Row Dow and vice versa.

CHAFFORD LANE, FORDCOMBE. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Southern Water works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Chafford Lane, Fordcombe, on or after 5th May 2022 for up to 1 night between 19.00hrs and 05.00hrs or until the works have been completed.

The road will be closed outside 1 Chafford Cottages.

The alternative route is via B2188 Spring Hill, Sandfield Road, Walters Green Road, Chafford Lane and vice versa.

CHURCH ROAD, HARTLEY. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of tree cutting to keep branches away from power lines, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Church Road, Hartley, on or after 17th May 2022 for up to 1 day between 09.30hrs and 16.00hrs or until the works have been completed.

The road will be closed between Blue Firs House and Ashcroft House.

The alternative route is via Church Road, Hartley Hill, Hartley Bottom Road, North Ash Road, Ash Road and vice versa.

CRANMER ROAD & ST MARYS DRIVE, RIVERHEAD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of SGN works, Kent County Council has made an Order to temporarily prohibit through traffic on Cranmer Road and St Marys Drive, Riverhead for their entire lengths.

Cranmer Road is planned from 2nd May 2022 to 23rd May 2022 and St Marys Drive is planned from 27th June 2022 to 19th July 2022.

There are no alternative routes but access will be given as and when safe to do so.

CROCKENHILL LANE, EYNSFORD. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Crockenhill Lane, Eynsford, on or after 4th May 2022 for up to 2 days between 08.00hrs and 18.00hrs or until the works have been completed.

The road will be closed outside Corner Cottage.

The alternative route is via Crockenhill Lane, Wested Lane, B2173 London Road, A20 London Road, Dartford Road, High Street, Sparepenny Lane and vice versa.

DARENT VALLEY 10K ROAD RACE - VARIOUS ROADS, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Darent Valley 10K Marathon 8th May 2022

For the safety of the public whilst an event is being held on the highway, Kent County Council has made an Order to restrict traffic on various roads as defined below.

High Street, Eynsford Road, Eynsford Northbound from the entrance to Anthony Roper School to the junction with Gorse Hill Southbound from 150 yards North of Priory Lane up to the entrance to Anthony Roper School

High Street, Farningham

In both directions between its junction with Eynsford Road and Sparepenny Lane

Sparepenny Lane, Farningham/Eynsford

In both directions between its junction with High Street, Farningham and Riverside

Diversion: from Wested Lane/Crockenhill Lane via the A20 and Eynsford Road

Lullingstone Lane, Eynsford

In both directions between Riverside and Lullingstone Castle

The Order will be effective when required on Sunday 8th May 2022 between 08.30hrs and 10.30hrs. The restrictions/prohibitions specified in this notice will apply in the direction and only at such times as indicated by traffic signs in operation.

Nothing in the Order will apply to:

- Any Vehicle being used for Ambulance purposes, Coastguard/RNLI, Fire Brigade or Police services.
- Anything done by a Statutory Undertaker vehicle in connection with an emergency repair.
- Anything done with the permission or at the direction of Event Organisers or a Police Constable in Uniform.

FARLEY LANE, WESTERHAM. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of drainage works, Kent County Council intends to make an Order to temporarily prohibit through traffic on Farley Lane, Westerham, on or after 19th May 2022 for up to 1 day between 09.30hrs and 15.00hrs or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via B2024 Croydon Road, A25 High Street/Westerham Road and vice versa.

HALE OAK ROAD, SEVENOAKS WEALD. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Hale Oak Road, Sevenoaks Weald, on or after 20th May 2022 for up to 1 day between 08.00hrs and 18.00hrs or until the works have been completed.

The road will be closed at the junction with Halls Green.

The alternative route is via Hale Oak Road, Long Barn Road, Windmill Road, Glebe Road, Scabharbour Road, Coppings Road, Camp Hill, B2027 Tonbridge Road and vice versa.

HEVER LANE, HEVER. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on Hever Lane, Hever, on or after 2nd May 2022 for up to 1 day between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via Chippens Lane, Uckfield Lane, Cowden Pound Road, B2026 Stick Hill and vice versa.

HOLE LANE, EDENBRIDGE. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Hole Lane, Edenbridge, on or after 18th May 2022 for up to 1 day between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed outside Gaywood Bungalows.

The alternative route is via Monks Lane, Grants Lane, Staffhurst Wood Road, Dwelly Lane, Honeypot Lane, Haxted Road, Lingfield Road, B2026 Mont St Aignan Way/Station Road/Main Road and vice versa.

NEW STREET ROAD, HODSOLL STREET. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on New Street Road, Hodsoll Street, on or after 16th May 2022 for up to 1 day between
