

Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via Rectory Road, Bunkers Hill Road, New Street Road and vice versa.

OLD CHAPEL ROAD, CROCKENHILL. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of carriageway patching works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Old Chapel Road, Crockenhill, on or after 6th May 2022 for up to 1 day between 09.00hrs and 16.30hrs or until the works have been completed.

The road will be closed at the junction with B258 Cray Road.

The alternative route is via Tylers Green Road, B258 Cray Road and vice versa.

OVENDEN ROAD, SUNDRIDGE. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of drainage works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Ovenden Road, Sundridge, on or after 3rd May 2022 for up to 2 days or until the works have been completed.

The road will be closed outside Oveny Green Farm.

The alternative route is via Ovenden Road, Pilgrims Way, Brasted Hill Road, Rectory Lane, A25 High Street/ Main Road, B2211 Chevening Road and vice versa.

PIGDOWN LANE, HEVER. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Sutton and East Surrey Water works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Pigdown Lane, Hever, on or after 16th May 2022 for up to 5 days or until the works have been completed.

The road will be closed outside Pigdown Cottages.

The alternative route is via Pigdown Lane, Wilderness Lane, Dyehurst Lane, Uckfield Lane and vice versa.

PILGRIMS WAY, KEMSING. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Pilgrims Way, Kemsing, on or after 20th May 2022 for up to 4 nights between 22.00hrs and 05.00hrs or until the works have been completed.

The road will be closed outside number 78.

The alternative route is via Pilgrims Way, Row Dow, Birch Cross Road, Clarkes Green Lane, Cotmans Ash Lane and vice versa.

POWDER MILL LANE, LEIGH. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Powder Mill Lane, Leigh, on or after 16th May 2022 for up to 1 day between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed between Barnetts Mead and Little Barnetts.

The alternative route is via Powder Mill Lane, B2027 Hildenborough Road/Stocks Green Road, Leigh Road and vice versa.

SPODE LANE, COWDEN. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of drainage works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Spode Lane, Cowden, on or after 4th May 2022 for up to 4 days or until the works have been completed.

The road will be closed outside The Orangery.

The alternative route is via Spode Lane, North Street, High Street, Butterwell Hill, B2026 Hartfield Road and vice versa.

TOYS HILL, BRASTED. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Toys Hill, Brasted, on or after 18th May 2022 for up to 1 day between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed between Emmetts Lane and Beech Wood.

The alternative route is via Toys Hill, Emmetts Lane, Sundridge Road, Ide Hill Roundabout To Wheatsheaf Hill, B2042 Wheatsheaf Hill/Ide Hill Road/Green Lane, Toys Hill and vice versa.

VALLEY ROAD, FAWKHAM. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of carriageway patching, Kent County Council has made an Order to temporarily prohibit through

traffic on part of Valley Road, Fawkham, on or after 4th May 2022 for up to 2 days between 09.30hrs and 15.00hrs or until the works have been completed.

The road will be closed between Manor Lane and Fawkham Green Road.

The alternative route is via Fawkham Road, B260 Main Road, Hartley Road, Ash Road, The Street, South Ash Road, Ash Lane, A20 London Road, Fawkham Road, Brands Hatch Road, Valley Road and vice versa.

VARIOUS ROADS, SEVENOAKS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

CROWN ROAD, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow replacement works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Crown Road, Sittingbourne, on or after 16th May 2022 for up to 5 days or until the works have been completed.

The road will be closed in the general vicinity of number 45, to the extent indicated by signs and barriers on site.

The alternative route is via Crown Road, Staplehurst Road, B2006 St Pauls Street, B2005 Mill Way, Saffron Way, North Street, High Street and vice versa.
