# Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

### ASHFORD AREA

### A28 CANTERBURY ROAD, KENNINGTON. (SUSPENSION OF BUS LANE & CYCLE LANE) TEMPORARY ORDER 2022

To allow Openreach works to be carried out, Kent County Council has made an Order to temporarily suspend the bus lane and cycle lane on part of A28 Canterbury Road, Kennington, outside number 105.

The suspensions are planned between 09:30 hours and 15:30 hours from 9th May 2022, with estimated completion by 10th May 2022.

# BETHERSDEN ROAD, HOTHFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of new utility connection works, Kent County Council intends to make an Order prohibiting through traffic on part of Bethersden Road, Hothfield, on or after 26th May 2022 for up to 2 days, between 09:30 hours and 15:30 hours or until the works have been completed.

The road will be closed between Church Lane and Alder Cottages, to the extent indicated by signs and barriers on site.

The alternative route is via Bethersden Road, Bears Lane, Etchden Road, Goldwell Lane, A28 Great Chart Bypass/Chart Road/Templer Way, A20 Maidstone Road, Station Road, School Road, The Street and vice versa.

### BLACKWALL ROAD, WYE. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of overhead cabling and arboricultural works, Kent County Council has made an Order prohibiting through traffic on part of Blackwall Road, Wye, on or after 9th May 2022 for up to 5 days, between 09:30 hours and 15:30 hours or until the works have been completed.

The road will be closed between Goodcheap Lane and Blackwall Road South.

The alternative route is via Blackwall Road, A2070 Kennington Road, The Street, Hinxhill Road (Brook-Wye), Naccolt Road, Road From Naccolt Road To Blackwall Road, Blackwall Road and Vice Versa.

#### BURNTHOUSE LANE & SHENLEY ROAD, SMARDEN. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of pole testing works, Kent County Council intends to make an Order prohibiting through traffic on Burnthouse Lane and part of Shenley Road, Smarden, on or after 24th May 2022 for up to 1 day, between 09:30 hours and 15:30 hours or until the works have been completed.

Burnthouse Lane will be closed for the entire length. Shenley Road will be closed between Haylands Farm and Smarden Bell Road, to the actual extent indicated by signs and barriers on site.

The roads will not be closed at the same time.

The alternative route for Burnthouse Lane is via The Cut, Smarden Road, A274 Headcorn Road, Bell Lane, Smarden Bell Road, Burnthouse Lane and vice versa. The alternative route for Shenley Road is via Smarden Bell Road, Bell Lane, A274 Headcorn Road/Biddenden Road, Shenley Road and vice versa.

# CRIPPLE HILL, HIGH HALDEN. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of highway improvement works, Kent County Council has made an Order to temporarily prohibit through traffic on Cripple Hill, High Halden, on or after 9th May 2022 for up to 5 days, between 07:00 hours and 18:00 hours or until the works have been completed. The road will be closed for the entire length.

The alternative route is via Cripple Hill, A28 Ashford Road, Hookstead, Shawlands Lane and vice versa.

# GREEN HILL LANE, EGERTON. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of new utility connection works, Kent County Council has made an Order prohibiting through traffic on part of Green Hill Lane, Egerton, on or after 9th May 2022 for up to 2 days or until the works have been completed.

The road will be closed in the vicinity of Dering Farm, to the extent indicated by signs and barriers on site. The alternative route is via Green Hill Lane, New Road, Rock Hill Road, Mundy Bois Road and vice versa.

# SUSANS HILL, WOODCHURCH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of works to install an electrical cable, Kent County Council intends to make an Order prohibiting through traffic on part of Susans Hill, Woodchurch, on or after 23rd May 2022 for up to 3 days or until the works have been completed.

The road will be closed in the vicinity of Gower Farm Barn, to the extent indicated by signs and barriers on site.

The alternative route is via Susans Hill, Haycross Lane, Brook Street, Front Road and vice versa.

# CANTERBURY AREA

(PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow utility works to be carried out Kent County Council has made an Order prohibiting through traffic on part of Albion Lane and Ridgeway Road, Herne, on or after 9th May 2022 for up to 2 days, between 09:30 hours and 15:30 hours, or until the works have been completed.

The roads will be closed as detailed below:

Albion Lane will be closed at its junction with Ridgeway Road, to the extent indicated by signs and barriers on site.

Ridgeway Road will be closed outside of number 54, for a distance approximately 100 metres in an Easterly direction, to the extent indicated by signs and barriers on site.

The alternative route for any through traffic is via Ridgeway Road, Busheyfields Road, A291 Canterbury Road, A291 Herne Street, Albion Lane, Forgefields, and vice versa.

A local diversion will be in place for residents East of Albion Lane.

### BUTCHERY LANE, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow utility works to be carried out Kent County Council has made an Order prohibiting through traffic on part of Butchery Lane, Canterbury, on or after 10th May 2022 for up to 4 days or until the works have been completed.

The road will be closed outside number 5, The Shakespeare, to the extent indicated by signs and barriers on site.

No diversion route available, but access will be maintained when it is safe to do so.

### CHESTFIELD ROAD, CHESTFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow street light column replacement works to be carried out Kent County Council has made an Order prohibiting through traffic on part of Chestfield Road, Chestfield, on or after 11th May 2022 for up to 1 night, between 23:00 hours and 04:00 hours, or until the works have been completed.

The road will be closed between the junctions of A2990 Thanet Way and B2205 St Johns Road, to the extent indicated by signs and barriers on site.

The alternative route for any through traffic is via B2205 St John's Road, B2205 Colewood Road, B2205 Whitstable Road, B2205 Sea Street, Greenhill Bridge Road, A2990 Thanet Way, and vice versa.

### CHURCH LANE, KINGSTON (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow drainage works to be carried out Kent County Council intends to make an Order prohibiting through traffic on Church Lane, Kingston, on or after 24th May 2022 for up to 1 day or until the works have been completed.

The road will be closed for the entire length. The alternative route is via The Street, Bonny Bush Hill, Black Robin Lane, Covet Lane, and vice versa.

#### FIRS ROAD, WOMENSWOLD (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow fibre cabling works to be carried out Kent County Council intends to make an Order prohibiting through traffic on part of Firs Road, Womenswold, on or after 23rd May 2022 for up to 4 days or until the works have been completed.

The road will be closed between the junctions of Wick Lane and Forstal Road, to the extent indicated by signs and barriers on site.

The alternative route is via Woolage Green Road, Wick Lane, and vice versa.

#### GROVE FERRY HILL, UPSTREET, & GROVE FERRY ROAD, WICKHAMBREAUX (30 MPH SPEED LIMIT) TEMPORARY ORDER MAY 2022

To allow yellow hatching installation and footway works to be carried out Kent County Council intends to make an Order to temporarily impose a mandatory 30 MPH speed limit on part of Grove Ferry Hill, Upstreet, and Grove Ferry Road, Wickhambreaux, for approximately 200 metres either side of the level crossing, to the extent indicated by signs on site. The restriction will be in place on or after 23rd May 2022 for up to 3 days, or until the works have been completed.

# ST PETER'S LANE, CANTERBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow electrical connection works to be carried out Kent County Council intends to make an Order prohibiting through traffic on part of St Peter's Lane, Canterbury, on or after 23rd May 2022 for up to 7 days or until the works have been completed. The road will be closed at its junction with Westgate Hall Road, to the extent indicated by signs and barriers on site.

No diversion route available, but access will be maintained when it is safe to do so.

### THORNDEN WOOD ROAD, HERNE BAY (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022
