

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

To allow rail maintenance and other associated works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Barden Park Road, Tonbridge, on or after 8th May 2022 for up to 1 day or until the works have been completed.

The road will be closed in the general vicinity of the level crossing, to the extent indicated by signs and barriers on site.

There is no alternative route for this closure. However, residential access will be maintained on site, when it is safe to do so.

CROUCH LANE, BOROUGH GREEN (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow overhead cabling works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Crouch Lane, Borough Green, on or after 10th May 2022 for up to 1 day between the hours of 09:30 and 15:30, or until the works have been completed.

The road will be closed from the junction with Maidstone Road to outside number 1 Tillmans, to the extent indicated by signs and barriers on site.

The alternative route is via Maidstone Road, Long Mill Lane, Crouch Lane and vice versa.

CYCLE TRACK FROM CHATHAM ROAD TO KITS COTY SLIP NORTHBOUND, AYLESFORD. (PROHIBITION OF CYCLISTS) TEMPORARY ORDER MAY 2022

To allow drainage cleansing works to be carried out, Kent County Council has made an Order prohibiting through cyclists on part of Cycle Track From Chatham Road To Kits Coty Slip Northbound, Aylesford, on or after 9th May 2022 for up to 1 day or until the works have been completed.

The road will be closed adjacent to the Shell Garage to the junction with Old Chatham Road, to the extent indicated by signs and barriers on site.

There is no alternative route for this closure.

GILLETTS LANE, EAST MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow meter installation works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Gilletts Lane, East Malling, on or after 11th May 2022 for up to 3 days or until the works have been completed.

The road will be closed in the general vicinity of number 1, to the extent indicated by signs and barriers on site.

The alternative route is via Gilletts Lane, The Rocks Road, Chapel Street and vice versa.

GREENFRITH DRIVE, TONBRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow road crossing and joint bay works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Greenfrith Drive, Tonbridge, on or after 9th May 2022 for up to 5 days or until the works have been completed.

The road will be closed in the general vicinity of number 45, to the extent indicated by signs and barriers on site.

The alternative route is via Greenfrith Drive, Pine Ridge and vice versa.

HIGH STREET, WOULDHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow cleaning works to be carried out on sewer lines Kent County Council intends to make an Order prohibiting through traffic on part of High Street, Wouldham, on or after 17th May 2022 for up to 2 nights between the hours of 19:00 and 06:00, or until the works have been completed.

The road will be closed from outside number 223 to the junction with Portland Road, to the extent indicated by signs and barriers on site.

The alternative route is via Wouldham Road, Borstal Street, Priestfields, Maidstone Road, Bridgewood Roundabout, Lord Lees Roundabout, Bluebell Hill Slip South On, Blue Bell Hill, Chatham Road, Kits Coty Slip Southbound Off, Pilgrims Way, New Court Road, Village Road, Peters Bridge Roundabout, Hall Road and vice versa.

HILLTOP, TONBRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow clearance works to be carried out on ducting Kent County Council intends to make an Order prohibiting through traffic on part of Hilltop, Tonbridge, on or after 16th May 2022 for up to 3 days between the hours of 08:00 and 18:00, or until the works have been completed.

The road will be closed at the junction with Baltic Road, to the extent indicated by signs and barriers on site.

The alternative route is via Baltic Road and Hilltop.

OLD CHURCH ROAD, BURHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow ducting works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Old Church Road, Burham, on or after 11th May 2022 for up to 3 days between the hours of 08:00 or until the works have been completed.

The road will be closed in the general vicinity of Burham Court, to the extent indicated by signs and barriers on site.

The alternative route is via Burham Court Road, New Court Road, Old Church Road and vice versa.

PHOENIX DRIVE, WATERINGBURY (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow road crossing and joint bay works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Phoenix Drive, Wateringbury, on or after 10th May 2022 for up to 7 days or until the works have been completed.

The road will be closed in the general vicinity of number 84, to the extent indicated by signs and barriers on site.

There is no alternative route for this closure, due to the road being a dead-end. However, residential access will be maintained at all times, when it is safe to do so.

THONG LANE, BOROUGH GREEN (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow drainage cleansing works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Thong Lane, Borough Green, on or after 12th May 2022 for up to 1 day or until the works have been completed.

The road will be closed between the junctions with Quarry Hill Road and Basted Lane, to the extent indicated by signs and barriers on site.

The alternative route is via Thong Lane, Mill Lane, Bates Hill, The Street, Borough Green Road, Dark Hill Road, Quarry Hill Road and vice versa.

WATERINGBURY ROAD, EAST MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022

To allow drainage works to be carried out Kent County Council intends to make an Order prohibiting through traffic on part of Wateringbury Road, East Malling, on or after 16th May 2022 for up to 3 days or until the works have been completed.

The road will be closed between the junctions with Sweets Lane and Gilletts Lane, to the extent indicated by signs and barriers on site.

The alternative route is via Wateringbury Road, Red Hill, Malling Road, A26 Tonbridge Road, The Street, A228 Ashton Way, Leybourne By Pass, Oxley Shaw Lane, London Road, New Road, High Street and vice versa.

WROTHAM HILL ROAD, WROTHAM (PROHIBITION OF

DRIVING) TEMPORARY ORDER MAY 2022

To allow overhead cabling works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Wrotham Hill Road, Wrotham, on or after 12th May 2022 for up to 1 day between the hours of 09:30 and 15:30, or until the works have been completed.

The road will be closed in the general vicinity of Beech Cottage, to the extent indicated by signs and barriers on site.

The alternative route is via Wrotham Hill Road, Labour In Vain Road, A20 London Road, Gravesend Road, Fairseat Lane and vice versa.

TUNBRIDGE WELLS AREA

FARNHAM LANE, LANGTON GREEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of UKPN works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Farnham Lane, Langton Green, on or after 23rd May 2022 for up to 5 days or until the works have been completed.

The road will be closed outside Hole Farm.

The alternative route is via Farnham Lane, Nellington Road, Longmeads, Dornden Drive and vice versa.

FOREST ROAD, PADDOCK WOOD (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Forest Road, Paddock Wood, on or after 9th May 2022 for up to 11 days or until the works have been completed.

The road will be closed between numbers 21 and 37.

The alternative route is via Forest Road, Warrington Road and vice versa.

FORGE ROAD, SOUTHBOROUGH (PROHIBITION OF DRIVING & SUSPEND ONE-WAY) TEMPORARY ORDER 2022

Because of South East Water works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Forge Road, Southborough, on or after 23rd May 2022 for up to 5 days or until the works have been completed. The One-Way will be suspend to allow access.

The road will be closed at the junction with A26 London Road.

The alternative route is via Forge Road, Norton Road, Western Road, A26 London Road and vice versa.

GATE FARM ROAD, BIDBOROUGH (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of drainage works, Kent County Council intends to make an Order to temporarily prohibit through traffic on Gate Farm Road, Bidborough, on or after 25th May 2022 for up to 1 day or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via Hayesden Lane, B2176 Peshurst Road/Bidborough Ridge and vice versa.

PIPERS LANE, HAWKHURST (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on Pipers Lane, Hawkhurst, on or after 26th May 2022 for up to 2 days between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via A229 Horns Road, Talbot Road and vice versa.

RANTERS LANE, GOUDHURST (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Ranters Lane, Goudhurst, on or after 20th May 2022 for up to 6 days between 08.00hrs and 18.00hrs or until the works have been completed.

The road will be closed between Trillinghurst Farm House and Gatehouse Farm.

The alternative route is via Ranters Lane, Church Road, Kilndown Road, A21 Hastings Road/Lamberhurst By-pass, A262 Horsmonden Road/Goudhurst Road/Spelmonden Road, Station Road and vice versa.

THE KENT COUNTY COUNCIL (TUNBRIDGE WELLS BOROUGH) (PROHIBITION OF WAITING) NO.4A ORDER 2021 ROAD TRAFFIC REGULATION ACT 1984

Notice is hereby given that the KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 4 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

The effect of the made named Order will introduce additional waiting restrictions DYL means no waiting at any time in the following length of road in Horsmonden, Tunbridge Wells:-

FURNACE LANE – DYL – On both sides of the junction with Gibbet Lane to a point 8 metres north west and to a point 8 metres south east. **GIBBET LANE – DYL –** On both sides from the junction with Furnace Lane for a distance of 58 metres in a north easterly direction. **UN-NAMED ROAD – DYL –** On both sides of its junction with Gibbet Lane for a distance of 9 metres in a north westerly direction.

The Order was made on 5 May 2022 and its provisions will come into effect on 12 May 2022.

Anyone may, by application to the High Court within 6 weeks of the date of publication of this Notice, challenge the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or any instrument made thereunder, or that there has been a failure to comply with any statutory requirement to the Orders.
