Notice is hereby given that Medway Council on Thursday, 12 May 2022 made the above-mentioned Orders under sections 1, 2, 32, 35, 37, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
