

Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

THANET AREA

A28 MARINE TERRACE, MARGATE (TEMPORARY PROHIBITION OF TRAFFIC) TEMPORARY ORDER 2022 THE ROAD TRAFFIC REGULATION ACT 1984 AS AMENDED BY ROAD TRAFFIC REGULATION (SPECIAL EVENTS) ACT 1994 SECTION 16A

For the safety of the public whilst an event is being held on the highway Kent County Council has made an Order to temporarily prohibit the use of vehicles on:-

A28 Marine Terrace, Margate, between 09:30 hours and 14:30 hours from the 17th May 2022, with completion by the 20th May 2022.

The alternative route for any westbound traffic is via A254 Belgrave Road, A254 Eaton Road, A255 Grosvenor Gardens, A255 High Street, A255 St. Peters Road, B2052 College Road, B2052 Hartsdown Road, B2052 George V Avenue, and A28 Canterbury Road.

The alternative route for any eastbound traffic is via A28 Canterbury Road, B2052 George V Avenue, B2052 Hartsdown Road, Tivoli Road, Beatrice Road, B2052 College Road, A255 St Peters Road, A255 Ramsgate Road, A254 Queens Avenue, A254 Eaton Road, and A254 Belgrave Road.

A255 HERESON ROAD, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow utility works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of A255 Hereson Road, Ramsgate, on or after 19th May 2022 for up to 1 night, between 19:00 hours and 05:00 hours, or until the works have been completed.

The road will be closed outside number 117, to the extent indicated by signs and barriers on site.

The alternative route is via A255 Hereson Road, B2054 Victoria Road, Bellevue Road, Dumpton Park Drive, Montefiore Avenue, and vice versa.

A255 RAMSGATE ROAD, BROADSTAIRS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow carriageway resurfacing works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of A255 Ramsgate Road, Broadstairs, on or after 30th May 2022 for up to 2 nights, between 19:00 hours and 05:00 hours, or until the works have been completed.

The road will be closed between the junction of Park Avenue and number 193 (The Nissan Car Garage), to the extent indicated by signs and barriers on site.

The alternative route is via A255 Ramsgate Road, A255 Hereson Road, Montefiore Avenue, Dumpton Park Drive, West Cliff Avenue, Granville Road, and vice versa.

AVONDALE PLACE, MARGATE (PROHIBITION OF PEDESTRIANS) TEMPORARY ORDER 2022

To allow utility works to be carried out, Kent County Council has made an Order to temporarily prohibit pedestrian access on Avondale Place, Margate, on or after 17th May 2022 for up to 7 days or until the works have been completed.

The road will be closed for the entire length.

No diversion route available, but access will be

maintained for residents via Market Place or the car park at the rear of Market Place.

FOADS LANE, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow utility works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Foads Lane, Ramsgate, on or after 17th May 2022 for up to 7 days or until the works have been completed.

The road will be closed outside number 50, to the extent indicated by signs and barriers on site.

The alternative route is via Foads Lane, Sandwich Road, Cliffs End Road, and vice versa.

HIGH STREET, BROADSTAIRS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow new connection works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of High Street, Broadstairs, on or after 16th May 2022 for up to 5 days or until the works have been completed.

The road will be closed outside number 43, to the extent indicated by signs and barriers on site.

The alternative route is via High Street, Vicarage Street, A255 Broadstairs Road, St Peters Road, and vice versa.

PRESTON ROAD, MANSTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022 (2)

To allow ducting works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Preston Road, Manston, on or after 17th May 2022 for up to 7 days, between 08:00 hours and 18:00 hours, or until the works have been completed.

The road will be closed outside numbers 5 and 6 The Leys, to the extent indicated by signs and barriers on site.

THE LENGTH, ST NICHOLAS AT WADE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow utility works to be carried out, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of The Length, St Nicholas At Wade, on or after 30th May 2022 for up to 3 days, between 08:00 hours and 18:00 hours, or until the works have been completed.

The road will be closed between Walmer Cottage and number 8, to the extent indicated by signs and barriers on site.

The alternative route is via The Length, A28 Canterbury Road, Manor Road, and vice versa.
