THE KENT COUNTY COUNCIL (VARIOUS ROADS, DOVER DISTRICT) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (No. 97) ORDER 2022

Notice is hereby given that KENT COUNTY COUNCIL intend to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

If made the effect of the Order will be to further amend Kent County Council (Various Roads, Dover District) (Waiting Restrictions and Street Parking Places) Order 2005 as follows :

DISABLED PERSONS VEHICLE PARKING PLACES

Parking places for disabled persons vehicles will be provided in the following locations

Dover - Across the frontages of 4 and 17 Beaufoy Terrace; 206 Coombe Valley Road; 35 Devonshire Road; 22 Douglas Road; 25-47 Harold Street and 6 Kings Road. Leighton Road – on the north-eastern side between points 10 metres and 16.6 metres north-west of the junction with Beaconsfield Road; Across the frontages of 45 Lowther Road; 72 Manor Road; 40 Millais Road; 32 Monins Road; in line with 92 Old Folkestone Road; 4 Queens Avenue; 89 St David's Avenue; 169 St Radigunds Road; 44 Tower Hamlets Street and 1 Winchelsea Street.

Deal - Across the frontages of 41 Ark Lane; 55 Freeman's Way; 57 Owen Square; 2 William Pitt Avenue; and for 71 Western Road (outside number 76 Western Road).

Eastry - Across the frontage of 45 Cooks Lea. Lower Street – from a point in line with the southern building line of 'Old Place' for a distance of 6.6 metres in a northerly direction.

Elvington - Across the frontage of 22 Milner Road

Disabled persons vehicle parking places in the following locations in Dover are no longer required and will be removed – **Dover** – 32 Elms Vale Road; 32 Durban Crescent; 95 Priory Hill and 8 Vale View Road

Full details are contained in the draft Order which, together with a copy of any orders which will be amended by the proposed Order, drawings, and a statement of the Council's reasons for proposing to make the Order may be examined (by appointment) at The Council Offices, White Cliffs Business Park, Dover from Wednesday 11 May 2022 and on the Dover District Council web site www.dover.gov.uk/parking.
