Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

15:00, or until the works have been completed

Lenham Road will be closed at the junction with Chegworth Road, to the extent indicated by signs and barriers on site.

Chegworth Road will be closed at the junction with Lenham Road, to the extent indicated by signs and barriers on site.

The alternative route is via Ulcombe Hill, The Street, Headcorn Road, Crumps Lane, Ulcombe Road, Lenham Road, Liverton Hill and vice versa.

The road will be closed from the junction with Roseacre Lane to outside Tower House, to the extent indicated by signs and barriers on site.

The alternative route is via Yeoman Lane, Ware Street & Hog Hill or Yeoman Lane, Ashford Road and The Landway.

The Grove, Bearsted

The alternative route is via The Landway, A20 Ashford Road & Yeoman Lane.

Clarendon Close, Bearsted

The road will be closed for its entire length, to the extent indicated by signs and barriers on site.

There is no alternative route for this closure, due to the road being a dead-end. However, residential access will be maintained at all times, when it is safe to do so.

B2026 QUEBEC SQUARE/HOSEY HILL, WESTERHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022
