

# Highways

## Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

### **NEWNHAM LANE, EASTLING (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow gas service works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Newnham Lane, Eastling, on or after 16th May 2022 for up to 9 days or until the works have been completed.

The road will be closed in the general vicinity of Goose Meadow to the extent indicated by signs and barriers on site.

The alternative route is via Newnham Lane, Eastling Road, North Eastling Road, Faversham Road and vice versa.

### **SONORA WAY, SITTINGBOURNE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow frame and cover replacement works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Sonora Way, Sittingbourne, on or after 19th May 2022 for up to 1 night between the hours of 19:00 and 05:00, or until the works have been completed.

The road will be closed at the junction with Jade Close, to the extent indicated by signs and barriers on site.

The alternative route is via Quinton Road, Sheppey Way, Bobbing Interchange, B2006 Staplehurst Road, Sonora Way and vice versa.

### **STONE STREET, FAVERSHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER JUNE 2022**

To allow carriageway resurfacing works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Stone Street, Faversham, on or after 1st June 2022 for up to 6 nights between the hours of 19:00 and 05:00 or until the works have been completed.

The road will be closed between the junctions with South Road and Preston Street, to the extent indicated by signs and barriers on site.

The alternative route is via South Road, North Lane, Conduit Street, Quay Lane, Court Street, Crescent Road, Newton Road, Station Road, Preston Street and vice versa.

### **THROWLEY ROAD, THROWLEY (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow ducting works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Throwley Road, Throwley, on or after 18th May 2022 for up to 8 days or until the works have been completed.

The road will be closed between the junctions with Throwley Road and Bagshill Road, to the extent indicated by signs and barriers on site.

The alternative route is via Throwley Road.

### **WISES LANE, BORDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow gas main connection works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Wises Lane, Borden, on or after 30th May 2022 for up to 82 days or until the works have been completed.

The road will be closed between the junctions with A2 London Road and Dental Close, to the extent indicated by signs and barriers on site.

The alternative route is via Wises Lane, The Street, Borden Lane, A2 London Road and vice versa.

### **VARIOUS ROADS, FAVERSHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow gas main replacement works to be carried out, Kent County Council has made an Order prohibiting through traffic on various roads in Ospringe, on or after 16th May 2022, with estimated completion by 8th July 2022, or until the works have been completed.

The works will be carried out in phases, as detailed below.

#### **Brogdale Road, Ospringe**

Brogdale Road will be closed from 16th May 2022, with estimated completion by 10th June 2022.

The road will be closed from the junction with Plumford Road to north of the junction with Tettenhall Way, to the extent indicated by signs and barriers on site.

The alternative route is via London Road, Ashford Road, Porters Lane or London Road, Water Lane, Painters Forstal Road and Eastling Road.

#### **Porters Lane, Faversham**

Porters Lane will be closed from 30th May 2022, with estimated completion by 24th June 2022.

The road will be closed from the junction with Brogdale Road to outside number 4, to the extent indicated by signs and barriers on site.

The alternative route is via Porters Lane, Ashford Road, Old Badgins Road, Wilgate Green Road, Throwley Road, Stalisfield Road, Scooks Hill and Eastling Road.

#### **Whitehill, Faversham**

Whitehill will be closed from 30th May 2022, with

estimated completion by 8th July 2022.

The road will be closed between the junctions with Brogdale Road and Eastling Road, to the extent indicated by signs and barriers on site.

The alternative route is via Eastling Road, Stalisfield Road, Throwley Road, Wilgate Green Road, Old Badgins Road, Ashford Road and London Road.

#### **Stalisfield Road, Faversham**

Stalisfield Road will be closed from 16th June 2022, with estimated completion by 8th July 2022.

The road will be closed from the junction with Eastling Road to outside number 1 Brook Meadow, to the extent indicated by signs and barriers on site.

The alternative route is via Throwley Road, Wilgate Green Road, Old Badgins Road, Ashford Road, London Road and Porters Lane.

#### **Eastling Road, Faversham**

Eastling Road will be closed from 13th June 2022, with estimated completion by 8th July 2022.

The road will be closed between the junctions with Whitehill and Painters Forstal Road, to the extent indicated by signs and barriers on site.

The alternative route is via Porters Lane, Ashford Road, Old Badgins Road, Wilgate Green Road, Throwley Road, Stalisfield Road, Scooks Hill and Eastling Road.

## TONBRIDGE & MALLING AREA

### **A227 THE STREET, IGHTHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER JUNE 2022**

To allow a street party to be held in celebration of the Queen Elizabeth II's Platinum Jubilee, Kent County Council intends to make an Order prohibiting through traffic on part of The Street, Ightham, on or after 4th June 2022 for up to 1 day between the hours of 07:00 and 19:00, or until the works have been completed.

The road will be closed between the junctions with Fen Pond Road and Sevenoaks Road, to the extent indicated by signs and barriers on site.

The alternative route is via Borough Green Road, A25 Sevenoaks Road, Western Road, Maidstone Road, A20 London Road, A228 Ashton Way, Malling Road, Tonbridge Road, High Street, Hadlow Road East, Cuckoo Lane, Higham Lane, Shipbourne Road, Stumble Hill and vice versa.

### **BLACKMANS LANE, HADLOW & HARTLAKE ROAD, GOLDEN GREEN (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow gas main replacement works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Blackmans Lane, Hadlow & Hartlake Road, Golden Green, on or after 30th May 2022, with estimated completion by 21st October 2022, or until the works have been completed.

The works will be carried out in phases, as detailed below.

#### **Phase 1**

Blackmans Lane, Hadlow will be closed from 30th May 2022, with estimated completion by 7th October 2022.

The road will be closed between the junctions with A26 Tonbridge Road and Three Elm Lane, to the extent indicated by signs and barriers on site.

The alternative route for any through traffic is via A26 Tonbridge Road, Hadlow Road East, Three Elm Lane and vice versa.

#### **Phase 2**

Hartlake Road, Golden Green will be closed from 3rd October 2022, with estimated completion by 21st October 2022.

The road will be closed from the junction with Three Elm Lane to outside Goldenhill House, to the extent indicated by signs and barriers on site.

The alternative route is via B2017 Tudeley Road, A26 Woodgate Way, Vale Rise, Vale Road, Cannon Lane, Hadlow Road, Cornwallis Avenue, Hadlow Road East, Three Elm Lane and vice versa.

### **GOLDFINCH CLOSE, LARKFIELD (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow ducting works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Goldfinch Close, Larkfield on or after 31st May 2022 for up to 3 days between the hours of 08:00 and 18:00, or until the works have been completed.

The road will be closed from outside number 1 to outside number 3, to the extent indicated by signs and barriers on site.

There is no alternative route for this closure, due to the road being a dead-end. However, residential access will be maintained at all times, when it is safe to do so.

### **HIGH STREET, WOULDHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow cleaning works to be carried out on sewer lines Kent County Council has made an Order prohibiting through traffic on part of High Street, Wouldham, on or after 17th May 2022 for up to 2 nights between the

hours of 19:00 and 06:00, or until the works have been completed.

The road will be closed from outside number 223 to the junction with Portland Road, to the extent indicated by signs and barriers on site.

The alternative route is via Wouldham Road, Borstal Street, Priestfields, Maidstone Road, Bridgewood Roundabout, Lord Lees Roundabout, Bluebell Hill Slip South On, Blue Bell Hill, Chatham Road, Kits Coty Slip Southbound Off, Pilgrims Way, New Court Road, Village Road, Peters Bridge Roundabout, Hall Road and vice versa.

### **HILLTOP, TONBRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow clearance works to be carried out on ducting Kent County Council has made an Order prohibiting through traffic on part of Hilltop, Tonbridge, on or after 16th May 2022 for up to 3 days between the hours of 08:00 and 18:00, or until the works have been completed.

The road will be closed at the junction with Baltic Road, to the extent indicated by signs and barriers on site.

The alternative route is via Baltic Road and Hilltop.

### **LONG MILL LANE, PLAXTOL (PROHIBITION OF DRIVING) TEMPORARY ORDER JUNE 2022**

To allow pole testing works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Long Mill Lane, Plaxtol, on or after 3rd June 2022 for up to 1 day between the hours of 09:30 and 15:30, or until the works have been completed.

The road will be closed at the junction with Dux Lane for 250 metres east, to the extent indicated by signs and barriers on site.

The alternative route is via Dux Lane, Dux Hill, Bourne Lane, Winfield Lane, Basted Lane, Long Mill Lane and vice versa.

### **WATERINGBURY ROAD, EAST MALLING (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow drainage works to be carried out Kent County Council has made an Order prohibiting through traffic on part of Wateringbury Road, East Malling, on or after 16th May 2022 for up to 3 days or until the works have been completed.

The road will be closed between the junctions with Sweets Lane and Gillets Lane, to the extent indicated by signs and barriers on site.

The alternative route is via Wateringbury Road, Red Hill, Malling Road, A26 Tonbridge Road, The Street, A228 Ashton Way, Leybourne By Pass, Oxley Shaw Lane, London Road, New Road, High Street and vice versa.

### **YOPPS GREEN, PLAXTOL (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow water main connection works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Yopps Green, Plaxtol, on or after 30th May 2022 for up to 3 days or until the works have been completed.

The road will be closed in the general vicinity of Barnes Farm, to the extent indicated by signs and barriers on site.

The alternative route is via Tree Lane, Church Hill, Plaxtol Lane, Tonbridge Road, Bewley Lane, Sheet Hill, Yopps Green and vice versa.

## TUNBRIDGE WELLS AREA

### **CALEY ROAD & RANKINE ROAD, TUNBRIDGE WELLS. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Caley Road and Rankine Road, Tunbridge Wells, on or after 1st June 2022 for up to 3 days or until the works have been completed.

Caley Road will be closed outside number 1 and Rankine Road outside number 22.

The alternative route is via Rankine Road, Caley Road and vice versa.

### **FAIRMANS LANE, BRENCHLEY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Fairmans Lane, Brenchley, on or after 31st May 2022 for up to 3 days between 08.00hrs and 18.00hrs or until the works have been completed.

The road will be closed outside Gate House Cottages.

The alternative route is via Horsmonden Road, Short Lane, Brenchley Road, The Heath, B2162 Lamberhurst Road, Tong Lane, Green Lane, Tong Road, Fairmans Lane and vice versa.

### **GREEN ROAD, HORSMONDEN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Green Road, Horsmonden, on or after 3rd June 2022 for up to 11 days or until the works have been completed.

The road will be closed week days between 08.00hrs and 18.00hrs, Saturday between 08.00hrs and 17.00hrs and Sunday between 09.00hrs and 13.00hrs.

The road will be closed at the junction with B2162 Maidstone Road.

The alternative route is via Green Road, The Heath, B2162 Maidstone Road and vice versa.

### **LINDEN PARK ROAD, TUNBRIDGE WELLS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of drainage repair works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Linden Park Road, Tunbridge Wells, on or after 16th May 2022 for up to 3 days or until the works have been completed.

The road will be closed between Montacute Road and The Old Coach Park.

The alternative route is via Montacute Road, A267 Frant Road/Nevill Street, A26 Eridge Road, Nevill Terrace, Linden Park Road and vice versa.

### **MONTACUTE ROAD, TUNBRIDGE WELLS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Montacute Road, Tunbridge Wells, on or after 4th June 2022 for up to 5 days between 08.00hrs and 18.00hrs or until the works have been completed.

The road will be closed between A267 Frant Road and Clarendon Way.

The alternative route is via A267 Frant Road/Nevill Street, A26 Eridge Road, Nevill Terrace, Linden Park Road, Montacute Road and vice versa.

### **ROGERS ROUGH ROAD, KILNDOWN (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Rogers Rough Road, Kilndown, on or after 16th May 2022 for up to 1 day between 09.30hrs and 17.30hrs or until the works have been completed.

The road will be closed outside Combewell Meadow Farm.

The alternative route is via Rogers Rough Road, Ranters Lane, Peasley Lane, B2079 Bedgebury Road and vice versa.

### **ST MARKS ROAD, TUNBRIDGE WELLS. (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of St Marks Road, Tunbridge Wells, on or after 3rd June 2022 for up to 1 day between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed outside number 19.

The alternative route is via St Marks Road, Broadwater Down, A267 Frant Road and vice versa.

### **ST MARKS ROAD, TUNBRIDGE WELLS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on part of St Marks Road, Tunbridge Wells, on or after 17th May 2022 for up to 1 day between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed outside number 21.

The alternative route is via St Marks Road, Broadwater Down, A267 Frant Road and vice versa.

### **TONG ROAD, BRENCHLEY (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022**

Because of UKPN works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Tong Road, Brenchley, on or after 16th May 2022 for up to 4 days or until the works have been completed.

The road will be closed outside Apple Blossom Barn.

The alternative route is via Tong Road, Marle Place Road, Ruck Lane, B2162 Lamberhurst Road, Tong Lane, Green Lane and vice versa.

### **THE KENT COUNTY COUNCIL (VARIOUS ROADS, TUNBRIDGE WELLS) (SPEED LIMITS) (CONSOLIDATION) ORDER 2020**
