# Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

The road will be closed between the junctions with Roughway Lane and Allens Lane, to the extent indicated by signs and barriers on site.

The alternative route is via Dunks Green Road, Hamptons Road, School Lane, The Street, Long Mill Lane and vice versa.

#### MEREWORTH ROAD, MEREWORTH (PROHIBITION OF **DRIVING) TEMPORARY ORDER JUNE 2022**

To allow pole replacement works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Mereworth Road, Mereworth, on or after 8th June 2022 for up to 3 days between the hours of 08:00 and 18:00, or until the works have been

The road will be closed in the general vicinity of number 79, to the extent indicated by signs and barriers on site.

The alternative route is via Mereworth Road, B2016 Seven Mile Lane, A26 Tonbridge Road, Maidstone Road, Common Road, Matthews Lane, Forge Lane and vice

## **OLDBURY LANE, IGHTHAM (PROHIBITION OF DRIVING) TEMPORARY ORDER MAY 2022**

To allow sewer maintenance works to be carried out, Kent County Council has made an Order prohibiting through traffic on part of Oldbury Lane, Ightham, on or after 23rd May 2022 for up to 2 days or until the works have been completed.

The road will be closed from the junction with Spring Lane to outside Heronshaw, to the extent indicated by signs and barriers on site.

The alternative route is via Oldbury Lane, Ightham Bypass, Old Lane, Spring Lane and vice versa.

#### PLOUGH HILL, BASTED (PROHIBITION OF DRIVING) **TEMPORARY ORDER 2022**

To allow works to be carried out to underground structure, Kent County Council has made an Order prohibiting through traffic on part of Plough Hill, Basted, on or after 25th May 2022 for up to 1 day between the hours of 09:30 and 15:30, or until the works have been completed.

The road will be closed from the junction with Winfield Lane to outside Orchard House, to the extent indicated by signs and barriers on site.

The alternative route is via Winfield Lane, Crowhurst Lane, Thong Lane, Basted Mill, Mill Lane, Plough Hill and vice versa.

#### **ROUGHWAY LANE, TONBRIDGE (PROHIBITION OF DRIVING) TEMPORARY ORDER JUNE 2022**

To allow gully cleansing works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of Roughway Lane, Tonbridge, on or after 8th June 2022 for up to 1 day or until the works have been completed.

The road will be closed from outside Brown Cottages to outside Roughway Farm, to the extent indicated by signs and barriers on site.

The alternative route is via Roughway Lane, Dunks Green Road, Hamptons Road, Park Road, Oxenhoath Road, The Hurst and vice versa.

## THE HAWTHORNS, AYLESFORD (PROHIBITION OF **DRIVING) TEMPORARY ORDER JUNE 2022**

To allow cabling and road crossing works to be carried out, Kent County Council intends to make an Order prohibiting through traffic on part of The Hawthorns, Aylesford, on or after 8th June 2022 for up to 7 days or until the works have been completed.

For the safety of the public whilst an event is being held at Dunorlan Park, Kent County Council intends to make an Order to prevent parking on Bayhall Road, Tunbridge Wells, as per the schedule below.

Because of Openreach works, Kent County Council intends to make an Order to temporarily prohibit through traffic on part of Lower Green Road, Speldhurst, on or after 7th June 2022 for up to 3 days between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed outside Little Garth.

The alternative route is via Lower Green Road, Etherington Hill, Speldhurst Road, A26 St Johns Road, Mount Ephraim, A264 Bishops Down, A264 Langton Road, Rusthall Road and vice versa.

## PIPERS LANE, HAWKHURST (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on Pipers Lane, Hawkhurst, on or after 26th May 2022 for up to 2 days between 09.30hrs and 15.30hrs or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via A229 Horns Road, Talbot Road and vice versa.

#### RANTERS LANE, GOUDHURST (PROHIBITION OF **DRIVING) TEMPORARY ORDER 2022**

Because of Openreach works, Kent County Council has made an Order to temporarily prohibit through traffic on part of Ranters Lane, Goudhurst, on or after 20th May 2022 for up to 6 days between 08.00hrs and 18.00hrs or until the works have been completed.

The road will be closed between Trillinghurst Farm House and Gatehouse Farm.

The alternative route is via Ranters Lane, Church Road, Kilndown Road, A21 Hastings Road/Lamberhurst By-pass, A262 Horsmonden Road/Goudhurst Road/ Spelmonden Road, Station Road and vice versa.

# THE KENT COUNTY COUNCIL (TUNBRIDGE WELLS BOROUGH) (PROHIBITION OF WAITING) NO.2 ORDER 2022 **ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL, (herein referred to as "the Council") acting as the local traffic authority and in exercise of its powers under Sections 1, 2, 4 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, propose to make the following

The effect of the proposed named Order will introduce additional waiting restrictions DYL means no waiting at any time in the following length of road in Tunbridge

REYNOLDS LANE - DYL - (1) On the west side from a point in line with the boundary of Whitegate Farm and Sandalwood Reynolds Lane for a distance of 244 metres in a south westerly direction. (2) On the east side from a point 10 metres south of the northern boundary of 43 Reynolds Lane for a distance of 180 metres in a south westerly direction. REYNOLDS LANE - SYL - 9am and 5pm Mon-Fri between September and July - On the east side from a point 10 metres south of the north boundary of 43 Reynolds Lane to a point in line with the boundary of 29/31 Reynolds Lane.
