NOTICE OF CONFIRMATION AND COMING INTO EFFECT OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990 SECTION 257 AND PARAGRAPH 7 OF SCHEDULE 14 ASHFORD BOROUGH COUNCIL (PUBLIC FOOTPATH AE247 (PART), BRABOURNE) PUBLIC PATH DIVERSION ORDER 2022

On the 18th May 2022, Ashford Borough Council confirmed the above Order under Section 257 of the Town & Country Planning Act 1990 and on the 14th June 2022 the Kent County Council – on behalf of Ashford Borough Council – certified that the terms of Article 2 have been complied with, as such the order has come into effect.

The effect of the Order is to divert the entire width of that length of Public Footpath AE247 which commences at NGR TR 0855 4232 (Point A on the Order Plan) and runs in a southwesterly direction for 179 metres to NGR TR 0848 4216 (Point B). As shown by a solid black line between Points A-B and will add a new length of public footpath AE247 with a width of 2.0 metres which will commence at Point A and run in a south-south-easterly direction for 115 metres to NGR 0857 4221 (Point C) and then continue in a west-south-westerly direction for 102 metres to NGR 0847 4217 (Point D) where it connects with Public Footpath AE255.

As shown by the black broken line between Points A-C-D on the plan

All directions are general, all distances are approximate.

The Order came into force on the 14th June 2022, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the above Act, or on the ground that any requirement of the Act, or of any regulation made under the Act has not been complied with in relation to confirmation of the Order, he or she may apply to the High Court for any of these purposes under Section 287 of the Town and Country Planning Act 1990 within six weeks of the date on which Notice is first published as required by paragraph (7) (8) of Schedule 14 to that Act.

Road Traffic Regulation Act 1984 Section 14(1), As Amended By The Road Traffic (Temporary Restrictions) Act 1991

The Secretary of State for Transport has directed that the Order made by Kent County Council on the 18 June 2021, the effect of which was to prohibit all traffic from Public Footpath SD92 has been extended for a further 6 months, until the 27 December 2022

The path is closed between Highlands Hill and TQ 522694

The alternative route is via the northern and eastern side of the field and will be signed for the duration of the closure.

NOTICE OF THE MAKING OF AN ORDER TO TEMPORARILY CLOSE PUBLIC FOOTPATH ZR191 IN THE PARISHES OF BAPCHILD AND TONGE IN THE BOROUGH OF SWALE

KENT COUNTY COUNCIL (PUBLIC FOOTPATH ZR191) (PROHIBITION OF TRAFFIC) TEMPORARY ORDER 2022

Road Traffic Regulation Act 1984, Section 14(1), As Amended By The Road Traffic (Temporary Restrictions) Act 1991

Kent County Council has made an Order the effect of which is to temporarily close Public Footpath ZR191 between A2 (Foxhill) and its junction with Public Footpath ZR190, located south of the railway line, from the 27 June 2022

The path will be closed for a maximum of six months.

The path is to be closed because works are planned on or near it.

The alternative route is via the A2 towards Faversham, Public Footpath ZR192 to Tonge Mill and then Church Road to connect to Public Footpath ZR190, and will be signed for the duration of the closure.
