

Highways

Kent County Council, acting in exercise of its powers under the Road Traffic Regulation Act 1984, makes or intends to make the following Orders.

THANET AREA

BROCKENHURST ROAD, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow utility works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Brockenhurst Road, Ramsgate, on or after 15th August 2022 for up to 5 days or until the works have been completed.

The road will be closed outside number 11, to the extent indicated by signs and barriers on site.

The alternative route is via Brockenhurst Road, Victoria Parade, Lyndhurst Road, Queens Road and vice versa.

BROOKE AVENUE & CROW HILL, MARGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow gas mains replacement works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Brooke Avenue and Crow Hill, Margate, on or after 15th August 2022 for up to 17 days or until the works have been completed.

Brooke Avenue will be closed between the junctions of Crow Hill Road and Leslie Avenue, to the extent indicated by signs and barriers on site.

Crow Hill Road will be closed at its junction with Brooke Avenue, to the extent indicated by signs and barriers on site.

The alternative route for any through traffic is via Brooke Avenue, Birds Avenue, High Street, A28 Canterbury Road, B2052 George V Avenue, Westfield Road and vice versa.

DUMPTON LANE, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow carriageway patching works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Dumpton Lane, Ramsgate, on or after 17th August 2022 for up to 1 day or until the works have been completed.

The road will be closed between the junctions of Sherwood Gardens and College Road, to the extent indicated by signs and barriers on site.

The alternative route is via College Road, Cecilia Road, A255 Hereson Road, A255 Ramsgate Road, West Dumpton Lane, Dumpton Lane and vice versa.

HARBOUR STREET, BROADSTAIRS (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow sewer maintenance works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on Harbour Street, Broadstairs, on or after 17th August 2022 for up to 1 night between 20:00 hours and 05:00 hours, or until the works have been completed.

The road will be closed for the entire length.

No diversion route available but access will be maintained when it is safe to do so.

KING EDWARD ROAD, BIRCHINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow cable installation works to be carried out, Kent County Council has made an Order to

temporarily prohibit through traffic on part of King Edward Road, Birchington, on or after 15th August 2022 for up to 5 days or until the works have been completed.

The road will be closed outside number 17, to the extent indicated by signs and barriers on site.

The alternative route is via King Edward Road, A28 Canterbury Road, Quex View Road, Alexandra Road and vice versa.

NORTHWOOD ROAD, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow carriageway resurfacing works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on Northwood Road, Ramsgate, on or after 19th August 2022 (excluding weekends) for up to 6 nights between 19:00 hours and 05:00 hours or until the works have been completed.

The road will be closed for the entire length.

The alternative route is via A254 Margate Road, A254 Pearce Signs Roundabout, A256 Westwood Road and vice versa.

SEAMARK ROAD, BIRCHINGTON (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow street lighting connection works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Seamark Road, Birchington, on or after 17th August 2022 for up to 1 day between 09:30 hours and 15:00 hours, or until the works have been completed.

The road will be closed between the junctions of A28 Canterbury Road and Crispe Road, to the extent indicated by signs and barriers on site.

The alternative route for any Southbound traffic is via A28 Canterbury Road, A299 St Nicholas Roundabout, A299 Thanet Way, A299 Monkton Roundabout, and Seamark Road.

The alternative route for any Northbound traffic is via A28 Canterbury Road, B2050 Park Lane, Acol Hill and Crispe Road.

STIRLING WAY, RAMSGATE (PROHIBITION OF DRIVING) TEMPORARY ORDER 2022

To allow carriageway resurfacing works to be carried out, Kent County Council has made an Order to temporarily prohibit through traffic on part of Stirling Way, Ramsgate, on or after 18th August 2022 for up to 2 days or until the works have been completed.

The road will be closed between the junctions of Kingston Close and B2014 Newington Road, to the extent indicated by signs and barriers on site.

The alternative route is via B2014 Newington Road, Bush Avenue, St Johns Avenue, St Johns Crescent, St Johns Avenue, Stirling Way and vice versa.
